Belvidere on Ice

Unleashing the Fury

When Ebenezer Peck, Belvidere's Canadian founder, came to the banks of the Kishwaukee, he may have planted the seed for skating and hockey greatness. With a new ice rink just west of downtown, we're about to find out.

In 2015, the Belvidere Park District opened an outdoor ice rink in Doty Park, just west of downtown. In its third year of operation, the Riverside Ice Arena is proving popular. There is a full schedule of public skating, hockey, and both skating and hockey lessons for all ages. It's the home ice for the Belvidere Fury and Belvidere River Otters. Because the weather is such a factor, the Belvidere Park District maintains an app (and website) to keep ice aficionados informed of the schedule.

You don't have to sit and watch the Olympics on NBC next month and think, "Gee, I wish I could skate like that"! Skating lessons are available for age 3 and up. Hockey lessons start at age 5.

The prices are extremely reasonable. Skating will cost you \$4, with children and teens half price. Skate rental is \$2. Overnight skate sharpening is available, \$7; often faster, if you need it. Skating lessons are \$25 if you are in district, and \$35 otherwise. Hockey lesson prices are comparable. Helmets are required for all hockey players, but can be furnished for those taking lessons.

Skating is a skill you can learn on the cheap in Belvidere. And you can get your start here as a hockey player, too.

Once you learn to play, skating can be a lot of fun and a great social activity. It's fun to go for an hour of skating close to home. But what if you want to go somewhere with a little bit more "atmosphere"? Show off your Belvidere skating prowess? Strut your stuff?

Chicago to the rescue.

Skate in Chicago at the Bean at Millennium Park. Bring your own skates and the McCormick Tribune Ice Rink is free! Skate sharpening is \$9 and lockers are \$1. Or, how about the skating ribbon at Maggie Daley Park (Just to the east of Millennium Park)? Admission is free there, too. Skate rental will cost you about \$12 in either place. Lockers are \$2 at Maggie Daley Park and there is also a free oversized baggage storage area outside, but no skate sharpening.

Getting to either of these venues is easy and cheap. Go to the Randall Road Park and Ride and take the bus to Rosemont. The Blue Line will take you to Washington and Dearborn Streets. Walk east three blocks and you're at the rink in Millennium Park. Walk just east of there across the BP Pedestrian Bridge and you'll be at the skating ribbon. Round trip from Randall Road will cost you \$5.00 with your Ventra card, but pay attention to the bus schedule. If you reserve in advance online, there is discounted parking (about \$14 instead of \$27) available in the Millennium Park garage.

You've seen them skating in Rockefeller Center in New York. Want to do that? Go for it! It will cost you, though. General admission to the rink is \$25 and skate rental is another \$12. If you want a lesson first, it's \$50 for a half hour and that includes general admission to the rink. And there is the little matter that it's 875 miles from Belvidere to New York. Gas and tolls will cost you a bit over \$100. Never mind the parking or the hotel; you really don't want to know

Illinois Radio Reporter Broadcaster of Hindenburg Crash

The explosion of the airship Hindenburg on May 6, 1937 is one of the most famous aviation disasters in American history and signaled the end of the zeppelin era of flight. An Illinois radio reporter provided the only news broadcast of the event.

Herbert Morrison, a 31-year-old reporter for WLS Radio in Chicago, delivered the startling description of the fiery crash at Lakehurst, N.J. that included the now-famous words, "Oh, the humanity." Morrison's Hindenburg recording is believed to be the first example of a recorded news event.

Morrison was the only broadcast reporter on the scene, and had to talk his way there. By 1937, airship landings were not really news; the Hindenburg had made multiple trans-Atlantic flights, and its predecessor, the Graf Zeppelin, had captured the imagination of the globe with its breathtaking success.

Though smaller, the Graf Zeppelin was probably more famous than the Hindenburg. The Graf had first flown in October 1928 and circled the world the following year amid great fanfare. The ship went on to fly 136 times across the Atlantic to South America and traveled to the Arctic Circle on a scientific mission in July 1931. In 1933, a flyover by the Graf Zeppelin was a highlight at the Chicago World's Fair.

However, the Lakehurst landing marked the oneyear anniversary of the start of passenger service on the Hindenburg. Also, Morrison had persuaded WLS management to demonstrate new recording equipment, which was not accepted media practice. In most instances, events were either covered live by telephone, or not at all.

After a delay of several hours due to inclement weather, the Hindenburg attempted to land at 7:25 p.m. before the massive explosion and fire that consumed the huge craft in only thirty seconds.

The pained words of Morrison have become synonymous with the Hindenburg disaster, though many believe that a technical flaw caused his voice to sound differently. Analysts now theorize that the recorder ran too slow, and that replays have since run the tape too fast. As a result, Morrison, who actually had a deep voice, comes across with a higher pitch.

Ryder is an EEO Employer/Vet/Disabled Reportedly, German officials attempted to seize Morrison's recording equipment, but he managed to escape and fly back to Chicago. WLS played the recording by noon the following day, and NBC Radio aired it at 3 p.m. that afternoon.

Four newsreel photographers were on the scene, filming what had been expected to be a normal landing. In 2014, an amateur film, providing a rear view of the explosion, was broadcast publicly for the first time.

Many believe the disaster was caused by a sharp turn just before landing that may have caused a rupture near one of the hydrogen tanks. In addition, the electricity in the air from the stormy weather may have created a spark that ignited the explosion.

Hydrogen, a highly combustible gas, was used because the United States, which controlled the world supply of non-flammable helium, balked at selling it to Germany with war clouds looming in Europe. Much to the dismay of many, the top airships carried the Nazi insignia as the Third Reich rose to power, and were frequently used for propaganda.

The loss of the Hindenburg effectively ended the vaunted German zeppelin program. The beloved Graf Zeppelin, in flight from South America when news of the Hindenburg was received, landed in Germany two days later and never carried another fare passenger.

Morrison, a native of Scottdale, Pa., continued his career in media and later became the first news director of WTAE-TV in Pittsburgh. A veteran of the Army Air Corps in World War II, he ran for Congress three times as a Republican from his native Pennsylvania in the 1950s. He died on Jan. 10, 1989.

At the time of the Hindenburg disaster, WLS Radio was owned by Burridge Butler, who also published The Prairie Farmer, a popular rural magazine. Butler was also a generous donor to Blackburn College in Carlinville, which built a residence hall in 1928 bearing his name.

Hockey Is Life. Life Is Hockey.

Let's get on to what's truly important in life: Hockey.

First you need to learn to skate. At age 5, you can start playing hockey.

When you get to be 7, you are ready for the Belvidere River Otters, a Belvidere Park District sponsored hockey league, where you can play until you are age 14. You'll learn to play hockey on a team and be on the road to becoming one of Belvidere's future hockey stars.

Belvidere is also home to the Belvidere Fury, a high-school age club in its second season, currently playing at the Junior Varsity level. The team is named for the popular automobile, manufactured for many years by Chrysler in Belvidere. The season runs from September through January, which forces the Fury to play many of its home games indoors at the Carlson Ice Arena or the Riverview Ice House in Rockford. The team is composed of students from Belvidere, Belvidere North, DeKalb, Sycamore and Honnonegah High Schools. The Fury plays teams chiefly from the

Northern and Western Chicago Suburbs.
You can see the Fury in action on home ice on Sunday, January 28 at 11:30AM when they play the Fox Valley Hawks at the Riverside Ice Arena in Belvidere.

Like any sport, when you want to become a professional player, there is a long, winding path to make it to college hockey or maybe the NFL.

Last Friday, The *Journal* caught up with Kip Hoffmann, Team Captain and Left Wing for the Janesville Jets. Hoffmann is originally from Marengo, before his family moved to Huntley. Hoffmann started at age 4, when his parents discovered a baseball bat wasn't Kip's thing, and gave him a hockey stick instead. At 7 and 8, Hoffmann was playing for the Rockford Road Runners at Carlson Ice Arena. Age 10 saw him move on to the Crystal Lake Leafs (now known as the Yellowjackets).

The next step up is triple-A youth hockey. There are four AAA hockey clubs in Illinois, all of them in the Chicago area. Hoffmann started out with Team Illinois in Crystal Lake before moving on to the celebrated Chicago Mission, who plays in Naperville. Many Mission alumni play for NHL teams, and many of the Mission coaches have NHL connections as well.

While at the Mission, Hoffmann was spotted by the Jets. Hoffmann was offered a tender, which means that, at age 16, he came to live with a "billeting" family in Janesville, finishing high school at Janesville Craig while playing for the Jets at the Janesville Arena. Interestingly Janesville's two high schools, Parker and Craig, have a joint team that practices at the Arena as well. Hoffmann found himself in classes with varsity players on that high school team. But then, when you're a Jet....

The Janesville Jets are part of the North American Hockey League, which is known as the middle tier in Junior Hockey. The Jets are consistently top performers in their league.

The Jets won their game last Friday against the Springfield Junior Blues 2-1. Although the Junior Blues scored first, the Jets' Jakov Novak of Windsor, Ontario scored a mid-game goal, assisted by Hoffmann to tie things up. Toward the end of the third period, the Jets scored their game-winning second goal by TJ Polglaze of Beloit. The Jets roster includes players from Canada, Sweden and all over the USA.

Typically, successful junior-leaguers go on to play college hockey. It is unusual for a player to go from Junior Hockey directly to either the NHL or the AHL. Hockey players begin college at a slightly later age and end up in the professional leagues in their mid-20s. With the NHL not participating in the Olympics this year, expect to see many college Olympians being drafted to play in the NHL this fall.

Hoffmann is 20, and has committed to attending Robert Morris University in Pittsburgh this fall on a Division I hockey scholarship. He is considering studying pre-medicine. The *Journal* wishes him well.

If you enjoy watching live hockey, the Janesville Jets are a great team to watch. The team plays first-rate, enthusiastic hockey. Notably, the Janesville Arena is the only geothermal ice arena in North America, cooled by the waters of the lake at nearby Rotary




Gardens. Although the Janesville Arena is a bit dated, it is a comfortable, low-key, hockey-loving environment. The Arena serves the usual refreshments including canned beer. Tickets are only \$9. It's about a 40 minute drive from Belvidere and there is convenient, free parking.

Trying something new...

Last Tuesday, I did something I have never done before. At 61 years of age, I went ice skating. I lacedup skates and tried out Belvidere's ice rink.

I wasn't really sure if I could even stand on a pair of skates. I'd never gone ice skating as a child. If you've never ice skated, you develop a fear and just assume you can't. Or you may try it "someday." Someday never happens, and it's a dream that you eventually give up.

In writing this week's issue on skating, the opportunity came for me to finally give it a try. It was now or never.

When you are over 60, falling is a problem. Broken hips and sprained muscles become a real issue. When you're six or sixteen, all you injure is your dignity.

Chris McFarland of the Belvidere Park District was a great and patient coach. I told him I'd never skated before, and was petrified about falling, breaking something and being in a cast for several weeks. Chris took me over to the ice house at Doty Park and asked my shoe size.

I stood up and took a tentative step on a rubberized surface. Ok, didn't fall. Maybe another step. Maybe a little help to get across the room. Feet closer together for balance. So far so good. Adrenaline and excitement taking the place of jitters.


I walked over to the rink and onto the ice. A couple of tentative steps. Then I shuffled forward on my left foot and the magic moment came: I felt the glide. I was skating! My spirit was one with Bobby Hull, Dick Buttons, Brian Boitano, Eric Heiden, Wayne Gretzky and Sid Crosby.

Chris made sure I didn't fall. I made it around the rink. Stumbled a couple of times. When I stood in the goal. I could see the hockey game coming at me. Fifty years ago, I would have been one mean goalie-and nobody wore helmets back then! For that one moment, Corey Crawford had nothing on me. I could skate, and I was as good as anybody in the NHL--or the Olympics!

At the end, I was a little tired and got some help. Changed back to street shoes rinkside. But it was an exhilarating experience. I now know what it feels like to ice skate. My ankles didn't hurt afterward and I wasn't stiff and sore the next morning. When I told Canadian friends what I did, at least five of ten admitted they'd never skated!

Watching hockey or Olympic sports will never be quite the same.

As children, we are fearless; we take risks that cause our parents to gasp. We cross busy streets we were forbidden to cross. We go swimming in deep quarries. We jump on and off moving trains. We hitchhike. But then we get older and lose our nerve.



Boone County Deputies continued to pursue the vehicle until the two occupants fled on foot in the area of Wynnwood Dr. and Brynwood Ln in Belvidere.

A Boone County Sheriff's Deputy apprehended one of the suspects shortly after the pursuit ended. Boone County and Belvidere Police K9 teams tracked the second suspect to an address in the 400 block of Wedgewood Lane where the suspect was located hiding in the bed of a pickup truck.

A class 2 felony is punishable by three (3) to Seven (7) years in the Illinois Department of Corrections. A class 4 felony is punishable by One (1) to Three (3) years in the Department of Corrections.

It's Just Plain Commonsense?

Cheri Bustos, my favorite Democrat in Congress, has stirred things up this week with a report on how Democrats can carry rural areas that favored Donald Trump in 2016.

It's not a particularly complicated formula: focus on the economy, don't get distracted by ancillary issues and meet people where they are.

In Bustos' case it's strolling supermarket aisles talking to ordinary folks about their concerns.

That's classic Cheri. She gets her energy from talking to people.

I've known Cheri for almost 30 years. We were both young journalists together at the Quad-City Times. We don't agree on all the issues. Ok, that's an understatement. We don't agree on many, many of the issues. (Regular readers will recall I called for making Illinois a right-towork state last week.)

And, hey, I think Wisconsin's Scott Walker may be one of the best governors in the nation. That's an idea that would make my friend Cheri a bit nauseous.

But if I still lived in her district, she would get my vote. Why? Well, for the same reason I've voted for people like former U.S. Sens. Paul Simon and Alan Dixon over the years.

They often weren't ideologically in line with me. But I voted for them because they were good people.

After covering politics for 30 years, I can tell you that politics attracts a lot of cruddy humans. We're talking about folks in both parties who are in love with themselves but are unable to reach for common ground with those with whom they disagree.

We are talking about Republicans who would defend a president who talks about not wanting black immigrants from "shithole countries." That's indefensible. But many in the GOP defend it. Why? Because Donald Trump is a Republican. He's also a bad person.

The same could be said for many Democrats who refused to criticize Bill Clinton's lack of personal propriety, but are quick to condemn Republicans for theirs.

That's why it's important to elect good people. Both Republicans and Democrats.

Since both Cheri and I come from a long line of hog farmers, I'll use this analogy: You can't make a silk purse out of a sow's ear.

It's an embarrassment that the Affordable Care Act passed without a Republican vote. It's equally bad that the recent tax reform package passed without a single Democrat vote.

Both parties have something to offer. They represent constituencies that need to be heard.

By contrast, in 1965, when President Lyndon Johnson pushed for creating Medicare, a majority of House Republicans supported him. And when Ronald Reagan campaigned for tax reform in 1986, most Democrats in Congress backed him.

But something has happened in the political culture that is making such bi-partisan deals a near impossibility.

The biggest reason is that congressional districts are now drawn with such precision that almost all of them are preordained to elect either a Republican or a Democrat. That means that members of congress from those districts can ignore the concerns of voters of the minority party of their district.

But Bustos' 17th District is an anomaly. The district in northern, western and central Illinois carried Donald Trump by 3 percentage points. Bustos carried it by 20 points. (That indicates that Cheri is popular in the district and the Republicans nominated a pretty lame opponent.)

Nonetheless, it is one of a handful of congressional districts where either a Republican or a Democrat can win. And Bustos has found a formula for success in such a district. She listens to her constituents and has avoided the "elitist" trappings of many Democrats.

Here's an example of that elitism. Back in 2002, I was covering a Democrat rally at the Illinois State Fair and there were a group of students from east-coast universities there working for congressional campaigns. As the farmers, factory workers, truck drivers and other working-class whites walked away, the students ridiculed them

"What kind of Democrats are these? They like guns and they are pro-life. These aren't 'real' Democrats," the youngsters said within earshot of those walking by.

You would never hear something like that from Bustos. The report she co-authored last week with Robin Johnson, a Monmouth College faculty member, is pretty commonsense: listen to your constituents, focus on economic issues, be open to candidates with different opinions on social issues and be respectful of the role religion plays in the lives of voters.

It is billed as a key for Democrats to win in rural areas, but, come to think of it, it's not a bad recipe for Republicans who want to succeed in more urban districts.

Like Cheri Bustos, it's just plain commonsense.


