## ONE HUNDRED YEARS AGO THIS SUNDAY

## November 11, 1918

The World War was one of history's deadliest conflicts. Nine million soldiers and seven million civilians perished. At the 11th hour of the 11th day in the 11th month of 1918, the Armistice, signed earlier that morning, took effect, and ended the fighting.

The World War led to a number of political revolutions, including the formation of the Soviet Union and an independent Ireland and Turkey. The war was also a cause of the 1918 influenza epidemic, the deadliest pandemic in history. The flu caused an additional 50-100 million deaths worldwide, killing between three and six percent of the world's population. 30,000 died of influenza in Illinois. Finally, the resulting resentments and many unresolved issues in the war's aftermath led to World War II, about 20 years later.

Europe at that time was divided into many, often warring nations, several of which had great empires extending far beyond the continent. By 1914, two large coalitions had formed, the first being France, Russia and the United Kingdom, the other being Germany, Austria-Hungary and Italy.

On 28 June 1914, Gavrilo Princip, a Bosnian Serb Yugoslav nationalist, assassinated the Austro-Hungarian heir Archduke Franz Ferdinand in Sarajevo. Austria-Hungary then delivered an ultimatum to Serbia.

Serbia was an ally of Russia, which triggered many other agreements among the European powers and their global empires.

In Flanders fields the poppies blow Between the crosses, row on row, That mark our place; and in the sky The larks, still bravely singing, fly Scarce heard amid the guns below.

We are the Dead. Short days ago
We lived, felt dawn, saw sunset glow,
Loved and were loved, and now we lie,
In Flanders fields.

Take up our quarrel with the foe:
To you from failing hands we throw
The torch; be yours to hold it high.
If ye break faith with us who die
We shall not sleep, though poppies grow
In Flanders fields.

The conflict quickly spread beyond Europe. Initially, Italy remained out of the war, but like Japan and the United States, was eventually drawn into the war on the side

of the United Kingdom and France. The Ottoman Empire and Bulgaria joined with Germany and Austria-Hungary.

Initially, all sides believed that the conflict would be over in a short time. But the War to End All Wars led to the mobilization of 70 million soldiers. Weaponry of the Twentieth Century collided with Nineteenth Century tactics and produced a particularly deadly result. Military losses were exacerbated by modern inventions, improved technology, and the stalemate caused by trench warfare. Most of the casualties were caused by artillery fire, which had seen great technological advances. Aircraft, telephones and poison gas were all a part of this war. Penicillin and other modern antibiotics had not yet arrived. As the picture shows, the war was devastating.

Boone County sent 712 soldiers to the World War. 26 were killed in action or died of pneumonia. 24 suffered injuries in gas attacks, and 26 more were wounded in action. Two nurses died of influenza at Camp Grant.

It is customary, particularly in the British Commonwealth, to wear a red poppy on November 11 and the days leading up to it to honor the fallen. Many people also observe two minutes of silence at 11am to remember the sacrifice.


The sensibilities of many of the underlying grievances and feuds that precipitated the war have been lost to time. Yet this war serves as a reminder of what happens when hatred is fomented and diplomacy is abandoned.

## **November Sixth**

On voting day, small groups of four to six people are assigned to a designated voting place, or precinct, in order to ensure that the voting process runs smoothly. From five in the morning to as late as eight-thirty in the evening, these people perform the set up and take down of voting booths, ballot counting machines, check-in stations, voting machines...the list goes on. Nearly every voting-related item that you see in a precinct was put there by an election judge. From the moment that the



#### Illinois' Richest Governor, Meet the Nation's most Powerful State Lawmaker

Illinois House Speaker Mike Madigan is about to see two things he's never seen before. And given he's been in the Statehouse since 1971, that's saying something.

The first is the strength of his majority.

Democrats have never held more than 72 seats in the 118-member Illinois House, with the high water mark coming in 1991. The magic number required to put a constitutional amendment on the ballot and override the governor's veto is 71 votes.

As of Nov. 8, House Democrats are in line for 73 House seats in 2019, possibly 74 – a new record. It will be Madigan's largest majority ever.

The second is the type of person who will occupy the governor's office.

Madigan has worked with two governors of his own party since he was first elected House speaker in 1983: Rod Blagojevich and Pat Quinn. These two men were not shrewd power brokers, to say the least. Madigan could pinion both at will.

Enter billionaire Gov.-elect J.B. Pritzker, who just spent more than \$170 million to unseat Gov. Bruce Rauner. That money is a total game-changer for Madigan's Democratic Party, which has traditionally relied on government worker unions, trial lawyers and business interests who need special favors in order to fill its coffers.

So far, Madigan has brought Pritzker entirely into the fold. He knew Pritzker's money would be a major boost for his House candidates across the state.

But what happens when Pritzker goes from candidate mode to manager mode? He will inherit a massive bill backlog, a state that's one notch above a junk credit rating and a budget that's already out of balance by \$2 billion. He will not be able to raise enough revenue to cover already-bloated spending and new promises in the short term. Something's got to give.

Government unions, for example, might not get everything they want at every turn. These fractures will be where Pritzker's money becomes a double-edged sword for Madigan.

Those deep pockets could provide the speaker covering fire to go against his traditional power base. But Pritzker's money could also offer Madigan's House members the same cover should they dare to go against the speaker.

For the first time ever in Madigan's speakership, Democratic lawmakers could have a real choice to seek shelter elsewhere when a tough vote comes around.

One key factor in all this is what Madigan wants beyond power: legacy. It's clearly on his mind.

The day after polls closed, Madigan released an odd personal statement under the Democratic Party of Illinois letterhead. In it, he claims Republicans lost because they tried to make the election a referendum on Madigan, but that strategy backfired because the speaker is actually "a champion of smart economic and social policies" and has provided "real, tangible economic benefits to the people and families of this state"

It's completely out of touch with reality. And Democrats know that.

Recall that in 2012, a political action committee closely linked to Madigan paid for mailers attacking ... Madigan. The mailers were sent in support of a Democratic challenger running against incumbent Republican state Rep. Skip Saviano. "A vote for Skip Saviano is a vote for Mike Madigan!" said one. "Democrat Speaker Mike Madigan calls the shots for Skip Saviano," said another.

If voters actually love the speaker, Senate Democrats must not have received the memo

Three Democratic Senate challengers ran a week's worth of TV ads in September calling for term limits on Madigan, before the Chicago Federation of Labor demanded they be taken down. Of those three challengers, one picked up a Republican seat and another is down just 12 votes with mail-in ballots left to be counted.

In Madigan's own chamber, Democrat Anne Stava-Murray pulled off a shocking upset in Chicago's western suburbs against incumbent Republican state Rep. David Olsen. Stava-Murray vowed to vote against Madigan for House speaker.

Madigan remains a black eye for the Democratic Party brand in Illinois. His

House members are well aware of that. But for now, they still need his protection.

Come inauguration in January, that could change.

## Saturday Night Massacre was Landmark of Watergate by Tom Emery

Critics of the Trump administration have compared the President's actions, including the dismissal of Attorney General Jeff Sessions and the fate of the Mueller investigation, to the "Saturday Night Massacre" of the Watergate scandal. Pundits may debate the comparison, but the massacre remains a hallmark of the two years of Watergate.

In one of the defining moments of the saga, President Nixon demanded the firing of special prosecutor Archibald Cox on Saturday evening, Oct. 20, 1973. The demand came in response to Cox's subpoena of Nixon's taped Oval Office conversations.

Attorney General Elliott Richardson refused to comply with Nixon's order that Saturday evening, and resigned in protest. Nixon then ordered the deputy attorney general, William Ruckelshaus, to carry out the firing, but he also refused and resigned.





Finally, Robert Bork, who was third in line at the Justice Department as solicitor general, adhered to Nixon's demand, and Cox was dismissed. Public sentiment turned and calls for Nixon's impeachment intensified from the episode, which the press dubbed "The Saturday Night Massacre."

"It was the culmination of all the drama that had built up from the scandal," said Duquesne University law dean Ken Gormley, an acclaimed Cox biographer. "It was evident that there would be a showdown, and it was clear that Nixon was going to test the outer boundaries of the law to defy Cox."

Questions surrounding the botched Watergate burglary of June 17, 1972 led to a Senate investigation the next March. A series of resignations followed on April 30, including top Nixon aides H.R. Haldeman and John Erlichman and Attorney General Richard Kleindienst. Richardson, who had been appointed Secretary of Defense in January 1973, replaced Kleindienst.

Senate hearings began on May 17 and two days later Cox, a respected Harvard law professor, was appointed as special prosecutor. Cox's position was defined as "career reserved," under the authority of the Attorney General and protected from dismissal unless "for cause."

Named solicitor general in the Kennedy administration, Cox came from a long line of distinguished public servants. He was a great-grandson of William Evarts, who, ironically, defended President Andrew Johnson during the first impeachment of a chief executive in 1868.

"Cox was careful, conscious, and principled, and was an independent thinker, like Evarts was," said Gormley. "His goal was not to bring down Nixon, or advance himself. He wanted to apply the rule of law."

On July 16, former Nixon aide Alexander Butterfield stunned the nation with Senate testimony that Nixon had installed a recording system in the Oval Office.

The Boone County Journal November 9, 2018 Cox and the Senate Committee requested the tapes, only to be rebuffed by Nixon,

who claimed executive privilege.

Cox and the committee then subpoenaed the tapes. Nixon ordered the subpoena dropped, but Cox refused. The matter was turned over to the Supreme Court.

Nixon offered a compromise on Friday, Oct. 19, 1973 by which Sen. John Stennis (D-Miss.) would independently review the many hours of tapes and present a finding to Cox's office. The choice of Stennis, an elderly man with a hearing problem who was recovering from a January shooting, raised eyebrows. Cox refused this "Stennis Compromise" and held a press conference the next afternoon to address his position.

"There just happened to be fewer football games on television than normal that day, and more people watched the press conference," said Gormley. "They saw Cox's forceful conviction and integrity on display, and people connected with

Shortly after the press conference, Richardson received a call from Nixon chief of staff Alexander Haig, relaying the President's order that Cox be fired. Richardson met with Nixon, refused, and offered his resignation. The order then passed to Ruckelshaus, who also refused to dismiss Cox and resigned.

Finally, Bork acted on Nixon's demand. FBI agents were then ordered to seal the offices of Richardson, Ruckelshaus, and Cox. The White House announced the events at 8:30 that evening as the nation looked on in amazement.

NBC News anchor John Chancellor grimly reported "what may be the most serious Constitutional crisis" in American history. The press later nicknamed the affair "The Saturday Night Massacre," and the public erupted over the spectacle.

Congress introduced several resolutions for Nixon's impeachment, and Cox became a sympathetic figure. Some 450,000 mailgrams and telegrams were received at the Capitol and White House in the coming days, many supporting Cox's integrity and demanding the President's impeachment.

"I can't tell you how many people I've talked to in their fifties, sixties, and seventies who can tell you where they were, and what they were doing, when they heard the news of the massacre," remarked Gormley.

Nixon never recovered from the massacre and resigned on Aug. 9, 1974 in the face of certain impeachment. "After Cox was fired, the outcome was somewhat inevitable," said Gormley. "The Supreme Court then demanded that Nixon turn over the tapes, which contained damning information that showed he was involved in the Watergate cover-up. There was no room for political maneuvering, and it was increasingly clear that Nixon was going out either by impeachment or resignation."

By comparison, one contemporary declared that Cox "became a permanent American hero." He eventually returned to Harvard, continued his distinguished career, and died in 2004.

"Cox was an incredible public servant, and uniquely suited for that crisis," concluded Gormley. "He spent his whole life admiring the American system of laws, and his role in Watergate was not about his own career. Cox was standing up for our institution of government."

In a single day, I was able to interact with hundreds of very kind people, eat some very delicious chili and be a part of something amazing. At the precinct I was working at, and at the one next to us as well, over sixty percent of the voters registered to each of the two precincts casted a vote on November 6. Due to the amount of nonresponse and nonvoting in past years, this is a very high number, maybe even record breaking for that site. I am so thankful to have been able to aid nearly 400 people in exercising their right to vote.

Most of McHenry County is the 14th Congressional District, where Democrat Lauren Underwood defeated incumbent Republican Randy Hultgren. The vote within McHenry County was an extremely close 40,475 to 40,306 in favor of the Democratic challenger. Underwood said that Hultgren's vote to repeal the Affordable Care Act was her reason for seeking office.

Southeastern McHenry County is in the Sixth Congressional District. Incumbent Republican Peter Roskam was defeated by Democratic Challenger Sean Casten both in the McHenry County portion of the district and the district at large.

Wisconsin Incumbent Republican Governor Scott Walker was narrowly defeated by Democrat Tony Evers.

In Wisconsin's First Congressional District, adjacent to Boone County (which was represented by Republican Speaker of the House, Paul Ryan, who is retiring), Republican Bryan Stihl defeated Randy Bryce, 55 to 42 percent. Randy Bryce ran a colorful campaign with the nickname "Iron Stache."

Bryce's opponents emphasized his arrest record for drunk driving, child support violations and arrests at numerous political demonstrations. Bryce had raised millions of dollars in his campaign from grassroots sources nationally, and was the top such fundraiser in the nation. Both President Trump and Sen. Bernie Sanders (I-Vt.) made appearances in the district on behalf of the candidates.
