Stormwater Tax for Belvidere:Mechanics Done, Finishing Touches Coming

Belvidere's mayor, Mike Chamberlain, has moved the city one step closer to implementing a new tax. Based upon a study commissioned by the city, which outlines the mechanics of fees, implementation, and collection of the new tax, the city need only check a few boxes and fill in a few variables to pay for a \$40 to 50 million storm sewer upgrade for Belvidere's south side.

The study presents rationale for the upgrade by pointing out that, "portions of the storm sewer system are more that 50-years old and are beyond their intended service life."

Presently, the city budgets \$30,000 per year from the general fund to maintain the storm sewer system.

This study has been designed to accommodate the results of an engineering analysis done last year, which was reported on in this newspaper.

The present study states that despite raising sales tax a half percent and increasing the motor fuel tax 2 cents (together adding approximately 1.5 million yearly to the general fund) that those funds were designated to go into the general fund and not specifically for a storm sewer upgrade. The study does goes on to explain the relevance of that comment.

• Insufficient Funding for Stormwater Management – Maintaining and improving a network of over 400,000 feet of storm sewer costs more than \$30,000 and the availability of monies from the general fund is unknown from year to year.


• Current Spending Ties Up General Fund Monies – Money spent from the general fund on stormwater is money that cannot be spent on other urgent municipal infrastructure needs.

• Not an Equitable System for Generating Revenue – Tax revenues that support the general funds are not based on the burden property owners place on the stormwater system, so groups of taxpayers pay disproportional amounts toward addressing stormwater program needs.

No mention was made regarding the 5 percent utility tax designated for infrastructure improvement and implemented under the Brereton administration about 20 years ago. A decade ago, the improvements for which the utility tax was intended had been completed. Since then that money has flowed to the general fund. The study did not discuss the future of the new storm sewer tax after bonds for the construction of the storm sewer improvements were retired. This newspaper has previously reported that the city recently discovered it had not been collecting a utility tax from several industrial natural gas users in the city due to a loophole in the law. After closing the loophole, the city raised an additional \$900,000 this year and will be able to capture a similar amount in future years. That revenue was not allocated in the most recently created city budget. Jeff Carlisle, a local resident, and Boone County Board member. rumored to be planning a run for mayor in the next election, spoke to the city council during public comment. Carlisle said its not clear where the money, (from the sales and gas taxes), has been posted to any purposeful fund its just placed in the general fund. He said, "No one has any idea how much is set aside for this project or pensions." Carlisle cautioned them to, "...put the brakes on and to get a grip on this situation."







Something Special in a Photograph

What an asset this building would be to Belvidere's downtown if it still existed today. The character of individualism in the composition of the façade for each of the business and its lesser tenants is distinctive. The occasion was a photograph made for us to be able to see great accomplishment on the Midwestern Prairie. The Belvidere settlement began to develop around 1835. The first advertisement for Plane Hardware in a local newspaper, The Belvidere Standard, appeared on October 28, 1851. John Plane was a partner in Plane & Jenner Hardware at the time of the advertisement, and presented the business as having been long established by 1851. By 1852, the name Jenner had been dropped from the business advertisements.

An 1852 advertisement indicate Plane Hardware was in operation on North State between what today we call Lincoln Avenue and Hurlbut. Perhaps after the Civil War he moved the store to 600 South State Street. plan rather than doing things piecemeal guided by head scratching old men, it could lead directly to the Belvidere Oasis, a mass transit hub connecting with Chicago and O'Hare by bus.

The stonework, the irregular wall, the ornate orderliness at a principal highway fork set off this part of the business district as a centerpiece and created a new center of town. When the railroad came through Belvidere on the south side of the Kishwaukee River in the 1850s, it caused the south side of the city's business district to develop, and eventually exceed the original business district on the north side in size. The railroad changed everything, because, as a practical matter, any long distance travel or shipping in that era was by rail.

In the photo at the front door of Plane's Hardware is a kitchen stove and most likely the Plane family standing around it. The Planes lived above the store. Another stove from the inventory can be seen outside the big windows along Logan Avenue.

Above the Sabin & Sykes Dry Goods store is a sign for an attorney at law by the name of R. W. Coon. Belvidere's legal community had clearly grown as well.

Stephen Hurlbut the third attorney to practice

Plane was a stove dealer. Marketing stoves for cooking, the parlor, dining room both in heavy and light versions, he had a broader definition of a hardware store than we do today. He sold horse-pulling hay rakes, hayforks, shovels, hoes, and scythes for the farmers. The store sold Fairbanks Scales, general hardware in iron, steel, copper and tin – nails, and farm tools under the banner, "as good as the best and cheaper than the cheapest."

We do not know as yet when this building was built or who built it. It may have not been the first at the corner of South State Street and Logan Avenue, where a bank branch is located today. Perhaps Plane with friends, family and with the help of a contractor, combined to be both architect and laborers. We do know of this building and three others, J. C. Penney being the occupant of two of them, constructed on this site at 600 South State Street. 600 South State Street is at a fork in the road, one going east and one leading to the west. Today, if you went west, and if South State Street were extended, and Belvidere had an urban

in Belvidere arrived in the 1850's. Coming by a train to Galena in an attempt to outrun forgery charges Charleston, South Carolina. He stopped in Belvidere becoming the third attorney, with Loop and Fuller, to practice in Boone County. Belvidere now had a judge, and a lawyer for both the defense and the prosecution. Hurlbut became a state representative for this district. When the Civil War broke out, he rose to the rank of a Major General primarily because of his political connections. He was in charge of supplying the Army of the West from Memphis. Hurlbut used his position to smuggle Confederate, black market cotton with the help of Loop but both were pardoned by Lincoln because of Hurlbut's political status. After the war, Hurlbut became the U.S. Ambassador to Peru. The local newspaper defended him in the face of his disgrace and undoubtedly John Plane knew him well. Fuller went on to become perhaps Belvidere's most important citizen. The population of Belvidere in 1850 was about 1,000, and by 1870 it had grown to 3,200.

There will be a graveside service in Belvidere Cemetery on Tuesday, July 21, 2020. The photo shown above is circa 1961.

My View

Comed's Bribery Admission Implicates Madigan

Court document shows utility agrees to pay \$200 million, admits attempts to influence House Speaker

Hours after filing a court document implicating – but not charging – Illinois' House Speaker Michael Madigan in a yearslong bribery scheme, federal officials took to the courtyard of the Dirksen Federal Building in Chicago on Friday to deliver a message to those engaging in public corruption: "We will find you too."

The charges in the document filed Friday are officially against Commonwealth Edison, Illinois' largest electric utility company, which has agreed to pay \$200 million and to continue cooperating with an ongoing federal corruption probe in order to defer prosecution for a single count of bribery. Per that agreement – which is still pending approval from a judge – prosecution against the utility giant would be delayed for three years and potentially dismissed in exchange for the company's cooperation.

The bombshell in the report, however, is that ComEd admitted to –

from 2011 until 2019 – seeking to "influence and reward Public Official A" for that person's favorable action on legislation. While Public Official A is not directly named in the document, that person is later identified as "the Speaker of the Illinois House of Representatives and the longest serving member of the House of Representatives."

The current House Speaker is Michael Madigan, a Chicago Democrat who has held that position since 1983, except for a brief stint from 1995 to 1997. The documents did not contain his name or any charges against the person identified as "Public Official A." At their news conference Friday afternoon, federal authorities said the FBI does not name those who are not charged.

The implications were clear, however, as federal officials said ComEd "admitted it arranged jobs, vendor subcontracts, and monetary payments associated with those jobs and subcontracts, for various associates of a high-level elected official" in order to advance legislation that would bring the company monetary benefits that "exceeded \$150 million."

This occurred "even in instances where these political allies and workers did little to no work that they were reportedly hired to perform," John Lausch Jr., U.S. attorney for the Northern District of Illinois, said at a Chicago news conference. "In many ways, this agreement – including and specifically ComEd's statement of facts – it speaks for itself," Lausch said. "But it also speaks volumes about the nature of a very stubborn public corruption problem we have here in Illinois. The admitted facts detail a nearly decade-long corruption scheme involving top management at a large public utility, leaders in state government, consultants, and several others inside and outside of government."

Later Friday, a statement issued via a communications firm on behalf of Madigan said he had "accepted subpoenas" at his offices asking for documents related to job recommendations "among other things."

"He will cooperate and respond to those requests for documents, which he believes will clearly demonstrate that he has done nothing criminal or improper," according to the statement distributed by Maura Possley of the BoycePossley firm.

"The speaker has never helped someone find a job with the expectation that the person would not be asked to perform work by their employer, nor did he ever expect to provide anything to a prospective employer if it should choose to hire a person he recommended. He has never made a legislative decision with improper motives and has engaged in no wrongdoing here. Any claim to the contrary is unfounded," Possley said in the emailed statement.

'Intent to influence and reward Public Official A'

The statement was a direct rebuttal to the claims made by prosecutors, who said ComEd "corruptly gave, offered, and agreed to give" jobs, subcontracts and monetary payments to Public Official A and Public Official A's associates, "with intent to influence and reward Public Official A."

Lausch, however, said it was a "complex question" as to whether a public official has to benefit directly from an action for it to constitute criminal activity.

"The short answer is, sometimes a corruption charge is appropriate if it does benefit someone personally, and other times a charge is appropriate if it benefits somebody else," he said.

The public utility company, which is subject to heavy state regulation, admitted it "understood that, as speaker of the House of Representatives, Public Official A was able to exercise control over what measures were called for a vote in the House of Representatives and had substantial influence and control over fellow lawmakers concerning legislation, including legislation that affected ComEd."

The electric utility also admitted in the court document that it appointed an individual to its board of directors and retained a particular law firm "at the request of Public Official A." It also accepted into an internship program "a specified target number of students who primarily resided in a Chicago ward that Public Official A was associated with."

In a statement, Christopher Crane. of ComEd's CEO parent company, Exelon, said, "In the past, some of ComEd's lobbying practices and interactions with public officials did not live up to" the company's standards. "When we learned about the inappropriate conduct, we acted swiftly to investigate. We concluded from the investigation that a

small number of senior ComEd employees and outside contractors orchestrated this misconduct, and they no longer work for the company," he said. "Since then, we have taken robust action to aggressively identify and address deficiencies, including enhancing our compliance governance and our lobbying policies to prevent this type of conduct."

Pritzker: If true, 'he's gonna have to resign'

Gov. JB Pritzker – who was also a subject of headlines regarding a public corruption investigation Friday – said at an unrelated news conference in Waukegan that if the allegations against Madigan are true, "He's gonna have to resign."

"The speaker has a lot that he needs to answer – to authorities, to investigators, and most importantly, to the people of Illinois," Pritzker said. "If these allegations of wrongdoing by the speaker are true, there is no question that he will have betrayed the public trust. And he must resign."

The Chicago Sun-Times reported Friday morning that it had obtained documents that "show the U.S. attorney's office in Chicago has asked Cook County Assessor Fritz Kaegi for all emails and any other communications dating to 2012 regarding the tax break that Kaegi's predecessor, Joseph Berrios, gave Pritzker."

The documents requested reportedly pertained to the \$330,000 property tax break that Pritzker – before he got into elected politics – received on his Chicago mansion after he purchased a neighboring property and removed toilets to render it uninhabitable.

Pritzker's properties were among 118 for which prosecutors sought information about property tax appeals granted during Berrios' tenure from 2010 to 2018.

Pritzker has consistently denied wrongdoing and did so again Friday, noting neither he nor his wife had been contacted by federal authorities on the issue.

"There's nothing new to tell you. ... I learned about this from a reporter," he said. "The facts about this matter have been public for some time and have extensively been discussed as they were in the 2018 election, and they've been fully aired. And as I've always said, any review will show that all the rules were followed."

Republican officials looked to tie the dueling Pritzker and Madigan headlines together.

"The announcement against ComEd and "Public Official A" and the ongoing investigation of Cook County property tax corruption are

ComEd Continued from page 3 another sad commentary on the state of our state," House Republican Leader Jim Durkin said in a videoconference. "The deep federal investigations into the highest members of the Democratic Party and their abuse of the Cook County property tax system is finally coming to light."

He suggested the state should reexamine laws beneficial to ComEd, and said he would like to see a special session for ethics reforms, which he accused Madigan of blocking in recent weeks.

"The allegations presented today are troubling and downright depressing," he said. "Speaker Madigan needs to speak up on this issue. And if the allegations are true, he must resign immediately. Just as important, I hope that members of the General Assembly in the majority party, the Democrat Party, finally have the courage to stand up and demand an explanation of their leader that they have, for decades, elected to rule."

'We will find you too'

In the courtyard of the Dirksen federal building Friday, Lausch signified more federal action could be forthcoming.

"It's not good," he said. "But our federal investigations of corruption in Illinois are ongoing. We have a lot of work ahead of us, and we will get that work done."

Federal authorities have been conducting a seemingly wide-sweeping probe of public corruption that first breached the public's radar in the second half of 2019.

State Sen. Tom Cullerton, a Villa Park Democrat, was indicted on embezzlement charges in August that alleged he took a salary and benefits from a labor union without doing any work. He continues to serve in the chamber and pleaded not guilty to the charges.

In September, federal agents raided the Statehouse office of then-state Sen. Martin Sandoval, D-Chicago. He resigned his Senate seat in November, and in January he pleaded guilty to a bribery and tax fraud charge pertaining to his dealings with a red light camera company and agreed to continue to work with investigators.

Luis Arroyo, also a Chicago Democrat and former state representative, was arrested in October for allegedly passing a bribe to a state senator for favorable treatment of legislation pertaining to gambling devices known as sweepstakes machines. He pleaded not guilty to the bribery charges in February, but waived a right to be indicted by a federal grand jury, "again signaling plans to eventually plead guilty in his corruption case," according to a report in the Chicago Sun-Times.

Investigations of local Chicago officials have been ongoing as well.

On Friday, Kathy Enstrom, special agentin-charge of the Chicago office of the IRS Criminal Investigation Division, said the office is committed to "investigating fraud and political

State Unveils 6-Year Road, Bridge Improvement Plan Without Covid-19 Adjustments

No 'cutting or delaying' projects 'at this time,' but IDOT is 'monitoring' revenues, secretary says

Gov. JB Pritzker joined Illinois Department of Transportation officials Tuesday to unveil a six-year, \$21.3 billion statewide road and bridge improvement plan that is an extension of the Rebuild Illinois infrastructure package passed last year by the General Assembly.

IDOT is tasked with unveiling a multiyear plan each year to detail how it will spend transportation dollars on state and local highway transportation systems. For the current fiscal year, the investment in road and bridge infrastructure totals \$3.15 billion, according to the governor's office.

Current funding levels would allow the multi-year plan to include 3,356 miles of road improvements and 8.4 million square feet of bridge deck in total over the next six years.

The infrastructure spending largely relies on revenue from the motor fuel tax — which was increased on July 1, as it will every year forthcoming under the new state law — among other driving-related fees.

According to an overview of the multi-year plan on the IDOT website, however, revenue estimates were not adjusted to account for economic impacts of the COVID-19 pandemic and associated stay-at-home orders.

"Due to the unprecedented COVID-19 pandemic and national stay-at-home guidance, the reduced consumption of gas is expected to cause a decrease in motor fuel tax revenue that would be deposited into the state's road and state construction fund," according to IDOT's summary of the plan. "It is not yet known what the actual decrease will be. Therefore, no adjustments were made to the (multi-year plan)."

"The department will continue to monitor the data and make any adjustments deemed necessary as actual revenue impacts become known," the summary continued.

While the attendees of a news conference unveiling the plan touted the Rebuild Illinois package, which passed in 2019, acting IDOT Secretary Omer Osman said the COVID-19 pandemic presented some unforeseen challenges.

"The multi-year plan keeps us on track during these uncertain times," Osman said at an event in Collinsville. "While we are not cutting or delaying projects at this time, we will continue monitoring the impact on future revenue to ensure we are investing taxpayer resources wisely. Clearly, COVID-19 is not going to be something that lasts for a few months, but likely impact our decision making for years to come." Despite the pandemic, Osman said, Pritzker allowed road work to continue by deeming construction workers essential in his executive orders. stay-at-home orders, so the first year of the plan saw \$2.77 billion in improvements, with \$2.15 billion to the state system and \$616 million in the local system.

Included was 1,385 miles of road improvements in the state system — comprising 61 bridges and 157 safety improvements — as well as 321 miles of road improvements in the local system, including 67 bridges and 71 safety improvements.

Pritzker noted IDOT had developed a plan consistent with the Federal Highway Administration's Transportation Asset Management Plan standards.

"That standard puts an end to the practice of letting roads and bridges in Illinois deteriorate until they're in just terrible shape," the governor said. "Instead we're investing on the front end saving money for taxpayers."

Among other projects, the first year of the plan included design work on an Interstate 80 bridge over the Des Plaines River that was deemed structurally deficient, resurfacing on state Route 251, widening and reconstruction on state Route 47, reconstruction on the Murray Baker Bridge in Peoria, construction and bridge repairs on Interstate 74, resurfacing on Interstate 55 and U.S. Highway 51, resurfacing and bridge repairs on Interstate 255, and completion of design for added lanes and bridge replacement on Interstate 57 in southern Illinois.

Pritzker touted the plan as one that would create jobs in a difficult economic climate in Illinois and across the U.S.

"Even in a pandemic — especially in a pandemic — our transportation systems connect the lives of our residents and our communities," Pritzker said. "...The Multi-Year Plan we're announcing today provides funding to reconstruct over 3,300 miles of roads and over 8 million square feet of bridges — and, more importantly, create and support hundreds of thousands of jobs over the next 6 years for hardworking Illinoisans across our state."

Projects for the plan are selected by safety criteria such as crash history, pavement conditions and traffic volumes.





Neither if your walking towards the sea (to swim) but otherwise, walking along the beach for whatever reason means the facemask needs to be worn at all times.

Public Transport: Facemasks are MANDATO-RY at all times. This includes taxi's buses, trains, airplanes.

Walking the dog, ferret, cat, horse goat or rabbit: Facemasks is MANDATORY at all times.

Restaurants, Bars, Cafes: When your sat at the table with friends/family, you do not have to wear a facemask, but if seated talking, perhaps consider putting it back on. (as a responsible adult!). Walking around or visiting the toilets, means the facemask must be worn.

Shops, streets, cinema, shopping malls, airports, train/bus stations: Facemasks are MANDATORY at all times.

Sports & exercising: You do not have to wear a facemask if exercising or playing sports. This includes jogging, running, cycling. But walking is NOT included (again, as a sensible adult, please wear a facemask if at all possible before & after).

Gym's: When actually using the equipment within the gym, a facemask need not be worn. But, when walking around in the common areas within the gym, a facemask must be worn (again, just sensible behavior towards other people will be appreciated).

At Work: Facemasks while at work is MANDA-TORY at all times.

Basically, we all need to be SENSIBLE about this. It is for the combined good of everyone. The rules exist and if ignored you will likely receive a fine, STARTING AT €100 per person and rising steadily as you disagree with the police officer. Those willing to pay these charges will of course be much appreciated by all for paying extra towards Spain's public services, but may well be shunned by most others who are willing to obey.

Governor Hits the Road to Make **Census Push**

Savs undercount will impact the neediest communities the most

Gov. JB Pritzker encouraged Illinoisans to complete the 2020 U.S. Census and touted a state investment in youth employment programs Thursday during two public appearances in Rockford.

The state has a 66.9 percent census selfresponse rate currently. That's nearly 5 percentage points better than the 62.1 percent national rate, but well below the state's 2010 final self-reporting tally of 70.5 percent. In 2000, the self-response rate in Illinois was 69

This year's numbers have Illinois tied with Virginia for seventh among all states. The response portal will be open until Oct. 31 due to delays caused by the COVID-19 pandemic.

Pritzker signed an executive order last year dedicating \$29 million to the census outreach effort through the Illinois Department of Human Services.

The outreach is done through a "hub and spoke" model in which funding passes through IDHS to 31 intermediary organizations that lead outreach efforts in 12 regions of the state. Those organizations partner with other community groups to target outreach at a hyperlocal level.

"We're working with trusted messengers and grassroots community organizations to focus on personalized targeted outreach groups," Pritzker said.

While the governor said the census has historically "not been an accessible tool," leaving "too many people locked out and left behind," he pointed out that there is no citizenship question on the census form and organizers are doing all they can to make communities that are fearful of such a question comfortable in filling out the form.

"It's been incredibly uplifting and inspiring to see so many Illinoisans taking to the streets to demand justice, so I need everyone to know, filling out the census is an act of engagement," he said.

In May, however, some of those census community organizers told Capitol News Illinois their outreach efforts have been stymied by the pandemic and associated stayat-home orders.

Youth Employment Program

Earlier Thursday, Pritzker spoke at the Lockwood Park equestrian center and children's farm to tout a COVID-19 Summer Youth Employment Program. The state dedicated \$9.3 million through the Illinois Department of Human Services to support the program to employ 2,400 young adults statewide between June and August 2020, helping them train for and find work.

The program is geared toward low-income youth who live in high-poverty communities and counties hardest hit by the pandemic. Job opportunities through the program are coordinated by community-based organizations in partnership with IDHS.

"COVID-19 has completely turned the working world on its head — but young people still deserve a chance to start building their future. In fact, it's more important than ever to ensure the most vulnerable among us don't slip through the cracks," Pritzker said. "That's why last month, my administration announced a redesigned \$9.3 million COVID-19 Summer Youth Employment Program, supporting dozens of projects across some of the counties hit hardest by the pandemic — projects that,

young people in need of an opportunity."

Pritzker was also asked about the progress on a Rockford casino, and said while he does not have an exact date as to when the Illinois Gaming Board will sign off on applications from potential casino operators, he is hopeful it occurs "certainly over the next couple of months." He said it must be done by October, per the law's deadlines.

The governor said the Gaming Board was affected by the COVID-19 pandemic, just like everything else. Now that it is back at work, it's dealt with a number of backlogged issues. It's important, he said, because revenues from the gambling expansion bill passed last year are to fund infrastructure programs throughout the state.

"(IGB) just got up and running the sports wagering in the state,... a difficult thing to get done but they did, and expanded video gaming terminals in the state, another part of our capital program," he said. "And then of course, we want very badly to make sure that our casinos get up and running. It's economic development, its job creation, it's opportunity. And of course, it's also revenue for the capital projects that we so badly need."

The board operates independently, he said, and a major focus is ensuring there is no corruption in the licensing process.

Pritzker's message at the Rockford City Market was that filling out the census is "an act of civic engagement" that has a direct effect on the amount of federal funding the state receives. In turn, an undercount often disproportionately impacts the neediest communities in the state, which typically have lower response rates.

"The same ZIP codes that are impacted the worst by COVID-19 — those that have been hurting for generations — are on track to be the most undercounted at a time when frankly we need full funding," he said.

A 1 percent undercount for the state could result in it losing \$195 million per year in federal funding for the next decade, Pritzker said. That equates to about \$1,500 per year in federal funding lost for each person not counted in the census.

Based upon the 2010 count, the state collects \$34 billion in federal funds annually, the governor added.
