The Farmers Bank 23 Years of Success in a Rapidly Changing World

The Farmers Bank opened for business in Belvidere on February 3, 1908. By 1932, the depression had crippled the bank and it was folded into a successor bank. In 1913, when this picture was taken, it had the 2nd highest amount of deposits in Belvidere. The Farmers Bank was a common name for a banking intuition at the turn of the century. In the 1850s, another Farmers Bank operated in Belvidere on South State Street, according to advertisements in the Belvidere Standard newspaper. That business seemed to represent a New York Exchange Bank and acted as an affiliate with limited services rather than wholly owned local bank, as were all of the banks in Belvidere at the time of this photo. For instance, if John Plane's Hardware Store made a purchase for a shipment of stoves from Chicago, the bank through its affiliation with a New York bank would act as an escrow agent for payment of the shipment. The Farmers Bank would receive a fee for the service. Once the railroad came to Belvidere in the 1850s, this type of business became common.

The 1850s Farmers Bank had long since disappeared when this picture was taken. In

Belvidere Sells Manley Lot at Cost

The City of Belvidere has reached an agreement with the Community Building Complex on the sale of land on First Street in Belvidere, generally known as the former Manley lot. The City purchased the lot for \$375,000 to facilitate the relocation of Manley Motors to the former Wolf Chevrolet property.

Wolf Chevrolet was closed as a result of dealership restructuring by GM when the financial fallout of investment bank shenanigans infected the world economy. It was reported in an October City Council meeting that the city had additional expenses in the deal with Manley, which brought the total cost for the city for the relocation to approximately \$398.000. The agreement with the Community Building Complex is for a sale price of \$400,000 and includes three easements. The lot is appraised at \$140,000 according to Belvidere Budget & Finance Officer, Becky Tobin.

The sales contract contains three conditions: The unlimited use of the lot for public parking by the city. The right to use as a site for city-sponsored festivals at no cost. Thirdly, the city has the right of first refusal at a pre-established price of \$400,000 If the Community Building Complex sells the property.

The Community Building Complex receives revenue from rental of the complex and a one percent sales tax on restaurant, bar sales and hotel stays.



City to Look into a Comprehensive Alley Plan

At its last meeting on October 26th, the Belvidere City Council Committee of the Whole discussed the future of alleys in Belvidere. City Works Director, Brent Anderson has been assigned the duty to collect data. An overview of the work toward a consistent alley policy was laid out.

City Attorney Mike Drella explained to the council that he saw three directions the city could take if it chose to make changes. One direction is to vacate all alleys that are not necessary to access existing structures. Another is to close unimproved alleys and post them by sign as closed. Thirdly, bring alleys that residents want to keep up to date.

Public Works Director Brent Anderson explained to the council some facts about Belvidere's alleys: Alleys in Belvidere are 12 to 16 feet wide, with most being 12 feet. If vacated, generally the split would be half to each adjacent property owner. He estimated the value per square foot to be \$1.50.

To close all alleys by posting a sign would cost an estimated \$7,000 plus for signage. The third option, upgrading alleys, could be done by the street department over a few years and cost an estimated \$155,000, which would include about 30 alleys. Anderson reported that the city can lay its own blacktop and there is a local source for blacktop. In the past alleys were seal-coated surface maintained. This final option would also add to snow removal cost.

Anderson also gave a report on the current status of Belvidere's alleys: Belvidere has

Graduated Tax Fails; Cuts, Tax Hikes or Both Could Follow

Backers of a graduated income tax constitutional amendment conceded defeat Wednesday, Nov. 4, for Gov. JB Pritzker's marquee policy proposal which was projected to bring in more than \$3 billion annually to state coffers.

With 98 percent of precincts reporting, voters had rejected the amendment by a 55 percent to 45 percent margin. The Associated Press called the race for the "No" camp, as a large number of outstanding mail ballots were almost certainly not enough to make up for the deficit of approximately 500,000 votes.

In his daily COVID-19 briefing in Chicago, an agitated Pritzker lashed out against the Republican Party, warned of cuts to public safety and human services and said several other options were on the table for addressing state budget deficits that have been ongoing for decades.

"Illinois' fiscal problems haven't gone away. We now sit at a crossroads," Pritzker said. "Our state finances still require fundamental structural change. In the coming days I'll be talking with the leaders in the General Assembly about our path forward. But here's what we know for sure: I promised to be a governor who balances the budget and pays the bills that my predecessor left behind. I promised to make sure that our kids get a good education that we invest in job creation and that we build a better future for Illinois. There will be cuts, and they will be painful."

The failure of the amendment marks the end of a fight led by Pritzker which began legislatively in April 2019 and even before that politically when Pritzker was running for governor in 2017 and 2018.

1913 Belvidere's four banks were doing business and were locally owned. They were: The First National Bank, The Second National Bank, The Peoples Bank and The Farmers Bank. Who the person is in the foreground of this picture is unknown, but it would not be unreasonable to guess it is the head cashier of the bank. At the time, A. Gates White was the cashier at the Farmers bank. In December 1813, the Governor of Illinois appointed Mr. White to be the Boone County Public Administrator. What the responsibilities of that office were are unclear at this time. In 1913, the County Board was organized differently than it is today. The County Board of Supervisors was composed of township officials, as opposed to today's 4 members elected from each of 3 districts. Today, the county has an administrator but is that the equivalent to Mr. White's office? We do not know.

In 1913, local banks and the City of Belvidere's finances were intertwined as is illustrated by this quote from the *Belvidere Daily Republican* April 13, 1913:

"The office of City Treasurer has always been considered more an office of the bank than of the individual running for office..."

The editorial went on in support of the cashier of the Farmers Bank for City Treasurer. The editorial argued that it was the Farmers Bank's "turn" to hold the position even though it was the newest bank. In the most diplomatic way it states the following:

"...There are four banks in Belvidere, each of which has a patronage entitled to consideration at the hands of the people. A few years ago a new bank was started here which has grown to a considerable prominence in a financial way and with the people, because of its uniform courtesy and fairness to its patrons and to everybody who wished to do business with it. There is no

difference, so far as courtesy is concerned, claimed in this campaign, between the banks of Belvidere, and none desired by the Farmers State bank. The Farmers' State bank believes that it is at least entitled to the same consideration, and in return assures its patrons that they will hereafter, as heretofore, always receive that uniform courtesy that has been the desire of the bank to manifest toward all people in the past."

In 1913, Belvidere national banks could issue currency under the signature of the head cashier of a particular bank. Today, currency has been standardized and under the signature of the Federal Secretary of the Treasury. The business of banking has been reformed into a more cohesive structure. 1913 was a sea-change year in the banking business. The Federal Reserve System was created. The Federal Reserve System is made up of regional banks and is the central banking system of the United States. There are twelve regional banks in total, one for each of the twelve Federal Reserve Districts that were created by the Federal Reserve Act of 1913. Belvidere is located in the Seventh Federal Reserve District, headquartered in Chicago.

Reserve Banks are organized as self-financing corporations and empowered by Congress to distribute currency and regulate its value under policies set by the Federal Open Market Committee and Bank's Board of Governors. The corporate structure reflects the concurrent interests of the government and the member banks, but neither of these interests amounts to outright ownership.

The financial panic of 1907 threatened several New York banks with failure. The result was the Federal Reserve System, which provided liquidity to banks. The Federal Reserve Banks opened for business in November 1914.

53 fully improved alleys, 19 being partially improved, 30 are unimproved. Eleven alleys are just grass, and hard to tell if there is an alley, but still may be used occasionally. 2 miles of alleys have already been vacated over time.

It was decided to solicit input of adjacent property owners and public comment. The Director of Public Works will finish his study on the subject and report it to council. In closing, Alderman Snow made a final comment that he supports a clear policy but likes the improvement of alleys that are regularly used, but would vacate those that are not. "A decent alley builds a better neighborhood and eliminates, 'the broken-window effect," Snow said.

Pritzker spent \$58 million of his own personal fortune to promote the amendment, while billionaire Ken Griffin, the state's wealthiest person and founder of the hedge fund Citadel, dropped more than \$53 million into an effort to defeat the tax change.

The governor had billed the graduated income tax proposal – which would have imposed higher tax rates on higher income earners – as the best of three options, the others being a 20 percent increase to the state's flat tax or 15 percent across-the-board cuts to state spending.

Complicating matters is a global pandemic that has ripped a hole in state finances. Even before COVID-19 redefined the state's revenue picture, Pritzker had pegged the state's structural, year-after-year budget deficit at about \$3.2 billion. Considering lost revenues due to COVID-19 and associated economic restrictions, that deficit could exceed \$7 billion with the graduated tax's failure, Pritzker predicted in April.

The state's path forward could include some combination of cuts and tax increases, as well as borrowing from the federal government's Municipal Liquidity Facility program which was authorized in the state's budget for fiscal year 2021

"Everything is on the table," Pritzker said.

Pritzker Warns of Record Positivity Rates as Entire State Triggers Mitigations

Governor highlights state, federal grant money to businesses

All 11 of the state's mitigation regions will face stricter COVID-19 based restrictions by Wednesday due to increasing positivity rates, while opposition grows from some bars, restaurants and other small businesses struggling during the pandemic's economic downturn.

"The virus is spreading. And every region of the state is suffering from its insidious, invisible contagion," Gov. JB Pritzker said Monday during his daily COVID-19 briefing.

"Nothing we can do will immediately reduce the positivity rates, or hospitalizations, but our resurgence mitigations are designed to have an impact over several weeks as long as everyone takes some responsibility for masking, social distancing and following the (U.S. Centers for Disease Control and Prevention) and (Illinois Department of Public Health) guidelines. Just like driving a car, when someone blows through a stoplight, they not only risk their own life, but also the lives of all the drivers around them. Right now, the stoplight is red. Please act accordingly."

According to the governor, the past week was one of the worst single-week increases in regional positivity across the state since the spring, with none of the regions experiencing a decrease in their positivity rates.

The lowest increase in any region was by 1.2 percentage points, which was in Region 5 in southern Illinois, and the highest was a 3.1 percentage point increase in Region 7, which includes Will and Kankakee counties.

The state's rolling seven-day average case positivity rate reached 8.1 percent, which is the highest level since May 28. Monday's one-day positivity rate of 9.1 percent was the highest recorded since June 2.

Last week, the Illinois Restaurant Association called on Pritzker to consider alternative mitigations to reduce the hardships that many restaurants are already experiencing. The organization also said it plans to file a legal brief in support of pending lawsuits from restaurants challenging the administration's executive orders.

A group of more than a dozen restaurants in Springfield also filed a similar lawsuit against Pritzker on Friday. The new restrictions have also received pushback from some local leaders, including Orland Park Mayor Keith Pekau, who have said they would not enforce them.

"All we're asking is for simple enforcement," Prtizker said in response to a question about pushback to the new restrictions. "Many, many restaurants and bars are doing the right thing. They're either using outdoor tents, or they're just providing pickup and delivery service or drive through during this difficult period."

But the governor also said some officials are choosing not to do the right thing.

"I would encourage people to speak to their local leaders and remind them that leadership means making some difficult decisions," he said.

Pritzker also touted the number of local businesses that have benefited from federal stimulus funding released by the state — the Business Interruption Grants program and the Local Coronavirus Urgent Remediation Emergency (or Local CURE) Support Program.

"Until we can reduce the upward movement of hospitalizations and bring the rate of spread down, we must keep our economy moving forward, and support our small businesses," Pritzker said

Economists love graphs. They use graphs to represent theories. They use graphs to illustrate concepts. They use graphs to present current conditions extrapolated into the future. Currently economists are debating with graphs possible or likely resolutions of our current recession. represent Competing graphs competing projections. What graph would best project our ultimate emergence from our current plight? The answer matters. It matters a lot.

"V" Shaped Recession...More often than not, since the Depression our recessions have been "V" shaped. For various reasons a sharp, rapid decline in GDP--with a corresponding rise in unemployment--has been followed by an equally rapid recovery. The result? A "V" shaped recession. To state what is painfully obvious--Not This Time! That depressing fact will, of course, generate depressing consequences.

"U" Shaped Recession... Things can, of course, go from bad to worse. On occasion we suffered through a "U" shaped recession. "The bottom drops out." A rapid, sharp decline in economic activity persists for a painfully long period. At least, though, the ultimate recovery would be bracing. But remember that economics is referred to as "the dismal science". Some economists present graphs projecting a more dismal future.

"W" Shaped Recession...It is difficult to deny that such a graph appears unfortunately to represent painfully accurately our current situation. After navigating some of the stages of what appeared to be a "V" shaped recession, the looming fall and winter virus resurgence threatens to drive us down into the depths again. If we add to the "V" shaped graph another precipitous decline, the "V" is transformed into a terribly threatening "W". Heaven forfend, but this graph does seem at least plausibly to represent the prospect that we face.

So far we have focused primarily on graphs illustrating economic consequences of our situation. But there are social and cultural consequences, ominous consequences, of our current conditions. We need another graph to illustrate those ominous consequences. A terrible fate may be in store for our less fortunate fellow

The graph that follows to illustrate this tragedy in the making is not all that inconsistent with the possibility of a "W" shaped recession. We have not just an economy. We have also a society, and the graphs focusing exclusively on economics

"K"

"K" Shaped Recession...We have a society, a society that is in danger of rending by a number of causes. The coronavirus is a new but major contributor to that rending. Some classes have weathered the pandemic quite well, thank you. Many Americans can telecommute. They can literally avoid or escape the virus breeding grounds. Many Americans are ascending the upward sloping segment of the "K".

But their immunity or ascendance comes almost literally at the expense of those fellow citizens who are slipping down the descending segment of the "K". These folks have to work and live in and through the virus. Social scientists speak of a "pulling apart" to describe this rending of society along class lines. It was occurring already; now the trend is exacerbated by the virus.

Congress, in a temporary fit of social and political responsibility, addressed some of the problem in a series of laws focused on the immediate threat. Now, however, political considerations and hyperpartisanship have seduced them to revert to type. The aid has expired. Our fellow citizens are abandoned to slide helplessly down the lower segment of the "K" toward despair. It should be otherwise, but a "K" shaped recession.

"L"??

Let us try to conclude on a sardonically optimistic note. In spite of all the depressing signals sent by many of these graphs, most economists would agree that we probably do not face the ultimate threat of an "L" shaped future. Who said that economics was the "dismal science"?

during his briefing. "And I encourage everyone listening to support your local small businesses. These are the heroes who are the lifeblood of our communities, and they are job creators."

The Illinois Department of Commerce and Economic Opportunity has distributed \$95 million in BIG funds to businesses through 4,000 individual grants, and there remains \$175 million in program to disburse, according to the governor's office.

Nearly \$50 million has also been distributed from the CURE program, which reimburses local governments for COVID-related expenses. About \$31.9 million in CURE funding is in the process of being distributed, with \$170 million remaining.

Both the BIG grants and Local CURE funding comes from the federal Coronavirus Aid, Relief, and Economic Security Act, also known as the CARES Act.

Tania Hernandez, a business owner who has benefited from BIG funds, spoke at Pritzker's daily press briefing about how the grant money helped keep her dress shop from failing due to the ongoing pandemic, as her business pivoted to making masks instead.

"The BIG grant that was provided by the state was essential for us. It allowed us to keep our employees and pay rent. Without this financial help, it was impossible for us to survive.

"We're facing critical times but the BIG grant has been a lift for us," Hernandez said.

Still, Pritzker said, more is needed in the way of aid to struggling businesses.

"The dollars provided by the federal government aren't nearly enough," Pritzker said. "So I've simultaneously called for the federal government to deliver more direct assistance for Americans in every state. And I would encourage elected officials across the state to join in on that advocacy."

Legislative Probe Into Madigan Postponed

Chairman cites pandemic, need for ComEd documents

The chairman of a special committee investigating Democratic State House Speaker Michael Madigan's role in a bribery scheme involving utility giant Commonwealth Edison has postponed the panel's next meeting, which had been scheduled for Thursday.

Rep. Emanuel "Chris" Welch, D-Hillside, announced Wednesday that the meeting is being delayed, in part because of the worsening COVID-19 pandemic and in part because it is still waiting to receive documents from ComEd.

"The Committee is currently awaiting documents requested from ComEd, which the company has indicated they are working to provide within the coming weeks," Welch said in a statement Tuesday. "Both Democrats and Republicans believe these documents will provide critical context to our work. While we face a surge in COVID cases across the state and new mitigation guidelines, holding a hearing without these requested documents would not only be unproductive but also an unnecessary risk for members, staff and our communities at large."

Welch did not announce a new date for the delayed meeting.

Madigan was implicated in the bribery scheme in July when ComEd officials entered a deferred prosecution agreement in federal court in which they admitted to handing out lobbying jobs and contracts to close associates of Madigan's over a nine-year period in an effort to curry his favor for state legislation that benefitted the company. Madigan has denied any wrongdoing and has not been charged with a crime.

Republicans in the General Assembly, however, say the allegations spelled out in the deferred prosecution agreement amount to "conduct unbecoming of a legislator," and they filed a petition in the House in August that initiated the disciplinary proceeding.

That proceeding begins with the formation of a Special Investigating Committee whose job is to determine whether there is enough evidence Continued on Page 5

to support such a charge. The six-member committee is divided evenly between Democrats and Republicans, but a majority of at least four votes is required to pass any motion.

So far, the committee has met only twice, the last time on Sept. 29. A week later, Welch announced that the committee would not meet again until after the Nov. 3 general election in order to remove the proceedings from "the backdrop of a political campaign."

In his statement Wednesday, Welch noted that both Republicans and Democrats on the panel wanted to hear testimony from Fidel Marquez, a former ComEd senior vice president of governmental and external affairs, but that he had declined to appear before the committee. Marquez was indicted for his role in the scheme and has pleaded guilty to one count of conspiracy to commit bribery.

Although the state Senate has adopted rules that allow them to hold subject matter hearings remotely, the House has not adopted such a rule, which means their committee meetings, including disciplinary ones, must be conducted in person.

Last week, Region 3 of the state's reopening plan, which includes Springfield where the Special Investigating Committee meets, was placed under enhanced mitigation measures after the rolling seven-day average COVID-19 test positivity rate rose above 8 percent for three consecutive days. As of Sunday, Nov. 1, the most recent data available, the region's positivity rate stood at 11.1 percent.

House Minority Leader Jim Durkin, R-Western Springs, who initiated the petition that led to the committee's formation, had scheduled a virtual news conference for Wednesday afternoon, but that news conference was postponed due to technical difficulties, according to a caucus spokeswoman.

Tom Demmer, R-Dixon, the ranking Republican on the committee, issued the following statement later Wednesday:

"The duty of the Special Investigating Committee is to conduct an investigation. A petition was filed 66 days ago in accordance with House Rules. The last meeting was 37 days ago, at which time we made a motion to issue subpoenas to key witnesses who have relevant and important information—but the Chairman did not allow a vote on that motion. Members of the House of Representatives—in both parties should be concerned about the way this process is being handled."

Failed 3rd District Retention is First Ever in State Supreme Court's History

Republican candidate in southern Illinois wins 5th District high court seat

For the first time since Illinois adopted judicial retention elections in 1964, an Illinois Supreme Court justice lost a retention bid to stay on the state's highest court.

Justice Thomas Kilbride failed to win at least 60 percent of the 'yes' vote in his district, earning only 56.4 percent of the vote, according to unofficial results. Kilbride conceded from the race in an email statement issued around 11:30 p.m. on Tuesday night.

"Though votes continue to be counted, I am

disappointed in the apparent outcome. I want to thank the voters of the Third Judicial District for twice placing their faith in me to uphold the sacred principles that guide our judicial system. Serving on the Illinois Supreme Court has been the honor and privilege of my lifetime, and I am proud of the legacy I will leave behind, including a court that is more open, transparent and accessible to all, regardless of economic means," the statement read.

Kilbride is part of the 4-3 Democratic majority on the seven-person Supreme Court. He represents the 3rd Judicial District, which includes 21 counties across north-central Illinois. Democratic justices have maintained a majority on the Illinois Supreme Court since 1969.

Kilbride's retention was opposed by Citizens for Judicial Fairness, a campaign committee that raised millions backing his removal, with hopes of electing a Republican to the 3rd District seat in 2022.

Jim Nowlan, chairman of the Judicial Fairness committee, in statement Tuesday night, said the outcome "sends an unmistakable message that Illinoisans want independent judiciary with no ties to [Democratic Illinois House Speaker] Mike Madigan."

"We call on the Supreme Court to listen to the people as they consider a potential interim replacement to serve until 2022," Nowlan said in the statement.

Since this is the first time a Supreme Court justice has lost retention, the court has never before faced the issue of replacing a candidate who has failed to gain retention.

Under article 6, sections 3 and 12, of the Illinois Constitution, the state Supreme Court must appoint an interim justice to fill the vacant seat, by a vote of at least four justices, until the next election in 2022.

The justices typically do not reveal the breakdown of their vote.

A court spokesman said he did not know when the court would appoint an interim justice to fill Kilbride's seat.

The state constitution does not set a specific time frame for when the Supreme Court must vote on an appointment after a vacancy on the

shall serve until the vacancy is filled for a term at the next general or judicial election."

Both Kilbride and Justice Lloyd Karmeier, who is retiring, have terms that end on Dec. 6.

If the court meets to appoint a justice before then, the two outgoing justices could be involved in selecting the temporary successor, said Ann Lousin, a constitutional law professor at the University of Illinois Chicago John Marshall Law School.

"If [Kilbride] does sit in on the meeting, he would have a say in his successor," Lousin said. "He would be one vote out of seven."

Kilbride's retention race has already exceeded the previous record for spending in an Illinois Supreme Court retention race, and it could be the most expensive race in the court's history.

The seven justices on the Illinois Supreme Court are elected from five judicial districts. The 1st Judicial District, which encompasses Cook County, contains three justices – Anne Burke, Mary Jane Theis and P. Scott Neville, who are also Democrats. Neville was also elected to the Supreme Court on Tuesday, but he ran unopposed.

Karmeier, a Republican representing the 5th Judicial District, will be succeeded by Justice David Overstreet, who won his contested race.

5th Judicial District race

Overstreet, a Republican, defeated his opponent Justice Judy Cates in the only other competitive Illinois Supreme Court race on Tuesday. Overstreet won roughly 63 percent of the vote, or 358,455 votes, according to unofficial

The 5th Judicial District covers counties in southern Illinois.

Both Overstreet, 54, and Cates, 68, serve on the 5th District Appellate

Court — one of five state appellate courts, which are one level below the Illinois Supreme Court and hear appeals from circuit courts.

Cates will retain her seat on the appellate court. She did not respond to a request for comment Wednesday.

Overstreet first joined the bench when he was appointed a circuit court judge in the 2nd Judicial Circuit Court in 2007. Before that, he worked in small, private firms in southern Illinois and Knoxville, Tennessee.

He was elected to the circuit court in 2008, appointed to the appellate court in 2017, and won election to the appellate court in 2018.

himself describes Overstreet "constitutional conservative," while Cates ran as a centrist Democrat who promised to protect the rights of gun owners.

Before Karmeier was elected to the Illinois Supreme Court in 2004, voters in the 5th Judicial District had only elected Democrats to the high court since 1964.

Overstreet's election to the court means that three Republican justices will remain on the Illinois Supreme Court.

Justice Rita Garman, from the 4th Judicial District, and Justice Michael Burke, from the 2nd Judicial District, are also Republicans.

Pritzker Pressures Local Officials to Enforce **Mitigation Orders**

Governor also encourages those who qualify to sign up for ACA health coverage

As state leaders continue to face pushback from the restaurant industry and even some county and municipal governments regarding COVID-19 mitigation measures, Gov. JB Pritzker on Tuesday put pressure squarely on the shoulders of local elected officials.

"The fact is that local officials who are not doing the right thing are the ones who are going to be responsible for the rates of infection going through the roof, and our hospitals getting overrun and people are dying if they don't enforce the rules," Pritzker said during his daily briefing in Chicago. "That is why those rules exist."

Beginning Wednesday, all 11 regions of the state's reopening plan will be under enhanced mitigation orders to control the spread of the virus because they have seen sustained periods of test positivity rates over 8 percent and, in some cases, dangerously rising hospitalization rates. The last region to cross those thresholds was Region 2, in west-central Illinois, where the enhanced mitigation measures take effect Wednesday.

Those mitigations include closing bars and restaurants to indoor service as well as limits on the size of public gatherings and social events.

But the restaurant industry has pushed back hard against the orders, arguing there is insufficient data to show that bars and restaurants have been a significant source of virus spread in Illinois. Those establishments went through several weeks of mandatory closures during the early phases of the pandemic, and they say another extended period of closure will force many of them out of business permanently.

Officials in Springfield and Sangamon County announced Tuesday that they will take a "phased approach" to enforcing the orders, starting with limiting indoor seating at bars and restaurants to 25 percent of the establishment's capacity.

That announcement came on the same day the Illinois Department of Public Health announced that 3,594 people in the state were being hospitalized with COVID-19, the largest number since May 28. IDPH also reported Tuesday that 6,516 new cases of the disease and 68 virus-related deaths had been confirmed over the previous 24 hours.

In Region 3, which includes Springfield, the test positivity rate stood at 10.6 percent on Oct. 30, the most recent date for which numbers were available.

"We know that that the places that are remaining open, they're having large gatherings and defying these rules are, in fact, spreading locations," Pritzker said. "These are places that are amplifying the virus across the state. And so, you know, when you've got double-digit positivity rates in your area, as is the case in Springfield, then the local officials need to take the laws that are on the books and the regulations that we've put forward and the orders that we've asked people to follow and enforce them locally.

'Obamacare' enrollment opens

As the number of COVID-19 cases continues to rise throughout the state, Pritzker used his Tuesday media briefing to encourage Illinoisans who do not have health insurance coverage through their employer or Medicaid to sign up for subsidized coverage through the state-run marketplace under the Affordable Care Act, also known as Obamacare.

Open enrollment in that program began Monday

and runs through Dec. 15.

"Since its passage in 2010, the ACA has been an invaluable asset in Illinois' fight to provide health care to all residents of the state," Pritzker said.

People can also access a special enrollment period if they formerly had employer-based coverage but lost their job for any reason, Pritzker said.

The ACA plans offer discounts in the form of tax credits for people who qualify based on their income. According to the Illinois Department of Insurance, more than 240,000 Illinois residents received those discounts last year.

This year, the department said, 179 different plans are available through eight different insurance

Elections Board Warns That Races Could be Undecided for Days

Mail-in ballots postmarked by Nov. 3 will be accepted if they arrive by Nov. 17

Although nearly 3.6 million Illinoisans had already voted by Monday morning, according to the Illinois State Board of Elections, nearly 2.3 million ballots are still to be cast if the state is to match the 70.56 percent turnout of 2016.

As of Monday, there were 586,709 mail-in ballots that Illinois voters had requested but not returned. As long as those ballots are post-marked by Tuesday, Nov. 3, they must be accepted by local election authorities if they arrive by Nov. 17 – two weeks after Election Day.

Those ballots can also be turned in at polling locations or deposited at official election authority drop boxes, which officials say are better options to ensure the vote is counted due to potential mail delays.

"If you still have your vote by mail ballot, you can do one of two things: Either bring it with you and vote in person (on Election Day)... or fill it out and bring it directly to your local election authority and check to see if you have a secure ballot drop box in your area," Gov. JB Pritzker said at his daily news conference Monday. "Do not mail your ballot unless you take it directly to the post office and have it postmarked by (Election Day)."

Because of the outstanding ballots, the Elections Board is warning that election night totals are unofficial, and it could take several weeks to decide close races as officials wait for outstanding mail ballots. Election night results are always unofficial, but the volume of outstanding ballots this year means more races could take longer to decide.

"The Illinois State Board of Elections will regularly update the statewide totals for mail ballots on its website, but does not report any election results until it certifies the vote on Dec. 4. Unofficial results before certification may be obtained from local election authorities," the Board said in a news release.

The Board warned that the graduated tax constitutional amendment question - which can pass if it receives 60 percent approval from voters who vote on the question or a simple majority of yes votes among all ballots cast – could take extra time to decide if the vote is close.

"Because of this formula, the fate of the amendment may not be known on election night even when accounting for mail ballots not yet returned," the Board wrote.

Pritzker advised patience on races with national significance as well.

"Counting votes that arrived by mail is timeconsuming work for our county clerks and their staffs," he said. "With vote-by-mail hitting all-time records, that means that we have to be patient about the results of all races this year. It will possibly take until Wednesday or Thursday, or even Friday to get results for some races in Illinois and in states across the country, every vote must be counted, particularly on the national level. It is very important that we are patient with the presidential election."

Pritzker said it's "extremely important" that Illinoisans do not get their election news over social media.

"We know that there are foreign actors, specifically Russia, Iran and others who intend to promote misinformation throughout Election Day, and in the days after. They would like nothing more than to promote conspiracy theories and sow discontent," Pritzker said. "If you want accurate information about the vote count, go to your local election authority's website, or to the Politico website, or to the New York Times website where they track all the races nationwide or visit other reputable national news outlets."

He urged news consumers to avoid reposting viral content they may see on social media.

"Look at a variety of news outlets if you like but be wary of claims you see on social media, foreign actors posing as Americans are producing disinformation, such as fake videos or fake official statements, hoping that you will repost it," he said. "So check before you repost anything, or better yet, you may want to take the next few days off from social media. Facebook and Twitter will still be there in the morning."

Also at his news conference, Pritzker was asked about Election Day security and the potential for unrest, and he noted the Illinois National Guard is "at a state of readiness," out of "an abundance of caution."

"We've made sure that our National Guard is simply in a state of readiness. We did this back during the few days before the ruling around Breonna Taylor. We want to make sure that that cities, counties that call upon us for help from the state of Illinois that we have those resources available to them," he said.

On Monday, the Illinois National Guard tweeted that they did not have a specific mission. National Guard vehicles were seen staging at McCormick Place convention center in Chicago.

"Lots of people seeing (Illinois National Guard) trucks moving about," the Guard wrote in the tweet. "While we can't discuss the specifics of troop movements or future plans for security reasons, we can say that we do not have any missions and are just preparing in case we are needed. We join most others in hoping we aren't."
