

## Remembering Times Past...

The Belvidere Woman's Club took a pleasant trip back in time during their October meeting as they revisited The Time Museum of Rockford.

This journey back in time was provided by a presentation by the owner of Pitkin Photography in Rockford, Steve Pitkin, about the evolution of clocks, their beauty and their functionality. Steve became interested in the clocks at the Time Museum when he began working a teenage job of cleaning the hallways and meeting rooms at the Clock Tower Resort.

Because of Steve's appreciation of the Museum's wonders, he caught the eye of Seth Atwood, the owner of this private collection of timepieces. Mr. Atwood asked Steve to work exclusively for the Museum, and these two clock enthusiasts became friends. Steve became the resident photographer of the museum and his photos are familiar to many of us.

Using pictures and sharing his detailed knowledge of the history of clocks, Steve's presentation started at the beginning of measured time when the thinkers began making efforts to measure time and incorporate this knowledge into mechanisms that would keep time accurately. Today that is done by an atomic clock. The Museum opened in 1970 and closed in March 1999.

When the Museum closed, in an effort to keep

the collection from being dispersed, The Museum of Science and Industry in Chicago put a large portion on display after Steve approached Mayor Daley. In 2002 the remainder of the collection went on sale at Sotheby's auction house.

Astronomy is the discipline most closely tied to the early evolution of clocks. Noting the uniformity of the timely rotations of the earth, the sun, and the stars proved that time could be predicted and measured. Clocks added a uniformity to the actions of human societies, aiding communication and cooperative efforts. Early clock makers passionately believed that science and art should go hand-in-hand.

Early clocks were magnificent works of art as many of Steve's pictures have shown us. Some clocks were definitely meant to entertain. Not only would a cuckoo chirp the hour, but a figurine with a hammer would strike a gong on the quarter hour, and twirling dancers would dance across the top of the clock on the half hour! All this on the same clock! One sundial, said Steve, had a lens that would catch the sun and focus its beam onto a little cannon loaded with gunpowder which then exploded every day at noon! Many clocks had intricate music boxes. All were finely painted and often had gold embellishments and gemstones.

## **City Eyes New Source** of Revenue from Plote

The Belvidere Planning and Zoning Commission this week unanimously approved a special use permit for a stone quarry on Town Hall Road, presently operated by Plote Construction Inc. of Hoffman Estates under a special use permit granted by Boone County.

The public hearing ran five-and-a-half-hours, largely due to the objections from residents of the Karr and Ratcliff Subdivisions and their attorney. These residents have no representation in the city, because their property is not in the city limits, nor are they slated to be annexed.

The residents of the area around the quarry presented facts at the hearing. Residents reported pictures falling off walls from blasts as an example of the magnitude of the shock waves. The Boone County Soil and Water Conservation District objected to the expanded quarry operation in that part of Boone County. Boone County Board Member Sherry Branson presented studies of the geological nature of the quarry land showing that it is the highest-risk area in the county to develop a quarry. The permeability of the surface soil and the blasting of quarry rock greatly increases the risk of opening a window to the three aquifers in Boone County. Rock that protects the water under the top soil can crack and allow any surface pollutant from industry or farming to seep into the underground aquifers on which the county depends. The quarry also has a natural creek running through it.

The Commission decided in favor of Plote. The special use permit and its associated annexation into the city of Belvidere of a stone quarry 2 miles south of Belvidere moves on now to the first reading at City Council on November 5th. It will have a second reading at the November 19 city council meeting. At that meeting, a final vote will be taken.

Plote is offering the city more money in tipping fees than the county is presently receiving, if in exchange for a 30-year, special use permit with expanded hours of operation. This would avoid the review process that comes with the current 5-year permit the county has granted. The present permit expires in 2019, according to a Plote representative. Representing the firm, Rockford attorney Roxanne Sosnowski argued that Belvidere will receive the tipping fees, rather than Boone County, and Belvidere will gain control over the area. Should the permit be denied, Plote will reapply to the County.

It was noted by the city that it presently does not have the staffing required to monitor the quarry and additional staff would needed. Presently, one person is responsible for enforcement in the city, and is unable to take on a larger work load. The county presently recieves approximately \$26,000 per year in tipping fees.

Originally, the quarry was opened and lightly mined for a decade beginning in 1958 by the Shappert Family business interests. The operation was then abandoned for 35 years and operated as a dairy farm until 2005, when the property was sold to Plote. At that time, the county zoning code did not permit quarrying close to residential areas. Subdivisions developed in the late 50's and early 60's around the former quarry. Plote sued the county to remove the zoning restriction and a deal was struck out of court by the States Attorney at the time, which was later determined not lawful.

A State's Attorney has no authority to issue a special use permit. The county board consented to the deal, not wishing to question the State's Attorney's actions, nor did other interested parties, i.e. Flora Township, all acting under the belief that authority existed. But no special use permitting process was conducted, except a ceremonial fiction of county board approving of the permit.

Numerous violations occurred at the firm's quarry over the years. In 2005, the new State's Attorney at that time, Michelle Currier, successfully sued the firm,

and prevailed in the appellate court. The appeal forced the quarry to operate within established business hours and to do required water testing. An 18-month special use permit agreement was established to monitor compliance.

In 2014, a 5-year special use permit was granted after having a public hearing similar to the hearing the city conducted this week, as required under Illinois law.

This meeting concluded the evidence phase of the special use permit process for the city.



## Opinion: Who Votes for Mike Madigan?

The level of drama in Washington D.C. right now would typically be enough to wash state politics to the wayside during election season.

But in Illinois that remains to be seen. Why? Voters still have Mike Madigan on the mind. The speaker of the Illinois House of Representatives remains a key campaign issue despite national headlines.

Even with all that attention, however, the anatomy of the speaker's power can be tough for the average voter to suss out. How has the longest-serving state House speaker in U.S. history remained in office for so long? Who's to blame? Will his dominance ever cease?

First things first: How does Madigan get to Springfield in the first place?

The answer lies near Midway Airport on Chicago's Southwest Side. This is Madigan's House district: the tiny 22nd. It's where Madigan grew up under the care of the 13th Ward political organization – his father, Mike, was the ward superintendent and his uncle, Tom, was a precinct captain. In fact, local precinct captains gave Madigan his first taste of political power in 1969 when they elected him to the office of ward committeeman, a party position he holds to this day.

As of the 2018 primary, the 22nd district was home to a little over 57,000 registered voters. Less than 18,200 of them cast a vote in the primary. And around 12,600 of them cast a vote for Madigan, who ran unopposed.

Every two years, over the last five general elections, he has received fewer than 22,000 votes on average. It is those Illinoisans – less than 0.2 percent of the state's population – who send Madigan to Springfield.

Just 21 percent of Illinois voters approve of the speaker, according to the most recent polling from the Paul Simon Public Policy Institute. So how does a man with such dismal approval ratings throughout the state keep getting re-elected? The logic is simple. It's good to ride with the king.

One example: In July 2015, while Illinois government was tight on money during the budget impasse, Madigan landed millions of state dollars to build a new school in his district by funneling the cash through Secretary of State Jesse White's office.

That's why they send him to Springfield.

But getting angry at the residents of the 22nd district is of little use, if only because taking down Madigan on his own turf is a pipe dream. They are voting in their self-interest. And these Illinoisans don't really cast the vote that gives Madigan more power than any state legislative leader in the country.

State representatives do.

"I don't become the speaker because someone issues an edict," Madigan said in a 2004 interview. "I become the speaker because there are at least 60 members of the House, generally Democrats, who vote for me to be the speaker."

Those representatives who don't stand up to Madigan for fear of losing campaign dollars, committee chairmanships, the ability to have bills passed and more are those who are to blame for the speaker's dominance.

Just like residents in the 22nd district, their vote for the speaker is self-interested.

Madigan Since of the Democratic Party of Illinois, campaign cash that the party sends to its candidates comes with the obligation to back Madigan as speaker. This expectation invites constant questioning from the press on how these candidates will remain independent from leadership. Some call this problem the "Madigan tax."

It should be noted that this phenomenon runs completely counter to the model of maintaining political power that was perfected by Madigan's most prominent mentor, the late Chicago Mayor Richard J. Daley.

The key to Daley's decadeslong dominance serves as the title of a 1976 book by University of Illinois Chicago Professor Milton Rakove on the Chicago political machine, "Don't Make No Waves...Don't Back No Losers."

The first command, "don't make no waves," means politicians must remove themselves as much as possible from controversial decisions and unfavorable media attention. The idea is simple: The people who hated you for a contentious decision will walk 10 miles in the snow to vote for your opponent. The voters who liked it? They'll forget it ever happened in three months.

Madigan flew largely under the radar for decades in the public consciousness because he never ran for statewide office. It was not until recently that he became widely known as the key player behind tax hikes, reckless borrowing and broken budgets over his 33 years with the speaker's gavel.

As his name recognition has skyrocketed, Madigan is a walking "wave." His reputation is a weight on the neck of every Democratic candidate.

Come November, that could make the second command – "don't back no losers" – more difficult.

In more modern times, American ingenuity focused on absolute accuracy and reliability of timepieces as well as on their mass production. ## Mother Jones Lit a Fire Under Laborers to Claim Their Rights

She lost her own family, so she adopted a new one, a huge one, lifting up the cause of labor while rising to become one of the most famous women in American history.



Muckraker Upton Sinclair, whose "The Jungle" excoriated the Chicago meatpacking industry, summed up Mother Jones thusly: "All over the country she had roamed, and wherever she went, the flame of protest had leaped up in the hearts of men; her story was a veritable Odyssey of revolt."

In the process, Mother Jones became perhaps the greatest labor force in the history of Illinois, a state no stranger to workers' movements. Barely over 5 feet tall, the dynamo who was Mary Harris Jones didn't start speaking and organizing until her mid-50s, a peripatetic rabble-rouser nationally from the 1890s to 1920s – yet always with a heart for Illinois.

"Illinois ranks as a union birthplace, and Mother Jones was a midwife in that process," says Mike Matejka, vice president of the Illinois Labor History Society. "She formed deep friendships with Illinois workers, from miners to union leaders, and continually returned to Illinois as a home base, roaming the state to mobilize and awaken the working class."

In her heyday, no labor leader inflamed passion like Mother Jones. Muckraker Upton Sinclair, whose "The Jungle" excoriated the Chicago meatpacking industry, summed up Jones thusly: "All over the country she had roamed, and wherever she went, the flame of protest had leaped up in the hearts of men; her story was a veritable Odyssey of revolt."

Yet she assumed that mantle only because of circumstance, then guile.

Mary Harris was born in 1837 in Cork, Ireland. A decade later, the potato famine drove her family to Toronto, Canada, where her parents realized a middle-class living and Mary learned dressmaking and teaching. As a young adult, she took her first wanderings, careening around the Midwest before landing in Memphis, Tennessee. There, she met and wed George Jones, a foundry worker and union supporter. They'd had four children by 1867, when an epidemic of yellow fever claimed the entire household, save Mary. The 30-year-old widow relocated to Chicago to start anew with a dress shop, but it burned to the ground during the Chicago Fire in 1871.

She scraped to get by, sometimes sewing piecework for wealthy Chicago families. According to the Illinois Labor History Society, she later said: "Often while sewing for the lords and barons who lived in magnificent houses on the Lake Shore Drive, I would look out of the plate glass windows and see the poor, shivering wretches, jobless and hungry, walking alongside the frozen lake front ... The contrast of their condition with that of the tropical comfort of the people for whom I sewed was painful to me. My employers seemed neither to notice nor to care."

She gravitated to organizing with the Knights of Labor, then the United Mine Workers. Though progressive in workers' causes, she broke from suffrag-

ettes of the day, saying that working men deserved a wage that would allow women to stay home to care for their children. But her labor-rights moxie quickly won over workers – first by the thousands, then millions – especially miners.

As Jones became more prominent and popular at rallies, she became a symbol of her own device. As Mother Jones magazine describes her transformation, "She invented Mother Jones. Or, to put it more precisely, she began to play a role that she and her followers made up as they went along. By 1900, no one called her Mary, but always Mother; she wore antique black dresses in public, and she began exaggerating her age."

Jones often squeaked by on a stipend from the United Mine Workers. But she'd travel to help wherever the call: Garment workers in Chicago, steelworkers in Pittsburgh, bottle washers in Milwaukee, railing against companies and corporation for fair wages and safe working conditions. She felt that change would come only through the mass campaign of workers as citizen-activists.

"Jones' intellectual core was the idea that labor creates all wealth, and that therefore the wealth of the nation should benefit the people who worked," says Rosemary Feurer, an associate professor of history at Northern Illinois University who maintains a Mother Jones website motherjonesmuseum.org. "This provided an intellectual foundation from which she agitated not only in Illinois but across the nation. She was the Johnny Appleseed of the country's immigrant workforce, planting seeds of rebellion from which the labor movement grew."

Jones was more direct in trying to light a fire under laborers to claim their rights and rewards. As she once put it: "I have been in jail more than once and I expect to go again. If you are too cowardly to fight, I will fight."

Despite her vagabond predilections, she often stayed in Illinois between causes. She considered Illinois the birthplace as rank-and-file unionism. And, with miners always dear to her heart and campaigns, she felt a special pull to the plight of miners in Illinois. At the close of the 19th Century, Illinois became a labor battleground – especially in downstate Virden and Mount Olive – as the Chicago Virden Coal Co. and two other anti-union owners defied a union contract sought to bring in strikebreakers, according to motherjonesmuseum.org. Miners from Mount Olive marched with others from across Illinois; in an ensuing battle, 13 people were killed, including four miners from Mount Olive.

She died in 1930 (some sources say at age 100, others say a shade less) and was laid to rest, per her wishes, among the miners laid to rest at Miners' Union Cemetery in Mount Olive. Her simple marker carries some uncharacteristically purple prose, in part extolling: "She gave her life to the world of labor, her blessed soul to heaven."

It's almost a shame she isn't remembered there from one of her most telling quotes: "I'm not a humanitarian. I'm a hell-raiser."

Highlights from the busiest 100 years of Illinois labor developments:

1859: Chicago & Al-

ton Railroad workers strike the entire railroad, protesting non-payment of wages

1861: American Association of Miners organized, in Belleville

1868: Order of Railway Conductors founded, in Galesburg and Amboy.

1877: "The Great Uprising" occurs, with spontaneous strikes by railroad workers nationwide, including crucial actions in Chicago, East St Louis, Peoria, Bloomington, Aurora and Urbana; the Chicago mayor deputizes 5,000 law-enforcers, with 20 strikers killed; 3,000 federal troops and 5,000 deputies battle strikers in East St Louis, with 18 strikers killed.

1886: May 1: 350,000 workers stage a nationwide strike to demand a standard eight-hour workday, with the largest contingent (40,000) in Chicago.

May 4: Haymarket Incident in Chicago.

1894: Pullman strike and boycott effectively shuts down railroad transportation in 27 states, with Illinois the center of activity. Federal troops are mobilized, 30 people are killed in Chicago.

1903: Illinois Child Labor Law enacted (no national law until 1938).

1905: Industrial Workers of the World (IWW) founded in Chicago.

1907: Illinois Factory Inspection Law is passed.

1911: Illinois passes a Workers' Compensation Act 1926: Illinois adopts anti-injunction law (court injunctions cannot be used simply to break strikes).

1932: Insurgent miners form the Progressive Miners of America in September in Springfield

1934: Associated Fire Fighters of Illinois (AFL) organized.

1942: United Farm Equipment (UFE) recognized at the East Peoria Caterpillar Tractor Co. plant.

1946: George McNear, Jr., president of TP&W Railroad, assassinated outside his home in Peoria.

1949: The United Farm Equipment (UFE-CIO) and UAW (CIO) battle for representation of agricultural implement workers in the Quad Cities.

1958: Illinois Federation of Labor and Industrial Union Council merge.

# Illinois had One of the Hottest Book-Banning Controversies

The banning of books over controversial content has long been a simmering debate, but was at its peak during the 1950s.

A 1953 incident in Illinois that resulted from a clerical error is remembered as one of the most heated examples. The controversy swirled around The Boy Came Back, a now-obscure novel that fell into the hands of a southeastern Illinois teenager. Before it finally subsided, the furor had swept Illinois and reached as far away as London.

Written in 1951 by Maine physician Charles Knickerbocker, The Boy Came Back featured small-town scandals slightly reminiscent of the later Peyton Place. The central characters were simply known as the Boy, an alcoholic, violent Army veteran, and his wife, the Girl, who is desired by most of the town's married men. She is later murdered by her husband. Graphic sexual descriptions and profanity are frequent in the book, which received favorable reviews.

In that era, many Illinoisans were not served by public libraries, and the Illinois State Library strove to provide free reading access to all citizens. One method was to distribute large quantities of reading material to designated locations statewide, where residents could browse and borrow. In October 1953, a teenage girl in Richland County in southeastern Illinois borrowed a copy of The Boy Came Back at a local high school, a drop-off point.

Indignant at the book's foul language and sexual content, the teen's mother took the book to county sheriff Jesse Shipley. It was the first in a series of outlandish reactions. Shipley in turn wrote a searing letter to Illinois Gov. William Stratton, decrying the book's "vulgar, obscene, and profane language" that would "lower the morality of American boys and girls"

He added that the book was "communistic in purpose" and went a step further, demanding the individual responsible for circulating the book be prosecuted with a legislative inquiry to follow.

The county superintendent of schools also weighed in, writing the state library that the book "was lewd in every sense of the word." Gov. Stratton forwarded Shipley's letter to Secretary of State Charles Carpentier, the official State Librarian, echoing Shipley's concern that The Boy Came Back was "communistic in purpose."

The episode was reflective of the decade. Dominated by McCarthyism, the Cold War, and conformity, the 1950s saw many authors, singers, and artists blacklisted for supposed non-traditional values

In Vincennes, Ind., just across the border from Richland County, the classic Robin Hood was banned for alleged "communistic influence." In Sapulpa, Okla, a handful of books dealing in "socialism and sex" were actually burned.

"That was a front-line issue in librarianship in the 1950s," said Spencer Brayton, the Library Manager at Waubonsee Community College in Sugar Grove, Ill. "There were a number of groups that petitioned individual libraries, as well as the American Library Association, to either ban or label items. In the majority of cases, librarians and the ALA took a stand against it."

In Springfield, Carpentier was equally alarmed by the concerns on The Boy Came Back. On Nov. 10, 1953, he ordered Assistant State Librarian Helene Rogers, the highest-ranking state library administrator, to "take out of circulation…books of a salacious, vulgar, or obscene character."

The vague directive left much room for interpretation. Rogers, who has been described as both energetic and autocratic, cracked that "if we acted on (Carpentier's memo) as it stands we would start with the Bible." For some reason, she elected not to inform the State Library Advisory Committee, the institution's oversight body, for several weeks.

Instead, Rogers quickly went to work, withdrawing massive numbers of books from state library collection. By mid- December, some 6,000 to 8,000 volumes were pulled. Finally, she told the Advisory Committee of the situation, and she and the members were clearly willing to pass the blame to Carpentier.

On December 16, the Moline Dispatch – the secretary's hometown newspaper – broke the story with the blaring headline "State Sex Education Books Ban!" The Dispatch, in an "exclusive series of conversations with state officials, legislators, and book borrowers," determined that "a purge of sex education books for teen-agers was in full blast in Illinois."


**Accessible:** A public notice is capable of being accessed by all segments of society.




