



The Company Band & Baseball Team

At the turn of the twentieth century, before the advent of radio, television and the multitude of communication devices that have since evolved, marketing of a product by most small businesses and retail establishments was limited pretty much to newspaper advertisement and word of mouth (the salesman's and the consumer's). Some creative thinkers also found that the cheap, mass produced novelty item, and trade card, helped many small businesses in this endeavor – but for a large industrial manufacturer selling a wholesale product for retail distribution, it was a whole different scenario – name recognition – and on as large a scale as possible. As a matter of fact, for many of the latter, and especially those in a highly competitive environment, it was the very foundation of their continued existence.

Take the brewing industry, for example. During this early era, it was found to be not only entertaining for the public, but extremely beneficial for the name recognition of the different brewers, to hold competitions featuring the finest draft-horse teams and rigs each company could put up. Competitions would be held across the country in an effort to not only win bragging rights – but to affix the company name in the collective mind of the public.

And it worked! At least for one of them. Today, some 100 years plus several more years after their first appearance – the Clydesdale draft-horse team is still almost synonymous with the name of a certain brewer. I'll let you guess which one. It starts with a "B".

So it was when the National Sewing Machine Company was founded and immersed in marketing its own products – and the company name. Mostly, the product manufactured had to speak for itself. Many of the items the National made were displayed at expositions and fairs – and high interest contests, like the Madison Square Garden bicycle race – to further their visibility and sales. Cultivating sales to large department stores also helped to effect name recognition. But the National needed more. They needed to connect their product and name with something – entertaining.

In 1898 "a meeting of the band musicians of Belvidere was called for the purpose of organizing a band to be known as the National Sewing Machine Company Band." Though initially a fledgling attempt, this "Band" idea was thought of as a possible vehicle for further distributing the National name through its eventual participation in, hopefully, major venue competitions. Until that time, it was a great way to promote local participation and create workforce pride in what was fast becoming a "company town."

A company baseball team was another avenue the National used to market their name while at the same time uniting the community with the company in this competitive sport.

Members of both the National Band and the National baseball team were culled from the local workforce as well as enticed to join through recruitment throughout the country.

Letters located in the Boone County Historical

Museum archives indicate that band hopefuls either inquired as to positions available or responded to a request from the National – from Kansas, Wisconsin, Iowa, Ohio, Indiana, Wyoming, and a variety of Illinois towns and cities. An inquiry into the position of Bandmaster was even sent from the Bandmaster of the Iowa Hospital for the Insane at Mt. Pleasant.

The same type of recruiting seems to have occurred with the baseball team. According to those I spoke to who worked at the factory, it seems there was always a job available for a professional player who was down on his luck or in between teams. Though local men made up most of the team, they often had the support of a player or players who had "experience".

Rumor has it that the baseball team was good enough to have once beaten the Detroit Tigers who made a train stop in Belvidere on their way to a scheduled game elsewhere. It seems the Detroit team needed some practice and the National team was more than willing to help them out. The game was played in a field located in the vicinity of where the Deans plant is today, off Meadow Street.

At least one fairly well known professional baseball player played on the team for a short time between contracts. His name was Chick Fraser. He ended his professional career pitching for the Cubs. Plug his name into an internet search engine on your computer and you'll find he was quite a colorful character with quite an interesting professional career.

In an era when concerts, parades, picnics, and any number of public festivities drew large crowds looking for entertainment – the creation of the band and the baseball team had what the National management thought would "fill the bill". Both were decked out in professional uniforms, which of course, prominently displayed the company name or initial. Bookings for both were highly advertised and the National took advantage of every opportunity to make the headlines in as many newspapers as possible.

Though the National Band never achieved the notoriety hoped for, it did, for a time, help to solidify the community with the manufacturer. It disbanded sometime in the latter part of 1900. It was mostly a case of the cost of upkeep outweighing the benefit.

The baseball team continued on for many years even after WWII – with a gradual evolution – becoming less an advertising tool, and more a way of keeping the company workforce happy, entertained and united.

Bryant lives with her husband and pets in McHenry. She will receive her Master of Library Science this December from the University of Missouri.

Letter to The Editor

Dear Editor:

Joe Sosnowski's website lists his goals, two of which are the need to create more charter schools and reduce wasteful spending.

Sosnowski is very quick to bring up charter schools as the solution to improving our education system. Perhaps this is because he is a member of the Elementary and Secondary Charter School Policy Committee. What Sosnowski isn't mentioning is that educational institutions are funded based on enrollment and implementing charter schools means a loss of finances for the traditional K-12 programs. Also, it is ironic that the same policymakers such as Sosnowski encourage school consolidation in order to promote fiscal efficiency and support charter school expansions. As a result, more small districts will be proliferated.

Sosnowski lists reducing wasteful spending as one of his goals. His goals are conflicted. Creating a charter school system results in more small districts. That is the problem.

As of July 1, 2017, there were 852 public school districts in Illinois, a state with 102 counties. 368 are elementary districts, 97 are high school districts 386 are unit districts and 1 Department of Juvenile Justice district. A number of these districts have only 1 or 2 schools in them. One would think that if Sosnowski was serious about reducing wasteful spending, he would be on a consolidation committee to reduce the number of school districts. Reducing the number of school districts would save Illinois tax payers hundreds of millions of dollars but policymakers like Sosnowski are too focused on what their political party wants.

Jason Goes to Stamford

This fall, Peoria resident Jason Spyres starts classes at Stanford University in California on a full-ride engineering scholarship. That fact alone shows he's one of Illinois' brightest and hardest working.

In admitting Spyres, Stanford acknowledged those virtues. But as he pursues his studies in California this year, he'll be patiently waiting for the same recognition from Illinois.

This August, before leaving for school, Spyres applied for a gubernatorial pardon for decades-old mistakes the state of Illinois has yet to let go.

He's not a typical incoming freshman to a university. He is 36 years old.

When he was 19 years old, he was arrested for selling cannabis, and until recently, the state of Illinois had kept him out of society for it. He served 15 years of a 30-year prison sentence at the Taylorville Correctional Center and was slapped with more than \$260,000 in fines. Now, with a record of model behavior and backing from law enforcement officials and a state lawmaker, he is asking for forgiveness.

"If I could go back, I'd slap myself and say 'grow up,'" Spyres said. "But I can't. All I can do is move forward, and do the best I can to help others see the mistakes I made before enduring the same consequences that I did."

As part of his personal petition to Gov. Bruce Rauner, state Rep. Allen Skillicorn, R-Crystal Lake, Peoria County Sheriff Brian Asbell and Bartonville Police Chief Brian Fengel all wrote letters to the governor recommending Spyres for a pardon. Peoria businessman Sean Kenny, who employed Spyres at Goldie's Pizza & Slots in Peoria, and retired correctional officer George Atterberry, who became acquainted with Spyres while he was incarcerated, also petitioned the governor recommending his pardon.

"I have read [Jason's] petition for a pardon and relief from fines, and believe granting his request is in the best interest of our state," Skillicorn wrote in his letter. "He served almost 15 years in prison and, by all appearances, has learned his lesson. Moreover, he is civic-minded and is using his time and resources to help others in his position come to the perspective he now has."

While Spyres' personal growth and success, as well as backing from elected and law enforcement officials, should make his case a slam-dunk, Illinois' outlook on criminal justice provides no guarantees.

Illinois did not even afford Spyres the same higher education opportunity Stanford gave him. If he were to go to the University of Illinois Urbana-Champaign, he would need to be on academic and disciplinary probation for his entire tenure.

"I got into U of I with an asterisk," Spyres said. "They said 'you're going to be on academic and disciplinary probation from the first day until you graduate, and it will never come off your record.'"

"I got out of prison and all of my counselors told me, 'Jason, you get out there and you make the life you told me you were going to make. We're so proud' ... So I get three years of parole done in seven months, and I can finally say the number K99397 has no tie to me. It's not

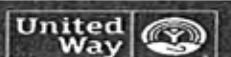

on a piece of paper tied to who I am.”

“And U of I wants me to take that back ... And remind myself of it everyday.”

Spyres knows he made a mistake. In 2001, his mother sent him 38 pounds of cannabis from Red Bluff, California, to Spyres’ then-home in Decatur. According to court documents, a Staples employee in Red Bluff became suspicious of the package when Spyres’ mother dropped it off in poor condition and had a nervous demeanor. The package was turned over to law enforcement and shipped to the Decatur Police Department. An undercover police officer posing as a UPS deliveryman then brought it to Spyres’ home, began searching his home pursuant to a warrant and found the UPS tracking number matching the package.

Spyres was sentenced to 30 years in prison, and racked up fines nearly impossible to pay back. He makes no excuses for his behavior, but hopes the state agrees that it’s time to turn the page.

“I’m \$268,000 in debt because I sold pot when I was 19 and 20,” Spyres said. “You can say all day you know what it’s like for somebody when they get out [of prison] and try to do the right thing. Tell me you know what it’s like when you have debt collectors calling you trying to take your paycheck, and it’s going to take 18 years of every penny you earn after taxes to pay off your fine.”

Spyres’ sentence and fine were as harsh as they were due to Illinois’ “Class X” classification for large possessions of cannabis. A Class X classification – which includes possessing more than 5,000 grams of cannabis with intent to deliver – is among the state’s most severe, short of first-degree murder. Class X felonies carry a mandatory sentence of between six to 30 years in prison, and those convicted are not eligible for probation.

Among the other charges under Class X: kidnapping, battery with a firearm, battery of a child, home invasion, aggravated criminal sexual assault, predatory criminal sexual assault, armed robbery, vehicle hijacking and arson.

In Illinois, nearly half of offenders released from prison each year will return within three years. But for an ex-offender who finds work within a year after release from prison, there is just a 16 percent chance of recidivating, according to a study by the Safer Foundation.

Spyres fortunately found work at Goldie’s Pizza & Slots, which helped him get on a positive track. That’s not only a win for him. But an ex-offender finding work is a win for all Illinoisans.

Each time an ex-offender reoffends and ends up back behind bars, it costs the state approximately \$151,662 on average, according to a 2018 report by the Illinois Sentencing Policy Advisory Council. Those costs add up in arrests, trials, court proceedings, incarceration and supervision; as well as costs for victims who have been deprived of property, incurred medical expenses,

lost wages, and endured pain and suffering; and indirect costs in foregone economic activity.

The report estimates that if Illinois’ recidivism rate stays about the same over the next five years, taxpayers will pay more than \$13 billion in the aforementioned costs. On the flip side, with a reduction in recidivism of just 1 percent, Illinois would save \$90.1 million in prison, court and policing costs over nine years. If the recidivism rate fell by 5 percent, these savings would jump to nearly \$450.7 million over nine years, along with \$75.5 million in avoided economic losses and \$224.1 million in victimization costs not incurred.

Lawmakers have made some progress: In 2016, Rauner signed into law a bill that removed barriers for ex-offenders in the fields of barbering, cosmetology, esthetics, hair braiding, nail services, roofing and funeral service, unless the crime is directly related to the occupation.

Also in 2016, Rauner signed into law a bill that decriminalized small amounts of marijuana – up to 10 grams – making it instead punishable by a fine of between \$100 and \$200. While small, these reforms are steps forward for Illinois’ criminal justice system.

Now, with the stroke of a pen, Rauner could make a decision that would directly improve the life of an Illinoisan who already paid his debt to society. Jason Spyres is a model citizen and an inspirational success story. In the future, he could be a permanent Illinoisan once again – something he hopes for after Stanford – and granting forgiveness would be an ideal way to welcome him back.

“Illinois is my home

state,” Spyres said. “I have to know that I made this place better. The only thing I have to point to my actions in Illinois is that I went to prison. I kind of wanted to go to U of I to say that I went to Illinois’ flagship campus and I made something of myself.”

“I’m really just trying to fix the system, and that’s why I want to come back.”

With the humility of having gone through the system, and a track record of overcoming past setbacks, the state might benefit from more Illinoisans like Spyres.

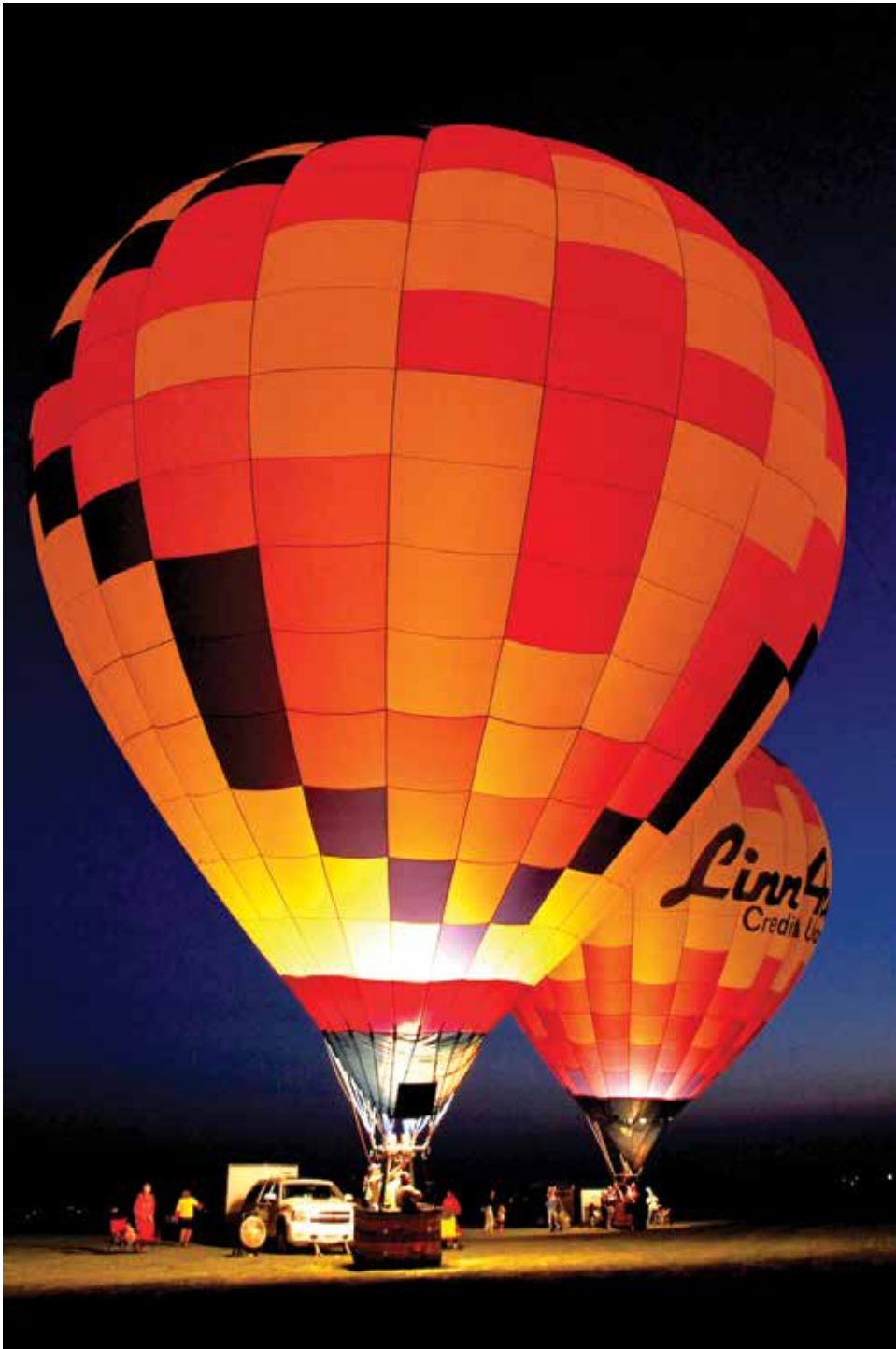

Assistance in Voting in November

Boone County Clerk, Julie A. Stapler, wishes to inform registered voters who are elderly or have disabilities of the many aids and provisions for assistance in voting at the upcoming election. Stapler said that her office welcomes inquiries by anyone who feels they may wish to take advantage of these aids at the November 6, 2018 General Election.

Stapler stated all registered voters may vote by mail. They may contact her office to request an application or print an application from the County website at www.boonecountyiil.org. After filing the application with the County Clerk's office, the ballot will be mailed to the voter at home, or wherever he or she may be at the time, along with complete instructions for voting and returning the voted ballot. Voters have until November 1, 2018 to submit an application.

Early voting is also available at the County Clerk's Office beginning September 27, 2018 through November 5, 2018. The only difference between early voting and vote by mail is that you would have to vote in person for early voting.

Judges of Election are permitted to deliver a ballot to any voter who cannot get into the polling place on Election Day if an application has been received in the County Clerk's office prior to Election Day. These judges may deliver the ballot to the voter at the point at which he or she is unable to continue toward the Polling Place as long as this point is within 50 feet of the Polling Place entrance. Assistance is also available in the Polling Place. A touch screen voting machine will also be available that is specifically designed to assist voters with disabilities to cast their vote in the County Clerk's Office or the Polling Place.

She went on to say that all Polling Places throughout the County are disabled accessible and will have disabled parking spaces available near the building entrance. In addition, all Polling Places will be equipped with special visual aids to assist voters.

Stapler urges everyone to take advantage of the right to vote at this Election, and to feel free to request assistance from the Election Judges on Election Day. They are specifically trained to render this assistance and welcome the opportunity to be of help.

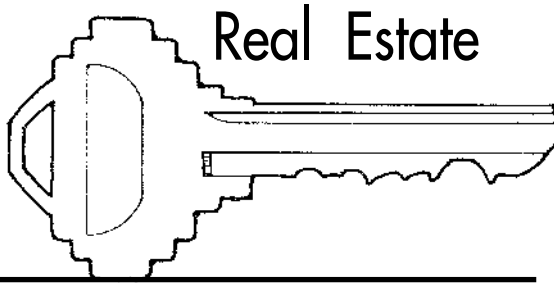
