Diving into Summertime

The 2017-18 school year has finally come to a close here in District 100. We've reached summer time at long last. To children of all ages, the next three months will revolve around having all the fun that just can't be fit into a school year. So, what does that mean in Belvidere? As many are aware, a hot summer day attracts a large portion of the area's youth to the local park pool. Located in Belvidere Park, William Grady Pool plays a major role in the summers of the youthful population. Those who have passed through the pool's doors have witnessed an innumerable amount of important experiences at the park pool without even realizing it. First jobs, first times learning to swim, first friendships, even first sunburns. It is undeniable that the park pool is the known place to be in the summer time-and it's been this way for a while.

As a few older residents may remember, there was a point on Belvidere's timeline where there was no local swimspot to hide from the heat. It wasn't until October 5, 1938 that a swimming pool project was approved for construction. Nearly three years later, a final product was in place—the Belvidere swimming pool. The pool was officially opened to the public on July 9, 1941. To add additional cause for celebration on the day of the opening, the pool hosted a Miss Belvidere pageant. Thousands came to witness the contest as beauties from across the area demonstrated the "grace and glamour," of being a woman. At the end of the night, it was Miss Billie Higgins that went home with a first place victory - and for Miss Marjorie Arthur, the title of Miss Belvidere Jr.. Miss Higgins was not the only town royalty to come from the Belvidere swimming pool. Miss America 1969, Judy Ford, worked as a lifeguard and taught swim lessons at the very same place.

As time went on, the pressing need for progress eventually influenced development at the pool. In 1979, a new children's pool and snack stand were built within the pool fences. The log cabin outside the building, which was once the original snack stand, has since been used for storage and alternative use. Five years later, the main pool was updated as well. In the 90s, the changing and bathing areas were redone in order to benefit a wider variety of patrons. Gradually, the pool evolved into the one that sits there today.

While construction-related changes obviously occurred, it seems that the foundation of having a place for community recreation has withstood the course of time. Places such as this help to bring people together,

to make Belvidere feel a little less spread out. As times are changing, technology has begun to alter just as rapidly. Despite the many benefits that come with this, a major drawback comes from the fact that we, as a society, are becoming increasingly less personal or social than ever before. Not many people associate with their neighbors, let alone people they meet in the streets. Smaller-scale places, such as a local public

On Monday, June 4, Belvidere's City Council met in the City Council Chambers to discuss new business in the next fiscal year.

A decision made by the council this week has the potential to change how travel is done around town. The city's alderman unanimously approved an agreement with Neutron Holdings Inc. to bring LimeBike to Belvidere.

Similar to the rental bikes that are stationed throughout the streets of Rockford and Chicago, LimeBikes are positioned all over, ready to be used by anyone at any time. Curious as to what all of the green bikes around Rockford are about? That's LimeBike at work. The company is new, and based out of San Mateo, California. LimeBike currently has stations in just over 50 cities across the nation. Much like

> Uber, a potential LimeBike rider downloads the app and makes purchases through digital transactions. To ride a LimeBike, customers pay \$1 for every 30 minutes spent using the bike.

> When a customer is done riding their LimeBike, they do not have to return it to the sharing station they found it at. Using GPS technology, LimeBikes are tracked and found by designated collectors to be picked up later on.

> Having LimeBikes here in town has multiple benefits. Biking promotes exercise and encourages eco-friendly travel at a low price. It appears that the City Council is on board with the idea and plans to move forward with the project.

> In other matters, the City Council discussed revising their budget for this fiscal year. According to City Finance Director, Becky Tobin, Belvidere saved a significant amount of money in the past year.

> 'We did end the year on a much better note than I thought we would. We had anticipated to spend over \$1.1 million of reserves this last year and we only spent about \$22,000 of reserves," said Tobin.


> The council approved the budget revision for the new fiscal year and plans to use the funds to carry on with projects that were in the process from the last year.


flowers, along with planting a small flag. Special attention is given to the grave of Stephen A. Hurlbut, a Civil War veteran buried in Belvidere.

Hurlbut joined the Union army and soon became a Brigadier General (one star) and was promoted to Major General (two stars) on September 17, 1862. After the war, Hurlbut became the Commander in Chief of the Grand Army of the Republic, a fraternal organization of veterans of several military branches. While this original organization does not still exist, its successor organizations still do, and the Post G.A.R. was involved in the celebrations on Memorial Day. Eventually, Hurlbut became a member of the US House of Representatives serving Illinois's fourth district, and served two terms until his defeat in 1876. Afterwards, he served as Ambassador to Peru until his death in 1882 in Limaat age 66. Hurlbut and his wife are buried in Belvidere Cemetery.

A local organization exists today in Boone County with the sole intention of honoring American Veterans, and with a focus on those who fought in the Revolutionary War: the Sons of the American Revolution. The local chapter has roots back to 1978, and still actively hosts events.

Muddy Waters Wrote the Songs of Chicago's Blues Legacy

Since June 2017, Muddy Waters' image has beamed down from a 10-story mural at 17 N. State St. in Chicago. But the king bee of Chicago blues looms even larger over the city with his outsized musical and cultural legacy.

The Mississippi Delta native, born McKinley Morganfield in 1913, followed the Great Migration to Chicago in 1943, where he found stardom with his groundbreaking electric guitar sound and classic bands. He died at age 70 in 1983, but new generations of artists often cite the influence of the six-time Grammy winner and Rock and Roll Hall of Famer, and Waters' songs such as "I'm Your Hoochie Coochie Man" and "Rollin' Stone" are used frequently by filmmakers and advertisers.

International tourists visit Chicago to bathe in Waters' lore, including a visit to his longtime home at 4339 S. Lake Park. There's not much to see, though, because the house that Tim Samuelson, Chicago's cultural historian, has called Chicago's most historic home has stood vacant and in a state of disrepair for many years. Plans are stalled to convert the Kenwood two-flat into a museum or other attraction.

Waters' bluesman son Larry "Mud" Morganfield, who like his dad is a singer-songwriter-guitarist, spent time at the house, but never lived there. But he quickly rattles off the names of blues stars who did.

"James Cotton, Pinetop Perkins, Otis Spann and Little Walter all stayed there, and everyone from Paul Butterfield to Keith Richards went there," Morganfield said. "I don't care to have that house. What I care about is the house standing and representing Chicago as the real house of the blues. ... Chicago needs to keep this man's legacy alive."

Morganfield admitted that being the son of a blues immortal can be a double-edged sword from a career standpoint.

"It's both a curse and a blessing," he said. "You have people who say, 'He sounds like his dad, but he ain't Muddy.' Of course I'm not. But I have other people come up and tell me, 'I had a lump in my throat because you remind me so much of your daddy.' "

Others who want to walk in Waters' footprints may visit the Chess Studios (www.bluesheaven.com/historic-chess-studios.html) at 2120 S. Michigan, where the bluesman recorded many of his best-known records and rock 'n' roll icon Chuck Berry strutted his stuff. Family members of the late Willie Dixon, who penned some of the biggest hits of Waters and fellow Chess artists such as Howlin' Wolf, operate the studios with their nonprofit Blues Heaven Foundation.

Keith Nelson, Dixon's grandson, conducts the tours and serves on the Blues Heaven board of directors. He said tours, which cost \$10, are given hourly from noon to 4 p.m. Monday through Saturday. He said between 100 and 350 people tour Chess weekly, and many ask about Waters.

"He's always a huge part of the legacy," Nelson said. "Muddy would be your most popular artist. He was your face. I'm a big comic book fan, and if you had a blues comic book, Muddy would be your Superman."

Musicians seeking to capture the Waters mojo may soon have their choice of two recording studios at Chess. "We're planning to put older recording equipment from 1961 upstairs and modern recording equipment in a new studio downstairs," Nelson said. "Hopefully this project will be done by the end of

2018 or early 2019."

Carrying on the legacy of Waters and other postwar Chicago blues greats is the mission of current Chicago blues kingpin Buddy Guy, who once operated the late, lamented Checkerboard Lounge on a section of East 43rd Street renamed Muddy Waters Boulevard. Guy moved Downtown in 1989 with his Buddy Guy's Legends (www.buddyguy.com), now at 700 S. Wabash.

While sweet home Chicago takes pride in its reputation as "the home of the blues," with a lakefront festival that has drawn hundreds of thousands of music lovers yearly since 1984, the city also is a cornerstone of modern jazz. In fact, Chicago's jazz fest predates its blues bash by a decade.

King Oliver and Jelly Roll Morton were early stars on the jazz scene, and the immortal Louis Armstrong further popularized the New Orleans sound in Chicago in the 1920s. Later Benny Goodman and a host of fellow big-band leaders swung at ballrooms such as the elegant Trianon in the Woodlawn neighborhood and the Aragon in Uptown.

Today the Association for the Advancement of Creative Musicians (www.aacmchicago.org) guides Chicago jazz in adventurous new directions, and the Green Mill Cocktail Lounge (www.greenmilljazz. com), 4802 N. Broadway, builds on its Prohibitionera tradition.

"Rendezvous With The Blues"

Blues: a genre that combines the beauty and fluidity of music with the ever-constant presence of hardship in rustic America. It was born in the cotton fields of the nineteenth century. Slaves and indentured servants put in endless work days in the sweltering heat of Southern plantations, sharing their sorrows through folk music. It traveled north up the Mississippi River, reaching the Midwest.. Louisiana. Then Memphis. Eventually Chicago. By the 1940s, Blues began to develop, as it mixed in with northern culture. Throughout the 50s and 60s, it melded with pop culture, and influenced other genres-Jazz, Country and Rock.

However, in the past few decades, the Blues has evolved into a dying genre. While the music itself still has a following of its own, there aren't as many Blues artists dominating the top charts these days. Is this the end of an era? Maybe not.

The Crossroads Blues Society is invested in keeping Blues alive. This nonprofit organization holds fundraisers to bring Blues into the local school system. A majority of the revenue comes from the festivals the Society holds. These feature live entertainment, musical challenges and workshops. The 9th Annual Crossroads Blues Festival will be held on August 25 at Lyran Park in Rockford. Gates open at 11 AM and close at 10 PM.

One of the musicians headlining the event is Toronzo Cannon. Toronzo is an original performer that is vastly praised in the Chicago area. Crossroads Blues deemed him the "hottest Chicago Blues act out there." This will be his third music appearance in Rockford. To see him live and in action, check out his performance on August 25 at 6 PM on the main stage.

The Monster Mike Welch/Mike Ledbetter Band Connection is also headlining the festival. Monster Mike Welch is originally from Boston and has worked with Blues names from all over, becoming well known through the grapevine for his Not enough Blues? The Chicago Blues Festival begins tonight at the Jay Pritzker Pavilion in Millennium Park. The festival goes on throughout the weekend, ending on Sunday night. Chicago Blues is celebrating the 65th anniversary of Delmark Records. Based in Chicago, it's among the first Jazz and Blues labels created. Buddy Guy. Lurrie Bell. Dave Specter. Some of the oldest and most popular Jazz and Blues artists in the Chicago area (and beyond) have been a part of this company.

Tonight, come see the Corey Dennison Band perform at 5:30. The band's performances are renowned across the Chicago area. Their claim to fame is being known as "the new sound of Chicago." Following, at 6:30 is Mississippi Heat, accompanied by Billy Flynn and Giles Corey. The night will conclude with a series of tributes to the early artists of Blues, dedicated to artists such as Junior Wells, Roosevelt Sykes and Willie Kent. On Saturday, catch Selwyn Birchwood at 5:30, followed by Willie Clayton at 6:45, then a Little Walter tribute at 8 PM. The last day of the event will be kicked off by Fantastic Negrito at 5:30. His music ties in Blues with R&B and folk. After him, Kenny Neal will perform, followed by Mavis Staples. Each night of the festival will end at approximately 9:30 PM. And best of all, it is free and inexpensive to reach via public transportation. Park at the Cumberland Station and take the "Blue Line". Round trip \$5.

Carry Moonbeams Home In A Jar

Several thousand people made the trip to Yerkes Observatory over the Memorial Day Weekend for the Starlight Festival. We saw some old and new friends from Belvidere among them. The Man on the Moon, his face slightly askew, glanced down at the assembled attendees as they shopped for new telescopes, launched model rockets and watched cryogenics experiments, entertainingly conducted by Fermilab's "Mr. Freeze."

A speaker from the Jet Propulsion Laboratory told us of her decades with the Cassini Project and the exploration of Saturn. Apparently, Saturn's moon, Enceladus, is a potential habitat for microbial life. We learned even more about the search for extraterrestrial intelligence conducted at SETI. Telescopes were set up on the grounds to look up at the heavens, including Antares, the bright red star in Scorpio.

For many first-time visitors, the highlight of the day was to see the 40-inch, refracting telescope inside the observatory. The one that so many famous astronomers used. And a few lucky stargazers got to look through that telescope into the heavens.

It was a beautiful day and a grand time. In addition to a lot of now-gray-haired folks who distinctly remember Neil Armstrong's words from the Moon, there were fascinated children present as well. Many of us wondered if we might be seeing a future astronaut bound for Mars, or perhaps a soon-to-be accomplished physicist or other scientist. Or maybe a physician, inspired by the scientific atmosphere of the day.

The University of Chicago is the premier institution of higher learning in the Midwest and one of the greatest in the World, generally ranked among the top ten. It includes 97 Nobel laureates who have distinguished themselves in fields as diverse as economics and creating the first man-made nuclear chain reaction. The school operates the Fermi National Accelerator Laboratory, Argonne National Laboratory, the Marine Biological Laboratory and soon, the Barack Obama Presidential Center. Its distinguished alumni include sixteen billionaires and heads of state of countries all over the world.

For the past 120 years, the Department of Astronomy and Astrophysics has been headquartered at Yerkes Observatory in Williams Bay. Yerkes has been the home of many renowned scholars, famous experiments and scientific discoveries of its own.

The Yerkes Campus, however, no longer meets the needs of the Department. On October 1, the Department will move to the Hyde Park Campus, ending over a century on the shores of Lake Geneva at Williams Bay.

We can hardly blame the University of Chicago for moving on. The University of Chicago has interests in telescopes and research all over the world, most notably in Chile. Yerkes is, indeed, a victim of its own success. The mission of the school is the growth of knowledge and the enrichment of human life. It would be a poorer world if Chicago were to abdicate from the cutting edge.

A study has already begun to determine the future of Yerkes and how it might be responsibly transferred to a group that could accommodate the outreach and educational potential of the facilities. We sincerely hope that effort is a resounding success.

We teach our children how to read and do arithmetic. We take them to the Field, the Museum of Science and Industry and other institutions to inspire them. We remember that our parents did that and that our lives are the richer for their efforts and sacrifices. We try out best to set a good example. Yerkes is another opportunity for our young people to reach for the stars, both literally and figuratively. We would love to see that opportunity not only maintained, but enhanced.

With such richness in our midst, we need to remind our community of the importance of world class education and the need for high-attaining elementary and secondary schools in Boone County. Our schools, whose average test scores don't crack the fortieth percentile, alarm us and give us serious concern about the future prosperity of Boone County and its residents. Furthermore, it should go without saying that all of our children also need a modern, 21st Century public library.

Not every child will grow up to be a nuclear physicist or molecular biologist, but each child should have the right to realize his or her full potential.

The local Sons of the American Revolution will be honoring Belvidere's Revolutionary War veterans on June 16. Belvidere citizens wishing to pay their respects can come to the famous Pettit Memorial Chapel, in the Belvidere Cemetery, on June 16, 2018 at 11:30AM. Organized by members of the Illinois Kishwaukee Chapter of the Sons of the American Revolution, this event will commemorate two veterans from the Revolutionary War, Timothy Lewis and Thomas Hart, who are buried in the Belvidere cemetery. The highlight of the ceremony will be the unveiling of two historic markers describing the life of these two veterans. The markers will be read by Jacob Shadinger, Illinois President of the Children of the American Revolution and a student at Belvidere North High School.

The ceremony will include speakers such as Dick Chamblin, President of the Illinois Sons of the American Revolution; Franz Herder, Founder of the Cemetery Marking Program; and Sam Larson, Sexton of the Belvidere Cemetery.

Timothy Lewis was a Revolutionary War veteran born in 1764 in Ashfield, Massachusetts, and enlisted in the Army in April of 1779. After a scarcity of food and clothes, Lewis became ill and his father took him back to Massachusetts. During this time he met his wife, Thankful Molly Brady, and had eight children. They lived in New York, Wisconsin, and finally Boone County. Timothy Lewis died in 1858, at age 94.

Timothy Lewis's fourth generation grandchildren will be present at the unveiling of the historic marker for their ancestor.

Thomas Hart was born in Farmington, Connecticut in 1757, and served in the army on three separate occasions. The first, he enlisted and joined the Connecticut Troops in May of 1775, serving 8 months. His second service was for three months in Brooklyn, New York, and his final service was for one month under Captain John Pierce in 1777. He was personally acquainted with Benedict Arnold, a general famous for defecting to the British. After the war, Hart married Ruth Payne and had twelve children before moving to Belvidere around 1844. Hart died in Belvidere in 1847, at age 89.

Rauner: State Purchase of Transitional **Home for Quincy Vets** to Close Friday

Gov. Bruce Rauner announced Tuesday that the state is on track to close Friday on the purchase of the shuttered Sycamore nursing facility, which will be retrofitted to house the residents of the nearby Quincy Veterans Facility that were displaced after 13 residents died from Legionnaires' disease.

Rauner said the newly passed budget included \$53 million for the planned veterans facility with more to come.

"We'll be investing several million dollars to upgrade that facility to make it nice and appropriate for our heroes," he said.

The Sycamore location, Rauner said, doesn't have much of the outdated construction that the aging facil-

"That building has much more modern

plumbing, much more modern pipes and we'll be able to treat those and enhance those in a way that we can have high-quality water for the heroes and our wonderful staff," he said.

Rauner said previously that the outdated plumbing at the current home was the contributing factor that led to the tragic deaths of 13 residents from Legionnaires Disease in recent years.

Rauner also announced that retired Brig. Gen. Stephen Curda will start immediately as the new director of the Illinois Department of Veterans Affairs.

Curda previously worked at the National College of Education and was special assistant to the president for Veterans Education at National Louis University. His last enlisted post was as commander of the 9th Mission Support Command in the U.S. Army Pacific, responsible for 3,600 personnel spread throughout the Pacific.

Rauner said Tuesday that Illinois Department of Healthcare and Family Services Director Felicia Norwood's last day is June 15 after she accepted a position with a private employer. Rauner praised Norwood for securing a federal waiver to spend \$2 billion on new behavioral health services and for updating information technology systems.

Illinois to Guarantee **Student Assistance Grants for Four Years**

Students who get a Monetary Award Program grant this fall will have more security, although the state program will likely have far more students who apply for the grants than there is money to fund them.

Illinois is, for the first time ever, guaranteeing MAP grants for four years. The grants, which don't have to be repaid, are awarded based on financial need. But they are first come, first serve. And many students who qualify for a grant don't get one.

State Rep. Dan Brady said the additional \$25 million in the new state budget, added to the nearly \$350 million already available, likely won't change that. But he said the four-year guarantee will make things easier on students.

"That's \$25 million that we found within the state budget," Brady said. "And with a match from the universities, that's going to mean a four-year stability for students who receive MAP grants."

Brady said lawmakers focused in the new state budget on helping colleges and universities in Illinois. But he said they didn't want to just throw money at schools for administrative costs.

"There are several things that were done for the universities and the students," Brady said. "We're not talking about just giving more money for general operations. We're trying to say, 'How do we help those students, and how do we keep those students here in Illinois?"

To that point, the new state budget includes \$50 million for AIM HIGH scholarships, a program Brady said was designed to encourage Illinois students to go to Illinois universities.

Tim Hardy, a spokesman for the University of Illinois, said the programs will help the students and university by providing predictability and reliability. During the more than two-year state budget stalemate, MAP students weren't sure if they would get money from the state. Some universities fronted students the

money and waited for reimbursement from the state, other schools couldn't afford to do so.

"Students and their parents who depend on MAP were being whipsawed by the crises of the past several years, and universities were left holding the bag for essentially an unfunded mandate. This gets us back to normalcy," Hardy said in a statement Tuesday. "The AIM matching funds scholarship plan will help universities in Illinois stem the outbound tide of students enrolling in other states."

Gov. Bruce Rauner signed the state budget Monday. It takes effect July 1.

Professor Calls for Troops on Ground in Chicago to Fight Gangs

A professor teaching in Chicago wants President Donald Trump to send in the military to deal with gang violence.

The federal government bans the use of the armed forces in a law called the Posse Comitatus Act. The act does allow the president to temporarily suspend the law and allow the military to work with law enforcement. That's exactly what Jason Hill, professor of philosophy at DePaul University, said Trump needs to do in order to stop the gang violence in Chicago.

"They are waging terrorism on these cities," Hill said. "Carry through on that campaign promise. Send in the troops and clean this city up."

Hill said each of the last three presidents has suspended the act. While he's technically correct, they did it largely to send in special operatives like Delta Force to act as a SWAT team of sorts. The 51-day siege of the Branch Davidian Compound East of Waco, for instance, employed Delta Force members but only as observers. Troops have also been sent to the Mexico border to stop drug trafficking.

Hill said his students have shared eye-opening stories of gang intimidation.

"One student who said he had to drop out because he had to cross gang turf to get to school," he said. "He was told he had two choices: Either be killed or join a gang."

Hill has been criticized for his opinion on the matter and accused of endorsing a police state.

"Sending federal troops would encourage naked demonstrations of force that could traumatize communities and further increase distrust of law enforcement for years to come," said Ed Yohnka, Director of Communications and Public Policy with the ACLU of Illinois.

In Chicago, 36 people were shot, seven fatally, over the Memorial Day weekend. But the city has seen 15th consecutive months of declines in shootings.

Hot May Breaks Records Across Illinois

If you thought last month was hotter than normal, you were right.

Cities across Illinois and the state as a whole experienced the hottest May in recorded history.

Illinois' a long state. It's usually warmer in Cairo than in Rockford. But, as a whole, state Climatologist Jim Angel said Illinois hasn't seen a May with more days of above average temperatures.

"The statewide average temperature for the entire month was 70.6 degrees, 7.9 degrees above normal for the whole state and the warmest on record," he said

Many cities saw the same situation.

"In Quincy, Springfield, Champaign and Carbondale, every day was at or above normal for this time of year," Angel said.

Other cities like Rockford were close but had a couple cool days that lowered their average.

A warm May doesn't necessarily mean June, or July for that matter, are guaranteed to see hotter-than-normal temperatures, Angel said, but June is forecasted to be warmer than normal.

Lawmakers Pass Ethics Reforms without Giving Legislative Inspector General Autonomy

Changes are coming to the way complaints about lawmakers and their staff members are handled after repeated problems with the system, but some say the reforms don't go far enough.

The House and Senate on Thursday, the final day of legislative session, passed a bill with a series of reforms to the state's various inspectors general. Some of the reforms include providing more reporting on the number of complaints filed, investigated and pending. There were also some changes to the Legislative Inspector General position, allowing it to be a full time post and requiring a search committee to find a permanent LIG, rather than a temporary Special LIG, as there is now.

This all comes more than six months after the nationwide #MeToo movement exploded in the entertainment industry with allegations of abuse of power and harassment claims. That then lead to people in the halls of the U.S. Congress and statehouses across the country coming out with their own stories of harassment. In Illinois, 300 people signed onto a letter describing harassment and other ethics complaints under the dome in Springfield.

Task forces in the Illinois House and Senate got feedback during multiple hearings after listening to workers in the public and private sectors about their experiences. They also took suggestions on how to make the complaint process more fair and responsive.

Denise Rotheimer, a victims' rights advocate who last October alleged state Sen. Ira Silverstein abused his power by making unwanted advances toward her while they were working on a bill, went through the Legislative Inspector General. Her outing of Silverstein also revealed a more-than two-year vacancy of the LIG position, which left two dozen complaints sitting on a shelf.

Thursday, standing next to another woman who said she was abused by a different leading lawmaker, Rotheimer said the ethics complaint process was flawed.

"You can't have legislators overseeing legislators," Rotheimer said. "They control the entire process. Who investigates, who does what, who says what. What gets investigated."

The existing law requires the LIG to request permission from the Legislative Ethics Commission, a panel made of a bipartisan group of eight lawmakers, before investigating a complaint against a lawmaker or one of their staff.

Rotheimer is pushing for the LIG to be independent and for accusers to have certain rights in the complaint process, something she said is not guaranteed by existing state law.

State Sen. Karen McConnaughay, a Legislative Ethics Commission member, said the system of filing ethics complaints was broken. She said House Speaker Michael Madigan has a conflict in asking for an investigation into his office.

"So in Mike Madigan's case, Mike Madigan allegations, or findings, about Mike Madigan go to Mike Madigan," McConnaughay said. "How is that not a conflict of interest?"

McConnaughay also said there's a conflict with current special LIG Julie Porter, who had been interviewed for the job by Madigan's attorney. The the LIG gets a criminal complaint, it would be forwarded to Attorney General Lisa Madigan, the Speaker's daughter, McConnaughay said.

"Don't think I see the conflict," Madigan's spokesman Steve Brown said in an email.

"Julie Porter is a well known former federal prosecutor with impeccable credentials and no known ties to the General Assembly," Brown said. "The [Legislative Ethics Commission] and the leaders have been searching for an inspector general since Bill Roberts resigned. All four legislative caucuses were given Julie Porter's name and résumé, and anyone could have reached out to Ms. Porter. One of our attorneys did contact her to determine if she was interested in the position."

As to the questions of possible conflicts Madigan has with his daughter as the attorney general, Brown

said, "I think I will defer on the other items since these are hypotheticals."

The legislature Thursday passed several reforms, but the reforms stopped short of giving the LIG the ability to investigate complaints without permission from lawmakers.

State Sen. Malinda Bush, D-Grayslake, got last-minute ethics changes through the statehouse, but said they didn't go far enough to provide needed independence.

"That is absolutely a key component that the Legislative Inspector General is allowed total autonomy," Bush said.

She said she filed a bill this week that would require that autonomy.

State Rep. Kelly Cassidy, D-Chicago, who said Madigan loyalists attempted to intimidate her for speaking out, said the fact that the LIG has to get permission from the commission to investigate is troubling.

"If we can't even accept that there should be that modicum of independence, we've got bigger problems," Cassidy said. "I'm very frustrated by that."

Also Thursday, the spot left vacant by Skokie state Rep. Lou Lang stepping down from post on the commission that oversees lawmaker ethics complaints was filled by another lieutenant to Speaker Madigan.

Records show House Majority Leader Barbara Flynn Currie, D-Chicago, as the new member. The position will again become vacant in the new year as Currie is not running for re-election.

Lang stepped down Thursday from his positions on the ethics and rules making commissions, as well as his deputy majority leadership post.

Trump Talks about Commuting Former Gov. Blagojevich's Sentence

There's a new conversation about when former Illinois Governor Rod Blagojevich may get out of prison.

President Donald Trump told reporters on-board Air Force One Thursday that he is thinking about commuting the former Illinois governor's 14-year prison sentence.

Trump said he's not sure Blagojevich needs to be behind bars for "saying something stupid."

Trump said something similar in 2016 when he spoke to the Chicago Tribune editorial board.

"I think it's an awfully tough sentence that he got, for what he supposedly did," Trump told the paper in November 2016. "Because what he did is what politicians do all the time."

The president said Thursday he is "seriously thinking of a curtailment" of the former governor's sentence.

Not every Illinois politician agrees.

Bloomington-Normal state Sen. Jason Barickman said ending the former governor's sentence early will not go over well with many.

"I think it will not be well received in Illinois," Barickman said. "We are very familiar with Gov. Blagojevich's efforts to shake people down for money, for all sorts of things, including a prized U.S. senate seat."

Although Barickman said he wasn't sure talk of a commutation isn't just Trump trying to do what he does and push a story.

Blagojevich is about halfway through his 14-year sentence in federal prison on his conviction of trying to sell President Barack Obama's former U.S. Senate seat and other corruption charges.

The governor's lawyers said this week that they are preparing a formal petition for commutation to send to Trump.
