A Restaurant Makes a Community

For over 30 years, Belvidere had a restaurant that was at the center of community life. That was common in Belvidere in the middle of the last century. The Dearth Brothers Restaurant was just that kind of a place. The owner worked in the restaurant and knew you and your family by name

Seven brothers made a living by establishing a chain of restaurants in Belvidere, Sycamore, DeKalb and Rockford. Frank and Joe Dearth opened their first restaurant in Sycamore, followed by a restaurant in the DeKalb train station known as the Aurora/DeKalb Depot. This is where their younger brothers, Lou and Victor, learned the business. In 1922, the Belvidere location was established. Business was going well in DeKalb, and in 1923, the brothers remodeled the DeKalb restaurant. The local paper referred to the restaurant as a "lunch room".

In 1937, the Dearth restaurant in DeKalb expanded into a larger space across the street from the depot. Finally, in 1947, the Dearth brothers opened a fourth restaurant in Rockford next to the Midway Theater and called it The Midway Restaurant. Willard and Phillip managed that restaurant

In making the move to Belvidere in November of 1922, just four years after the 1918 pandemic, Lou and Victor Dearth bought out Ned Higgins Auto Inn restaurant at 112 Logan Avenue. Later brother Leo joined them here. The three of them are in this week's picture. The building was a two-story located on the north side of Logan Avenue between the Julian House and State Street. Apartments were located on the second floor. Today it is a parking lot.

In 1931, an advertisement appeared, expressing the Dearth's approval of the new concrete road that connected northern Boone County to the city. The business had become a part of the community and hosted many events.

One Tuesday evening, July 5, 1926 a couple passing through Belvidere in route to Chicago stopped at the Dearth Brothers Restaurant. The couple wanted to catch something to eat before heading out. They were coming from Rockford, which was the hometown of the groom, and they had just married. The grooms name was Salvatore Mandala a.k.a Sammy Mandell a.k.a "The Rockford Flash" because of his fast hands and foot speed a.k.a "The Rockford Sheik" because of his Rudolph Valentino good looks and he held the World lightweight Boxing Title from 1926 to 1930! Mandell developed his fighting skill in the Camp Grant barracks in Rockford. Despite being too young to join the Army, and only 105 pounds, he was allowed to spar with the troops because of his natural talent. He was known as a cleaver fighter who had a solid punch and good defensive skills. Sammy had just fought Rocky Kansas on Sunday at Comiskey Park, winning the world championship in his weight class, which he held for the next 4 years.

Sports award dinners were held at the restaurant. In 1946, when polio irradiation was in full swing, the local chapter to irradiate polio held a retirement party for its chairman. The list goes on and on because of the food and good spirit the brothers carried.

The Dearth Brothers were known for serving Sunday chicken dinners, but during World War II, particularly in 1944-45, the restaurant closed at different times, being unable to get the food needed to open. Perhaps they could have gone into the black market in order to profit, but apparently, they chose otherwise.

One might ask if today the Dearth Brothers would have abided by the Illinois Department of Public Health orders, or would it have been one of those restaurants who ignored them in 2020?

The Dearth's were the victim of several crimes over the years. Early, in 1924, Lou had his Hudson Coach automobile stolen from the back of the restaurant at about 9PM. The restaurant was open usually 20 to 24 hours every day. The car was found a few hours later by motorcycle police officer Nester near the Coral Inn in McHenry County. A new dance hall had opened near there called Kuecker and the car appeared to have been used by local youths wanting to attend the dance. During the depression, counterfeit money was often passed in the restaurant. In 1943, burglars broke into the restaurant while it was closed between 2AM and 5AM. \$800 was taken from a safe. This was the second in a string of burglaries. The followed a Belvidere Post Office robbery, which netted the burglars \$1250, a thousand of which were war bonds. A third robbery was at Cornish Pharmacy, 601 South State Street.

By September 1952, the brothers decided to hang it up after 30 years in Downtown Belvidere. Lou and Leo were ready to retire, but Victor and his son Bob decided to change the name to Dearth Prime Rib. Victor worked the kitchen and Bob the front room. In 1956, Bob sold the restaurant to Robert Wait, who had a restaurant on the same block on Buchanan Street a.k.a "The Shortline". Wait was quick to flip it to Ed Fisher 2 years later. Ed was the original operator of the Motel Belvidere.

How Criminal Justice Bill Would Overhaul Officer Certification

New standards will determine who can become law enforcement in Illinois

A criminal justice package that passed both chambers of the General Assembly last month contains provisions that would grant the state increased power over police discipline and standards of conduct starting in 2022.

The omnibus package, which was backed by Illinois Attorney General Kwame Raoul, has not yet arrived at the desk of Gov. JB Pritzker, although he has said he looks forward to reviewing the bill which needs only his signature to become law.

Pritzker campaigned on several issues in the bill and indicated his support, but has not yet said directly that he will sign it.

One of the more controversial provisions in the bill would expand the scope of the Illinois Law Enforcement Training and Standards Board, or ILETSB, which currently oversees training and grant programs for law enforcement and correctional officers throughout the state.

Police certification standards would be made more robust under the legislation, with law enforcement officers placed into three categories: active, inactive and decertified. Only those with an active certification from ILETSB can be legally employed at an Illinois agency in a law enforcement capacity.

A decertified officer has 30 days to file a motion with the board for reconsideration, and all decertifications are subject to judicial review. Once an officer is formally decertified, they are prohibited from ever regaining certification.

Each officer will be responsible for keeping their certification active by submitting verification forms to ILETSB every three years





Welch Seeks to Set a New Tone in Illinois House

New speaker talks changes to House rules, path forward for General Assembly

The election of Rep. Emanuel "Chris" Welch as Speaker of the Illinois House of Representatives marked the beginning of a new era in state politics. Not only is he the first Black speaker in state history, he is also the first speaker in 24 years whose name is not Michael Madigan.

But Welch assumes the gavel at a precarious time in state history, a time marked by a deadly pandemic that has resulted in an economic crisis and a steep drop in state revenues, as well as a time of social unrest over racial inequities, many of which have been exacerbated by the pandemic.

"Well, I definitely agree that I'm taking over at a challenging time," Welch said during a podcast interview with Capitol News Illinois. "Any one of the things that you just mentioned makes for an interesting session by itself. And I'm inheriting a situation where we're going to have to deal with all of that all at once. And so I think that where you start is where have already started. And that's by putting a diverse leadership team in place, a team that reflects the diversity of our state, which is our strength."

Welch unveiled his new leadership team on Jan. 21. It includes a mix of old and new faces. Rep. Greg Harris, of Chicago, remains House Majority Leader and Rep. Jehan Gordon-Booth, of Peoria, remains deputy majority leader. But the team also includes some newer faces such as Chicago-area Reps. Mary Flowers, Jaime Andrade Jr., Robyn Gabel, Elizabeth Hernandez, Marcus Evans and Delia Ramirez, as well as Urbana Rep. Carol Ammons.

It will be some time, though, before the House is able to fully get back to work. Welch has already announced that the House will come back into session on Feb. 10 for the sole purpose of adopting new rules, which are expected to allow for remote committee meetings that will then occur regularly over the next couple of months. But other substantial action at the Statehouse in Springfield is unlikely to occur until at least sometime in April.

At that point, Welch said, he expects the General Assembly to move into high gear.

"As we approach April and May, as we're getting to crunch time, I anticipate being in Springfield a lot more than we have over the past year," he said.

Welch, 49, of Hillside, said he was born and raised in the 7th District that he now represents. He is a graduate of Northwestern University and the John Marshall Law School.

While at Northwestern, Welch also played baseball. A left fielder who was known for his speed, he wouldn't disclose his batting average, saying only that it was below .300, but he described the experience as "one of the best times of my life." But he did not play his senior year, saying he chose to focus on his grades that year "because I knew I wanted to go to law school."

As speaker, Welch faces a challenge distinguishing himself from his predecessor. That's because many members of the House were not even born yet the first time Madigan was elected speaker in 1983.

"I really speak very highly of Speaker Madigan," Welch said. "We wouldn't have 73 Democrats and a super majority in our chamber without Speaker Madigan. But I will say that I still have to be Chris Welch."

Madigan, through much of his tenure as speaker, was known for keeping a tight grip on the House. It was often said that no bill ever reached the floor of the House for a vote unless it had his blessing, including such issues as legislative ethics reform.

Welch, by contrast, has indicated he may try to govern with a softer hand by relaxing some of the House rules.

"We're being sincere in taking a quick, hard examination on these rules," he said. "But you know, we can't do much until rules are approved. And so our intent is to let this go on for the next

to confirm they've completed all mandatory training and have no disciplinary actions taken against them that would result in decertification.

Under current Illinois law, officers can only lose their certification under very narrow circumstances. They must either be convicted of a felony or a limited list of "decertifiable misdemeanors" such as offering a bribe, theft and prostitution.

From 2009 to 2014, Illinois decertified 64 officers. Over the same period of time, Florida decertified 2,125 officers and Georgia decertified 2,800.

Raoul, in his testimony in House committee in support of the provision during January's lame duck session, told lawmakers that while he does believe Illinois has the best trained and most upstanding law enforcement in the country, the massive discrepancy in the numbers has more to do with how hard it is to fire and decertify officers for blatant misconduct, even if the officers were known to be repeat offenders.

The new law would grant ILETSB broader discretionary authority to decertify officers that violate the new standards of conduct.

If the board determines an officer committed a felony or "decertifiable misdemeanor" that would normally result in automatic decertification, but the officer has not been charged or convicted, it can decertify that officer through the discretionary process.

Other misconduct that can result in discretionary decertification includes excessive force; failing to intervene in another officer's use of excessive force or failing to render aid; tampering with dashboard and body cameras or their footage; committing perjury or making false statements in an investigation of a crime; and engaging in any unprofessional, unethical or deceptive conduct harmful to the public whether or not it caused actual injury.

While governmental agencies are required to submit violations to ILETSB within seven days of their occurrence, the provision would also allow for members of the public to submit a complaint about an officer, and they may keep their own identity confidential as well.

Decertification process

Opponents of the bill have claimed the ability to file complaints anonymously will result in officers being targeted by disgruntled citizens and criminals who will flood the system to get them fired.

Raoul contends the provisions of the bill prevent unwarranted termination by filtering complaints through several layers, and that confidentiality is important to preserve the integrity of the process.

"We have to realize there have been incidents throughout the country that make the public at large feel that they can't have the greatest level of trust in law enforcement and we have to restore that public trust," Raoul said in an interview with Capitol News Illinois last week. "Just like other professions where they may be whistleblowers that their identity is protected such that there's no retaliation against them, but that doesn't mean you don't investigate the allegation thoroughly."

When ILETSB receives a complaint about an officer, it will conduct a preliminary review to determine if there's enough information to investigate. If the review finds there's sufficient cause, the board will conduct a full investigation.

If the board's investigation determines the officer may have conducted decertifiable conduct, it will submit a formal complaint to the Illinois Law Enforcement Certification Review Panel, a new entity created by the legislation with 11 members appointed by the governor and attorney general.

The complaint will result in a formal hearing before an administrative law judge who will hear the allegations in the complaint and testimony from the officer, their legal representation and relevant witnesses to the case. The judge will then deliver their conclusion and a recommendation to the panel.

The panel then votes on whether to recommend ILETSB remove the officer's certification or dismiss the complaint, with a simple majority vote needed either way. The recommendation is nonbinding.

Then, and only then, can ILETSB choose to decertify an officer through another majority vote.

Outside of this process, an officer's certification can only be revoked if they're convicted under the current decertification standards or rendered inactive if the officer fails to submit a valid verification form to ILETSB during their required reporting period.

Transparency database

The legislation also requires ILETSB to enhance transparency, both within law enforcement and for the broader public.

The Professional Misconduct Database, a private portal for chiefs and sheriffs, will be expanded and streamlined for all relevant governmental agencies, law enforcement entities and state's attorneys. The portal will contain an officer's certification history, reported instances of misconduct, suspensions and terminations.

Any agency looking to hire an individual in a law enforcement capacity would be mandated by law to view the individual's entry in the database before offering employment.

ILETSB will also create and maintain two new searchable public databases in an accessible portal on their website. One will contain officers' agencies, their certification status and confirmed instances of misconduct that led to decertification. The other will contain all completed investigations against law enforcement and correctional officers with any identifying information of the officers involved redacted.

The attorney general's office will also have greater latitude to investigate systemic abuse in law enforcement agencies under the new provision. According to Raoul, his office can only do so under the current law if the abuse is a clear human rights violation based on race, gender, national origin or other protected classes but not if it is a general systemic issue.

Potential 'clean-up language'

Republicans and law enforcement groups have voiced fierce opposition to the criminal omnibus legislation as a whole, urging Pritzker in a news conference last week to veto the bill once it arrives on his desk.

On police certification, Republican lawmakers take issue with the unfunded mandates involved in the new system and mandatory trainings for officers. The bill goes too far without providing more funding for police departments, they said, especially as the state is already hurting for revenue due to the COVID-19 pandemic and the continued structural budgetary pressures.

The bill's sponsors in the General Assembly, Chicago Democrats Sen. Elgie Sims and Rep. Justin Slaughter, have indicated budgetary issues and clean-up language can be addressed in follow-up legislation in the new session, which is why the bill's effective dates are pushed back by a year or more instead of being effective immediately.

A release posted to the ILETSB website the day after the legislation's passage reads "we have asked for our appropriations to be increased and funding secured to accommodate the increased trainings and duties associated with processing certification verifications, investigating statewide complaints, and seeking the decertification for reported misconduct."

It continues, "we trust that in the upcoming months, discussions on this topic will be fruitful."

Despite opposing the broader bill, law enforcement has been supportive of the certification provisions. Starting in June, the Illinois Association of Chiefs of Police, the Sheriff's Association and state's attorneys collaborated with the office of the attorney general and the governor's office to craft the language. According to Raoul, the group met nearly 20 times.

"We were trying to work with the attorney general on this," Joe Moon, president of Illinois Troopers Lodge 41, said at the Wednesday Republican news conference. "However, before that could happen this was all rammed together and shoved out in the lame duck session for a vote."

While police certification was originally its own legislation, it was added to the criminal justice reform omnibus package on the final day of the lame duck session.

"With regards to people urging the governor to veto, I welcome discussion about specific elements of the bill and where there might be need for a follow-up, clean-up language and so forth. I think that is a healthy part of the legislative process," Raoul said. "My participation has been to negotiate in good faith and to have the input of law enforcement along the way."

US needs to step up its game or face losing the economic 'Cold War'

I had lunch this past week with two civic leaders in their handsome small city in central Illinois. Both had moved to their present town for family reasons, after careers in other states. They are both concerned about the averageness of their local high school.

One is a successful, retired school man, from a Florida district that has sent more graduates to US service academies than maybe any other school in the nation. He recently made a proposal to the local high school that I figured couldn't be

The educator offered to fund the creation of an International Baccalaureate Curriculum (IBC) at the high school. This really rigorous program for talented high schoolers puts them on a path to success in our best universities.

"Nah," said the school board and superintendent about the offer. "We're doin' just fine."

But our average downstate high schools aren't doin' just fine. If you took Chicago kids' scores out of the state averages, most downstate schools would be below average, some significantly so.

We have to step up our game, or we will lose the hot "Cold War" competition we are in with China for technological and economic primacy. Nothing wrong with competition, especially when you win it.

Yet, I fear most Americans are blithely unaware of what is going on. If they were, I would hope they would get about shaping up our nation, which has lost its edge.

As I reported in an earlier column, I still recall my first day in Shanghai, now 15 years ago, for one of three teaching stints at a prominent university in that city of 25-30 million. I was stretching my legs on that Saturday morning, after the grueling flight, outside my "foreign expert" guest quarters.

I noted several clutches of darling youngsters, in uniforms, heading down the neighborhood street toward what looked like a school building. Later, I asked my host professor what I was seeing. "Oh, they were going to school. We have school every Saturday until noon (and one hour more of instruction each weekday than in the US)."

I'll bet that if the parents of those kids were told their kids couldn't go to school on Saturdays, there would be riots in the streets. I fear that, if parents here were told their children had to go to school on Saturdays, there would also be riots in the streets.

We have to look beyond our understandable preoccupation with the pandemic and political turmoil, to the larger, even more important challenge of intensifying a commitment to education at all levels, and to firming up the growing, soft underbelly of low-achieving American society.

Otherwise, we will wake up one day in 15 years, or sooner, and find that we are dependent on China for rare earth metals, high-tech products and the software to run our world.

America and European nations, plus Japan, colonized and humiliated China and much of Asia in the 19th and early 20th centuries. The proud Chinese haven't forgotten. Over thousands of years of history, a century ago to them is but yesterday. The Chinese are not evil in wanting to once again become the "Central Empire" of the world, any more than the West was when it tried to take over the world in the past couple of centuries. It's called competition, and it's brutal right now.

With four times as many people as in the US, they may have more honor students than we have students, and their people are "clever" (their English word for smart), but they aren't necessarily world beaters. The Chinese are

experiencing ever more oppressive state control, which appears to be stifling some innovation. So, their best and brightest may well want to create and innovate in the West.

And their earlier one-child program has resulted in leaving China with a high and growing ratio of elderly-to-producer population.

The US has to become more strategic in how it spends its limited money. (We can't print it forever, as we seem to be doing, without dire consequences for our grandkids).

For example, most Americans can do without the additional \$1,400 in pandemic largesse that will apparently be splashed onto us soon. That kind of money should instead go toward our research laboratories and into more IBC and AP (Advance Placement) programs in our high schools. Our students can handle the challenge of rigorous education.

The kids need to be challenged. Just as all of us need to step up our competitiveness game.

Pretrial Reform Efforts Continue in Illinois

Comprehensive, sustainable reform takes courage, patience, diligence and faith. Building upon the Bail Reform Act of 2017, the General Assembly recently passed additional reforms of the state's pretrial detention system. Importantly, the legislation includes a delayed effective date on many of its key provisions. This additional time will be critical to establish an effective statewide pretrial system to support these changes and ensure that individuals who pose a threat to public safety are detained pretrial.

The Illinois Supreme Court Commission on Pretrial Practices recognizes that for far too long our criminal justice system has criminalized poverty by often detaining low-level, nonviolent offenders simply because they cannot afford bail. A large percentage of accused persons who enter the criminal justice system are indigent, facing

economic obstacles. The General Assembly commended for addressing these difficult issues.

In December 2017, Illinois the Supreme Court took unprecedented step of creating and convening the Supreme Commission Court

on Pretrial Practices, a multidisciplinary body comprised of criminal justice stakeholders from all three branches of government. The commission was charged with providing guidance and recommendations regarding comprehensive pretrial reform in the Illinois criminal justice

The Supreme Court's directive placed Illinois among the leaders in a long and overdue national movement to rethink and improve effective and fair bail decisions and enact transformative pretrial practices.

The commission met for two years, studied national best practices, consulted pretrial reform experts from across the nation, held public forums, and collected feedback from stakeholders throughout Illinois. The commission issued its Final Report in April 2020 which contained a broad range of legislative and policy recommendations to bring about pretrial reform in Illinois.

Last summer, the Supreme Court established a task force to implement these recommendations. The task force, like the commission, is bipartisan and multidisciplinary. It has met biweekly since

Members of the task force were also in discussion with legislators and advocates regarding proposed criminal justice reform legislation. While we may not have agreed on everything, we listened to one another and worked to align the pretrial aspects of this bill as much as possible with the recommendations in the commission's Final Report. I was honored to provide testimony before the Illinois House and Senate during subject matter hearings regarding HB3653.

Going forward, the Supreme Court has directed the task force to assume a leadership role regarding the implementation of this historic and courageous legislation. We will prepare guidance and training on the bill's pretrial provisions and will identify areas in the bill for which amendatory language must be considered.

We look forward to continued dialogue with the legislative authors and we will work tirelessly to ensure comprehensive and sustainable pretrial reform is implemented throughout Illinois.

couple of weeks. And Feb. 10, We will have a vote on the rules. I anticipate that there will be some changes to the rules from the past."

Welch also said he hopes to repair the Democratic majority's relationship with House Republicans, including Minority Leader Jim Durkin, of Western Springs, who led an effort last year to have Madigan removed from office over his role in a yearslong bribery scheme involving utility giant Commonwealth Edison.

Welch, who chaired the special investigating committee that was formed to investigate Madigan's role in that scheme, played a key role in preventing the filing of formal disciplinary charges. But now, as speaker, Welch said he hopes to rebuild a working relationship with Republicans.

"And I actually called him this past Saturday (Jan. 23) to talk to him about the intent about going back to session to improve the rules on February 10, find out who his point person is on the rules,' Welch said. "And he was pleasantly surprised to receive a call from me on a Saturday morning."

"That's my style," he added. "And that's what I intend to do going forward is to keep an open line of communication. We actually live less than five miles from each other. When things open back up, we'll probably meet regularly for coffee."

Former GOP State Senator, Conservative **Party Candidate for Governor Indicted**

Sam McCann faces fraud, money laundering, tax evasion charges

A former Republican state Senator and Conservative Party candidate for governor on Wednesday joined the list of ex-state officials who have been indicted.

Springfield-area lawmaker Sam McCann, who frequently butted heads with Republican ex-Gov. Bruce Rauner and eventually challenged him as a third-party candidate in 2018, was indicted on charges of fraud, money laundering and tax evasion related to his alleged use of campaign funds for personal expenses, according to the U.S. Attorney's Office of the Central District of

The indictment alleges that from May 2015 to June 2020 McCann "engaged in a scheme to convert more than \$200,000 in contributions and donations made to his campaign committees to pay himself and make personal purchases." Further, McCann concealed his fraud from donors, the public, the Illinois State Board of Elections and law enforcement authorities, according to the news release.

McCann, of Plainview, was a state senator from 2011 until January 2019 following his unsuccessful third-party run for governor in which he received about 4.2 percent of the vote, or 192,527 votes.

According to the U.S. Attorney's office, McCann organized several political committees which received over \$5 million in donations.

But in several instances, McCann used some of that money to purchase personal vehicles, pay personal debts, make mortgage payments and pay himself, according to the U.S. Attorney's office.

That included \$60,000 spent on a 2017 Ford Expedition and a 2018 Ford F-250 pickup truck,

and he later used campaign funds to pay for fuel and insurance for the vehicles.

The indictment also details an alleged scheme in which McCann purchased two recreational vehicles, later establishing an account with an RV rental business in Ohio through which McCann rented the vehicles to himself, paid for by campaign funds. That also led to a tax evasion charge.

"McCann caused a total of approximately \$62,666 in campaign funds be used to pay the rental cost of the vehicles. The rental business retained approximately \$9,838 for commission and paid McCann, as the owner, approximately \$52,827 by direct deposit to McCann's personal checking account. McCann reimbursed the campaign accounts \$18,000, resulting in more than \$77,000 in campaign funds used to buy and rent from himself," according to the news release from the U.S. Attorney.

McCann also allegedly cut himself a \$20,000 cashier's check from the campaign account in 2016 to pay off a 2011 loan. From May 2015 to August 2020, McCann allegedly spent approximately \$64,750 in campaign funds on two separate personal mortgage loans.

His failed campaign for governor was lucrative as well, according to the indictment.

"McCann allegedly caused the Conservative Party of Illinois to issue approximately \$187,000 in payments to himself personally and an additional \$52,282 in payments for payroll taxes," through June 2020, according to the news release. "Using a payroll service, McCann was allegedly able to conceal himself as the payee for the expenditures from the campaign account."

The indictment also alleges the Conservative Party standard bearer spent \$50,000 in campaign funds on credit card payments related to a family vacation in Colorado and charges from Apple iTunes, Amazon, a skeet and trap club, Cabela's, Scheels, Best Buy, a gun store and cash withdrawals.

McCann is scheduled to appear via telephone conference at 2 p.m. Feb. 16 before U.S. Magistrate Judge Tom Schanzle-Haskins for arraignment.

If convicted, McCann could face penalties up to 20 years in prison for each of the seven counts of wire fraud and one count of money laundering he faces. For tax evasion, he could serve up to five years.

Legislative Republicans Seek Measures Allowing Voters To Recall Lawmakers, Overturn

Voters would need to amend state constitution for measures to take effect

Republican lawmakers from both chambers of the General Assembly are promoting three legislative proposals to give voters greater authority to amend the state constitution, recall legislative leaders and other lawmakers, and repeal recently-passed state laws.

The "Voter Empowerment Project" includes three amendments to the state constitution, meaning each would need approval from three-fifths of lawmakers before it would head to voters for approval in a statewide election year. The threshold for approval from voters on a constitutional amendment is 60 percent of voters on the specific question or the majority of those voting in the election.

House Minority Leader Jim Durkin, R-Western

Springs, said whether or not the bills get to the floor for full debate in the upcoming legislative session may be dependent on what rules the House adopts under newly seated Speaker Emanuel "Chris" Welch, D-Hillside.

"Right now, it's a wait and see attitude, but I'm cautiously optimistic that we are in a better place because the past was clearly not good for Illinois and the operations of the House were anything but transparent," Durkin said of the discussion of House rules.

The House is scheduled to return to discuss rules on Wednesday, Feb. 10. A frequent Durkin critique of former Speaker Michael Madigan was that he let bills he did not like languish before the House Rules Committee, meaning they would not gain a hearing at the substantial committee level or a vote on the House floor.

"The biggest impediment that we've had to reform or at least opening up state government

has been removed from state government," Durkin said of Madigan. "I'm going to have to say that we still have a process in place where we can still amend the constitution to make changes, but this is an opportunity for the citizens to take greater control over how state governments going to be run"

When it comes to the measures discussed Wednesday, Durkin said, "We just want an up or down vote."

A spokesperson for Speaker Welch did not respond to a request for comment on the proposals by deadline. Previously, Welch has indicated he is open to reforming House rules, and he and Durkin have spoken several times since Welch was inaugurated, according to both leaders.

Senate Minority Leader Dan McConchie, R-Hawthorn Woods, said he has brought up rule changes to Senate President Don Harmon, D-Oak Park, as well "in hopes of being able to negotiate a broader and kind of more inclusive process."

One of the measures the GOP lawmakers want brought to the floor is contained in Senate Joint Resolution Constitutional Amendment 3 and House Joint Resolution Constitutional Amendment 4. That measure would expand the government officials subject to recall vote to include any executive branch officer, the Speaker of the House, the President of the Senate, the auditor general, members of the General Assembly and local government officials.

It would also decrease the number of signatures needed to recall a governor to 12 percent of the votes cast for governor in the previous election, down from 15 percent. That threshold would apply for speaker, auditor general and Senate president as well. For a lawmaker, it would require 12 percent of votes cast for governor within the lawmaker's district.

A recall would need approval from 60 percent of voters to oust an elected official, who would then be forbidden from serving in the office they were recalled from for another 10 years.

The bill also eliminates the requirement that the recall effort receive bipartisan support from at least 20 members of the House and 10 members of the Senate.

Another measure, contained in SJRCA 2 and HJRCA 6, would give Illinois citizens an avenue to overturn laws recently passed by the General Assembly.

That would require a petition signed by 5 percent of the total number of voters who voted for governor in the last election, provided it is filed within 90 days of the law being enacted.

The third measure, contained in SJRCA 1 and HJRCA 5, would expand the scope of citizen initiative authority to amend the state constitution. Currently, the constitution allows for amendments via citizen initiative to "structural and procedural subjects contained in Article 4." The amendment would strike that language.

While McConchie said he'd submitted the

documents to Harmon, a spokesperson for Harmon said in an email that questions from a reporter were "the most information we've received" on the measures, although they would be taken under review.
