## Illinois Attorney General Wins State's First Civil Hate Crime Lawsuit

*The win came among dozens of lawsuits the state has filed against the Trump administration in the past year*

Amid a flurry of lawsuits filed in federal court against the Trump administration, Attorney General Kwame Raoul's office won a historic first in Illinois last month by successfully trying the state's first civil hate crime lawsuit.

Chad Hampton and his mother Cheryl Hampton, who are white, were found to have engaged in intimidation and disorderly conduct towards their neighbor, Gregory Johnson, who is Black, according to Raoul's office.

The Hamptons allegedly lynched an effigy of Johnson, facing his home, after Johnson had called the police on Chad Hampton for allegedly damaging his lawn. Court filings show the Hamptons also displayed a racial slur, swastikas and a Confederate flag aimed at their neighbor's home.

## Illinois Joins WHO Global Outbreak Network After U.S. Withdraws

*Illinois to continue sharing information about disease outbreaks with the public*

Illinois will join the World Health Organization's Global Outbreak Alert and Response Network, or GOARN, to counterbalance the federal government's withdrawal, Gov. JB Pritzker announced Tuesday.

The network monitors disease outbreaks across the globe and prepares countries to respond to those outbreaks. As a member, Illinois will have access to research, timely alerts and information about outbreaks, risk assessments and trainings so state officials can respond to public health emergencies.

The move follows President Donald Trump leaving the international health organization in January 2025.

"By withdrawing from the World Health Organization, Donald Trump has undermined science and weakened our nation's ability to detect and respond to global health threats," Pritzker said in a news release. "I refuse to sit idly by and let that happen."

Many WHO meetings involve national governments around the world, but GOARN is open to a wider variety of groups. It connects hundreds of public institutions, laboratories, academic institutions and different levels of government to detect and respond to public health threats like COVID-19, influenza and other diseases.

"Membership in this network strengthens Illinois' preparedness for future pandemics and emerging threats," the release states.

## Election '26: Four Democrats Seeking To Replace Mendoza As Illinois Comptroller

*Candidates offer various approaches to job with some pledging bold legislative agenda*

Who wants to manage Illinois' checkbook as the state faces growing financial uncertainty? Three state legislators and the treasurer of one of the state's largest counties have raised their hand.

Incumbent Comptroller Susana Mendoza — who first took office in 2016 in the middle of the state's infamous two-year budget stalemate — is not seeking reelection. Her departure created the first open primary for the Democratic party for a statewide constitutional office since 2018.

The comptroller's primary responsibility is ensuring the state's bills are paid — a task that wasn't always easy, but one that Mendoza has fine-tuned in recent years.

With Mendoza stepping aside, state Sen. Karina Villa of West Chicago, Rep. Margaret Croke of Chicago, Rep. Stephanie Kifowit of Oswego, and Lake County Treasurer Holly Kim are running in the Democratic primary. Each sat down with Capitol News Illinois reporters in recent days to answer questions.

Bryan Drew, a Republican from southern Illinois, is running unopposed for his party's nomination.

## 'My Own Government Attempted to Execute Me,' Chicago Woman Shot by Border Patrol Testifies

*Representatives called for immigration enforcement reform, civil liability of federal agents*

The Chicago woman who Border Patrol agents shot five times last October called the incident an attempted "execution" in a public forum Tuesday in Washington, D.C.

Marimar Martinez, a U.S. citizen and Chicago resident, was shot Oct. 4 during a confrontation with Customs and Border Patrol agents in Brighton Park in southwest Chicago.

Court documents state that Martinez's vehicle collided with a federal agent's, although it is undetermined which vehicle initiated the collision. Martinez's lawyers maintained she was not at fault for the accident and never intentionally hit the CBP agent's vehicle. But the Department of Homeland Security quickly spun the incident as an "ambush" on federal agents, and Martinez was charged with assault — a charge that a judge has since dismissed with prejudice, meaning it can't be refiled.

"On Friday, I was teaching the young children at the Montessori School, and we were singing and dancing and getting ready for spooky season, preparing fall activities to do the following week," Martinez said. "On Saturday, my own government was calling me a domestic terrorist, and I was in federal detention centers with the bullet holes all over my body."

"Domestic terrorist" is the same label DHS uses to refer to Renee Good and Alex Pretti, two citizens shot and killed by DHS agents in Minneapolis last month.

"I am Renee Good. I am Alex Pretti. I am Silverio Villegas Gonzalez. I am Keith Porter," Martinez said. "They should all be here today." Gonzalez was shot and killed by federal immigration agents in the Franklin Park suburb of Chicago, and Porter was shot and killed by an off-duty ICE agent on New Year's Eve in a suburb of Los Angeles.

### Public forum

Martinez testified with two other citizens who accused Department of Homeland Security agents of assault.

The panel also included the attorney for the family of Good, who was shot and killed by DHS

Illinois will bring laboratory capacity to the organization, including genomic sequencing and wastewater surveillance developed for COVID-19. Illinois also provides expertise in outbreak investigations and communication about risk.

Already, the Illinois Department of Public Health collects data and information about emerging health risks, and that will continue.

“Disease knows no borders,” said Dr. Sameer Vohra, director of IDPH. “The decision by the U.S. government to withdraw from the World Health Organization threatens decades of progress in global health coordination that makes Illinois residents safer.”

Joining GOARN is another move Pritzker has made to counter federal public health policies.

Pritzker in 2025 signed a bill to allow IDPH to set its own vaccine guidelines. It also requires insurance companies to cover vaccines that are

recommended by IDPH.

He also joined the Governors Public Health Alliance, a group of 15 other governors that coordinates to monitor public health threats, share information and communicate with the global health community.

California also joined GOARN in late January.

The withdrawal is complicated because there is no official way to leave WHO and the United States is the only country with the ability to do so. Experts say it’s up to WHO members when the departure is finalized, and they expect the matter to come up in meetings in February and May.

Leaving WHO doesn’t mean leaving all global health efforts. The U.S. will still participate in organizations like UNICEF and the United Nations Children’s Fund.

Trump tried in 2020 to leave WHO, but President Joe Biden reversed that decision. Trump has accused WHO of not being independent and has demanded reforms without clarifying what those are. He has also criticized the way WHO handled the COVID-19 pandemic.

Tom Hughes, executive director of the Illinois Public Health Association, praised the announcement, emphasizing how strong systems and partnerships are crucial to public health.

“Public health works best when we are informed, connected, and prepared,” he said. “Joining GOARN means Illinois public health leaders can access timely, reliable information, global expertise, and trusted partners when it matters most.”

have a president who pays lip service to the existential risk of nuclear weapons, but hasn’t taken the necessary steps to reduce that risk. His Truth Social post from today at least signals an openness to strong and enduring arms control agreements; whether his administration follows through remains to be seen.

“Anyone who remembers past arms control negotiations understands the gravity of this moment. Putin’s Russia has repeatedly shown that it views nuclear weapons not simply as a deterrent of last resort, but also as a tool of political blackmail. As Congress’ Ph.D. physicist, I’ve been sounding the alarm on this issue for years and remain deeply engaged in working across the aisle to decrease nuclear risk. I am calling on both nations to abide by the numerical limits set under New START until a new agreement is signed.”


Congressman Foster leads 27 colleagues in the House on H.Res.100, condemning Russia’s suspension of its participation in New START and calling on the administration to pursue arms control talks with Russia and China. Last month, Congressman Foster hosted a Special Order Hour on the expiration of the New START Treaty, which can be found here.

Before he became a Member of Congress, Foster worked as a high-energy physicist and particle accelerator designer at Fermi National Accelerator Laboratory (Fermilab). He was a member of the team that discovered the top quark, the heaviest known form of matter. He also led the teams that designed and built several scientific facilities and detectors still in use today, including the Antiproton Recycler Ring, the latest of Fermilab’s giant particle accelerators.

## U.S. Rep. Bill Foster, Congress’ Lone Ph.D. Physicist, Issues Statement On Expiration of New START Treaty

Belvidere’s Congressman Bill Foster (D-IL) issued the following statement:

“The last remaining limits on the world’s two largest nuclear arsenals disappear, and the world is now more vulnerable to nuclear escalation than at any point in the last fifteen years.

## Foster Statement on Funding Package Vote, DHS Reforms

Belvidere’s Congressman Bill Foster (D-IL) issued the following statement on his vote in favor of the funding package that reopens the government, locks in Democratic wins in the budget, and provides a two-week window to negotiate meaningful changes to ICE:

“Today’s vote is a win for Democrats and for the people we represent. This bill rejects the Trump Administration’s proposed \$163 billion in cuts to public services, protects hard-won Democratic priorities, and funds an additional seven of my FY 2026 Community Project Funding selections—delivering \$8.8 million for my district.

“Importantly, this agreement limits Homeland Security funding to a two-week continuing resolution, giving Democrats critical time and leverage to demand serious reforms and accountability at DHS. Right now, the vast majority of ICE’s funding comes from the One Big ‘Beautiful’ Bill, so prolonging a shutdown would not meaningfully reduce their budget or impact their operations. Passing this bill allows Congress to focus on enacting meaningful reforms to ICE without jeopardizing federal workers’ livelihoods or essential government programs.”

## Bill to Regulate Homeowners Insurance Rates Could Reemerge this Session

*Pritzker called for legislation following State Farm's double-digit rate hike last year*

Illinois lawmakers are poised to make a second attempt at passing a bill that would give state regulators more authority to control the rising cost of homeowners insurance.

Gov. JB Pritzker called for the legislation last summer after Bloomington-based State Farm Insurance announced it was raising premiums in Illinois an average 27.2%, citing years of losses in its property casualty line of coverage due to weather-related disasters in the state.

A bill to give the Illinois Department of Insurance authority to approve or reject insurance rate increases passed the Senate during last fall's veto session. But when it returned to the House for a

vote to concur with changes the Senate had made, the amended bill fell four votes short of the 60 needed for passage. That left many to believe the bill had died.

The following day, however, the bill's chief House sponsor, Rep. Robyn Gabel, D-Evanston, refiled a motion to concur, which is allowed under House rules. And Pritzker has said since the end of the veto session that he still wants the legislation to pass.

"They get a second bite at the apple," Kevin Martin, executive director of the Illinois Insurance Association, said in an interview.

Gabel told Capitol News Illinois through a spokesperson this week that no decision had been made about calling the bill for a second vote. But Martin said people in the industry have heard the bill could be called as early as Tuesday, when the House and Senate return to the Statehouse to begin the 2026 legislative session in earnest.

**Current environment**

The controversy over State Farm's rate hike last year raised attention to the fact that Illinois stands out among states for having exceptionally weak regulations over the insurance industry.

Advocates for the legislation argue that every state in the nation except Illinois has a law that prohibits insurance companies from charging "inadequate, excessive or unfairly discriminatory" premiums. And other states' insurance regulators have authority to review and modify proposed rate increases.

Illinois, however, is known in the insurance industry as a "use-and-file" state, meaning companies can raise their rates at any time and immediately put them into effect before filing the new rate schedule with state regulators.

The Illinois Department of Insurance has authority to license companies and agents to do business in the state. It also has authority to make sure insurance products sold in Illinois comply with state laws and that companies honor the terms of their policies. But it has no other authority to re-

view or approve the rates they charge.

Douglas Heller, director of insurance for the Washington-based Consumer Federation of America, described Illinois' law last year as "among the most toothless in the nation."

In the wake of State Farm's rate increase last year, Pritzker suggested the company was trying to shift the cost of disaster-related losses in other states like California and Florida onto the backs of Illinois consumers, and he said legislation was needed to prevent that practice from happening in Illinois.

"As states across the country face even more extreme weather than we do, we need to make sure Illinois homeowners are not paying for losses that companies experience in other states," Pritzker said in an op-ed column published in the Chicago Tribune that was cosigned by House Speaker Emanuel "Chris" Welch and Senate President Don Harmon.

State Farm officials firmly denied that allegation, and Martin insisted no insurance companies in Illinois engage in that practice.

"We have never seen anything like that, and we would argue very strongly that that does not happen and cannot happen based on the actuarial data that the companies have to provide in Illinois on Illinois losses," he said.

**Proposed changes**

Pritzker's call for new legislation to regulate homeowners insurance rates led to intense negotiations between the governor's office, legislative leaders and the insurance industry. But the final language wasn't unveiled until the final hours of the fall veto session.

The language was put into a Senate amendment to House Bill 3799. It included language prohibiting "excessive, inadequate, or unfairly discriminatory" rates. It also called for banning the practice of "cost-shifting" by requiring companies to use state-specific loss data to develop their rates whenever possible.

**Who are the candidates**

Kifowit is the longest tenured legislator of the group, having joined the General Assembly in 2013. She is leaning on her Marine Corps service and past career as a financial advisor to argue she is the most qualified candidate.

"In this race, individuals need an independent, knowledgeable, experienced person for this position, one that has the backbone like I do from being a United States Marine Corps veteran, and one that has life experience along with professional experience," Kifowit told Capitol News Illinois.

She is facing an uphill battle in fundraising, however, as her campaign raised the least money of the candidates in the final quarter of 2025. Croke is leading the financial race thus far as the only candidate to raise at least \$500,000 during that fundraising period.

Croke has been in the legislature since 2021 and was previously a deputy director at the Illinois Department of Commerce and Economic Opportunity. She is a close ally of Gov. JB Pritzker and has received endorsements from several top Democrats, including the influential Cook County Democratic Party, but Pritzker has not been one of them.

"We all have seen bills pass, and we've seen bills blow up, and it's because of your relationships or if you understand how to get these things done," Croke told Capitol News Illinois. "So, I feel really confident about my ability to kind of steer the ship in the right direction."

Croke narrowly won the support of the Cook County party over Villa, who is backed by Senate President Don Harmon and U.S. Rep. Delia Ramirez as she tries to carve a lane as the most progressive anti-Trump candidate in the race. Villa has been in the legislature since 2019 but does not have a financial background — her career was in social work.

"This is the people's money and a social worker who has this background, who has the understanding, who has spent all of this time in the General Assembly combing through the budget and understanding how, at times, in order to balance budgets, we have to actually cut service line items that are so critical for everyday people to make ends meet — the social worker being the comptroller makes the most sense," Villa told Capitol News Illinois.

Kim has no legislative experience in Springfield but spent four years on the Mundelein Village Board and has served as treasurer in Lake County — Illinois' 3rd largest county with more than 700,000 residents — since 2018. She

boasts support from dozens of officials in local government and Democratic county chairs across the state.

"I'm in charge of billions of dollars," Kim told Capitol News Illinois. "All the checks go out with my name on it, which means out of four people running, I'm already doing the comptroller job. I'm definitely going to be a fierce protector of people and their money."

**Budget philosophy**

The comptroller does not directly deal with the legislative process of approving a budget, but the candidates had plenty of ideas on how the state should manage its finances.

Mendoza herself has been an outspoken supporter of boosting the "rainy day" fund and has continued to advocate for ways to increase its size. The fund's \$2.4 billion balance only funds about two weeks of state operations, and lawmakers suspended the monthly transfer to the fund this year to free up money for other priorities in a tight budget year.

"To continue to put money away for a rainy day when we're in the middle of a tsunami, that's not when we should be putting money away for a rainy day," Villa said, adding "there's no way to prioritize that in this budget."

Raising revenue is the central focus of Villa's campaign. She suggested the state implement a tax on digital advertising and retry implementing a graduated income tax raise more money for social services she said are inadequately funded. Such a measure needs approval from both lawmakers and the general public, but voters rejected soundly rejected the proposed constitutional amendment that would have allowed it in 2020.

Kim took a similar approach and said the state's budget goals during Donald Trump's presidency should be focused on "maintaining" the state's credit rating, which was upgraded 10 times between the three major rating agencies under Mendoza.

"I would advocate for not only the progressive tax to be brought up as a longer-term solution, especially with years of rocky finances headed our way with Trump still in government for the next, you know, three years," Kim said.

Croke and Kifowit said they support reinstating regular funding for the rainy day fund.

"The comptroller's role is very vital in managing the finances and prioritizing and making sure that we're paying down our debt," Kifowit said.

Kifowit said the rainy day fund should be increased to at least \$5 billion. As the lead negotiator on pension reform for House Democrats, she also said that when bonds the state is currently repaying expire, she wants to dedicate those revenues to paying down pension debt. Pritzker has proposed a similar plan, but so far it hasn't gained traction in the legislature.

Croke said she wants those revenues to go to the rainy day fund, and

she suggested the state consider refinancing its pension debt.

"It all goes back to the credit rating: If we can increase our credit rating showing that we have financial stability, that we have those reserves and it helps us in the long term with our long-term borrowing, it's something that we need to do," Croke said.

**Role of the office**

Each candidate presented a different vision for how they will lead the office, with some saying they will use it to push policies in the General Assembly and others saying they will focus more on the comptroller's administrative responsibilities.

Villa said many answers to problems in Illinois depend on the legislature, and the comptroller's job should be "to bring attention to the fact that even though we are passing balanced budgets, we are missing a significant amount of money in order to fully fund the services that people need."

Kifowit said the comptroller must balance legislative goals with administrative responsibilities. Her goals include creating a nonprofit division to make it easier for nonprofits to track funds they will receive from the state.

Croke said her main focus will be on administrative responsibilities.

"I hope that everyone running just wants to make sure that this office continues to work because when it breaks down, state government breaks down," she said.

Kim said she wants to use the office to better connect with constituents about the office's responsibilities.

"The problem is government doesn't have really good, short explanation videos that are 'snacks,' and that's where we all are right now," she said. "And I think having more 'snack' videos of information of what's in the comptroller's office will help people to ... trust government and understand through transparency in those explanation videos."

**Putting their mark on the office**

Each Democrat complimented Mendoza's work but listed off changes they would make.

Mendoza's successor will have to be "nimble" to respond to constant federal uncertainty and be a "watchdog" over state finances to make sure the state isn't overspending, Kifowit said. She added that among her initiatives will be opposing any pension system investments in artificial intelligence or cryptocurrency.

Upgrading the office's technology is also a top priority for Croke and Kim.

"I've seen the software where you can follow appropriations within the budget and understand where taxpayer money is going," Croke said. "And I think at this critical time when you have household budgets that are, you know, really tight, and then our state budget is getting very tight, people want to know how you're using taxpayer money."

Kim said she will also focus on increasing privacy protections for personal data.

Villa didn't offer specifics about her initiatives beyond calling for new taxes, which is ultimately left up to the governor and legislature. She said the job can't just be about paying bills on time.

Villa, Kim and Croke said they support keeping the office separate from the treasurer — the state's chief investment officer — citing corruption problems in the office when the responsibilities were merged under one roof prior to the 1970 constitution. Kifowit, however, said she would be open to combining the offices if there were enough checks and balances to provide safeguards.

"This behavior is shocking, racist and un-American. I appreciate the judge's order that shows such despicable behavior will not be tolerated in our state," Raoul said in the release.

The attorney general's office was first given authority to try such a case in 2018. The legislature amended the Illinois Hate Crime Act to allow the attorney general to file civil lawsuits against residents for alleged hate crimes.

Carroll County Circuit Court Judge Jerry Kane ordered the Hamptons to each pay a civil penalty of \$5,000 and damages of \$45,000 to Johnson.

The lawsuit, filed in 2022, details a record of behavior Raoul says was aimed at intimidating Johnson, dating back to 2020. At the time of the

incidents, the Hamptons and Johnson resided in Carroll County in northwest Illinois.

"Johnson had repeatedly contacted the local police department in Savanna, Illinois, about the Hamptons' aggressive conduct toward him," the lawsuit says, stating that Johnson accused Chad Hampton of damaging his lawn with weed killer.

After Hampton was charged with a misdemeanor for the damage, the lynched effigy appeared in the Hamptons' front yard, which Raoul labeled as an intimidation tactic and threat of racial violence in the complaint.

Hate crimes in Illinois have been on the rise since 2016, but spiked in the last four years, according to FBI data collected from college, city, county, state and federal agencies.

Over 50% of reported hate crimes were due to race or ethnicity.

Reports of hate crimes have increased across the nation as well, according to the FBI data.

"With dramatic increases in reported hate crimes, I will continue to use all of the tools at my disposal to prosecute hate crimes and send the message that hate has no place in Illinois," Raoul said in a statement.

agents in January, and an expert on law enforcement use of force tactics, who both raised concerns on the force federal immigration agents have used across the nation.

Good's two brothers also spoke.

This is the second public forum organized by U.S. Sen. Richard Blumenthal, a Connecticut Democrat, and U.S. Rep. Robert Garcia, a Californian Democrat. The forums are part of an inquiry the pair opened in October investigating the detention of U.S. citizens by immigration agents.

"This is not normal, and this is neither professionally nor democratically acceptable," said Seth Stoughton, a former police officer and current public safety professor at the University of South Carolina School of Law.

"We see a lack of interagency collaboration or even basic communication, reducing both efficiency and public trust," he added. "We see poor tactics that put community members and federal agents themselves in unnecessary danger, and we see profound failures of leadership after critical incidents that never should have happened."

Blumenthal and Garcia opened the forum by asking Congress to support allowing citizens to sue federal agents for actions taken against them.

"When you serve this country in an elected office or in uniform, you swear an oath to the Constitution, you pledge to work for all Americans," Garcia said. "You don't get a license to kill, and there's no absolute immunity. We're going to stand up for the rights of our communities, and we believe strongly that we need to hear the stories of those that are in front of us."

U.S. Rep. Raja Krishnamoorthi, who represents part of the Chicago region and is running for the U.S. Senate, also called for reforming Immigration and Customs Enforcement at the forum.

### Martinez's testimony

Martinez is asking a federal judge to allow the release of evidence in her case in light of the federal government continuing to label her as a "domestic terrorist."

"As a 30-year-old USA citizen with no criminal history, I believed that I had nothing to worry about, but I was concerned for my friends and neighbors," Martinez testified, recalling the Saturday that she saw CBP agents in downtown Chicago. "For the next 15 to 20 minutes, I followed these border patrol agents through my neighborhood, honking my horn, shouting out, 'La Migra,'" which in Spanish means immigration officers.

Martinez followed the agents for several blocks before the vehicles collided, resulting in minor dents and scrapes on both vehicles.

According to testimony and documents from Martinez's now-dropped assault case, she stopped her vehicle directly after the collision and the agents' SUV came to a halt just ahead of Martinez. She then accelerated away, testifying in court that she swerved left to avoid hitting the agents, who were exiting their vehicle.

That's when the agents opened fire, ultimately striking Martinez five times in the arm, chest and both legs. Only one of the three agents had a body camera activated at the time.

While the body camera footage hasn't been released publicly, lawyers for Martinez have said in court that it shows an officer shouting "do something b—."



The agent who shot her allegedly said in a group text to friends: "I fired 5 rounds and she had 7 holes. Put that in your book, boys."

"The physical scars will always be there in the mornings and evenings, when I get dressed and I stare at my body, now permanently disfigured by the five lead bullets," Martinez said. "They will be there this summer when I head to the beach with my dogs and family. They will be there when I get down on the floor with my students."

"Perhaps even worse, the mental scars will always be there as a reminder of the time my own government attempted to execute me, and when they failed, they chose to vilify me."

**Release of evidence**

In late January, Martinez's attorneys requested that U.S. District Judge Georgia Alexakis lift an order barring Martinez from sharing records like photos, videos and communications from the incident.

Several media outlets, including the *Chicago Tribune* and *Chicago Sun-Times*, also requested the release of the records but that motion was denied.

Federal prosecutors announced Tuesday they would not oppose the release of the body camera footage that depicts the crash, or interviews with the agents, but would oppose the release of text messages not already seen by the public, according to the *Tribune*.

Alexakis is expected to rule on that motion Wednesday.

The order is standard in most trials to protect against public disclosure in a criminal case. But even though the charges have been dropped, Martinez's lawyers say the information needs to become public because DHS continues to label Martinez as a "domestic terrorist."

"I am asking you today, pleading with you to please help bring back the America I grew up loving," Martinez said at Tuesday's forum. "If there's no justice for the people, let there be no peace for the government."

The bill also would leave in place the state's "use-and-file" method of setting rates, meaning companies would not have to seek advance clearance from state regulators before implementing rate changes. But it would require them to give consumers at least 60 days' advance notice before raising rates by 10% or more.

The major sticking point for the insurance industry, however, was the provision giving the Department of Insurance authority to review and approve or modify rates after they are put into place.

Under the proposed language, if the agency found a company's rates to be excessive, inadequate or unfairly discriminatory, it would send the company a notice specifying the agency's objections. Companies then would be allowed to defend their rates at an administrative hearing. But after that hearing, if the agency still believed the rates violated standards of the law, it would be authorized to order the company to rebate excess charges back to customers.

According to Martin, the industry's main objection to that language was that there was no limit on how far back in time the agency could look in its rate review process.

"They can go back forever," he said.

"We just believe that, in all of the negotiations that we had, for them to come in at the last minute with this type of language, of the changes that they made, was just something that we thought was really unfair," Martin said.

The House and Senate have each been in session a few days this year, mainly to introduce new bills and to pass a few resolutions. But the work of the session will begin in earnest this coming week, starting Tuesday when both chambers will meet and begin holding committee hearings.

Pritzker is scheduled to deliver his annual budget and State of the State address to a joint session of the General Assembly on Wednesday.
