## Robotics Teams Learn Valuable Creative and Mechanical Skills

Imagine a group of talented 16-year-olds designing and building a robot from scratch in only 6 weeks! Each year, four different robotics teams in the Rockford area alone design and build robots to compete in the annual FIRST Robotics Competition.

FIRST stands for For Inspiration and Recognition of Science and Technology. It is a nonprofit corporation headquartered in New Hampshire. It sponsors four programs for youth, aged 6-18. The FIRST Robotics Competition is the program for high school students.

The competition pairs high school students with mentors (usually engineers and teachers) to design and build robots that compete against other teams. While mentors advise, the work and the engineering is done by the high school students. The robot must weigh no more than 125 pounds, with the height limited to 4 feet, and the overall size limited to 110 square inches.

The FIRST organization stresses a spirit of "Gracious Professionalism" and "Coopertition." While the program is a contest, the emphasis is on maintaining cordiality and helpfulness with others. According to FIRST, when teams behave in this fashion, everyone wins and society benefits.

The competition is structured as a game. Typically, three teams compete together against three opposing teams. Each group of three teams is called an Alliance.

This year's game was called "Charged Up." Two competing alliances use their robots to process game pieces (foam cubes and traffic cones),

## Pritzker Focuses on Business Development, Clean Energy Jobs

Efforts include weeklong trade mission to U.K.

Gov. JB Pritzker has spent much of his time in recent weeks promoting the state's electric vehicle industry and touting the impact of his signature Climate and Equitable Jobs Act, or CEJA, including during a weeklong trade mission to the United Kingdom.

On Friday, Pritzker was in Joliet where he joined other elected officials and local dignitaries to celebrate the grand opening of a new Lion Electric assembly plant, the first new automotive factory in the greater Chicago area since 1965.

Lion Electric announced plans to build its new facility in May 2021, just as state lawmakers were negotiating the final details of CEJA. The

Canadian-based company specializes in medium and heavy-duty all-electric vehicles, including electric school buses.

The 900,000 square foot facility in Will County is expected to employ about 1,400 people and have a production capacity of 20,000 buses and trucks per year.

The Lion Electric factory opening came on the same day that the state's Department of Commerce and Economic Opportunity announced \$38 million in funding availability to develop 13 regional "CEJA Workforce hubs,"

a training program that's intended to prepare people for entry-level jobs in the clean energy industry.

Speaking at the Lion plant Friday, Pritzker outlined some of the state's EV manufacturing and workforce development programs included in CEJA, the 2021 law that will require 100 percent carbon-free energy production in the state by 2045.

"This is about more than just cars on the road. It's also about making sure that we have

which will bring energy to their community. The goal is for their robot to retrieve the game pieces from a substation and incorporate these pieces into the power grid.

Each round of competition lasts 2-1/2 minutes. For the first 15 seconds, the robots must act autonomously, following pre-programmed instructions. For the remaining 2 minutes and 15 seconds, "drivers," who operate the robot remotely, take control. Points are awarded for completing assigned tasks proficiently. The alliance with the most points wins.

Typically, after a six-week period to build the robot, teams compete at regional competitions in the early spring. Winners of those competitions advance to the world contest in Houston, Texas.

Recently, we had a chance to visit with several of the teams in the area at an open house hosted by Winnebago's team, Winnovation, in preparation for the Rockford competition.

Winnovation's robot, "Panda," used a scoop at the base of the robot to acquire the game pieces. Their captain, Sarah Carslon, told me how they competed not only at the Midwest Regional in Chicago, but also at the Iowa Regional, where they won a slot to compete at the World Competition in Houston. In Houston, they got to meet and compete against teams from all over the world.

Belvidere's Flaming Monkeys, a local 4-H team in Boone County, built "Jarvis," a robot with a very large foldable arm and hand with metal grasping fingers. Belvidere High School Junior Andrew Cruz explained how the Monkeys settled on this design. Initially, they were playing catch with the foam cubes as part of a teambuilding exercise. This led to an understanding that they were using their arms and hands to catch the cube.

Cruz remembered a friend who had a prosthetic arm and thought that Jarvis the robot could be outfitted with such an appendage. The arm they designed folds up to be within the contestrequired size limitations for the robot. While mechanical, one can discern Jarvis' shoulder, upper arm, elbow, forearm, wrist, hand, and fingers. Hydraulics are used on the upper arm and movement is controlled at the joints.

Cruz, a junior at Belvidere North, would like to pursue a career in mechanical engineering and perhaps medical engineering, given his interest in the manufacture and design of prosthetics. Liam Ellingson, a junior at North Boone High School, is interested in computer hardware and is considering attending the University of Illinois. Cole Jones, a junior at Belvidere High School, is considering a military career and would like

For the past 11 years, the Rock River Robot-

ics Off-Season Competition has been held in Rockford, with over 32 teams competing this year. Several scholarships are awarded among the competing participants. This year's competition was held on Saturday, July 22 at Rock Valley College. This competition employs the same robots and rules that were used at the FIRST regional and world contests held earlier in the year.

At the contest, the Flaming Monkeys made it to the semi-finals. Andrew Cruz was awarded an RVC Foundation Scholarship and will attend the running start program at Rock Valley College in the fall of 2023. Gabriella Stormont of Stateline Robotics in Roscoe was also awarded an RVC Foundation Scholarship and will attend Rock Valley College in the fall of 2023. Also from Stateline Robotics, Abigail Barnhardt was awarded an R2OC Scholarship. Andrew Dierks of Winnovation was awarded the Norma Jean Trojan Memorial Scholarship.

## **Foster Introduces Legislation to Bolster Political Spending** Transparency

(Press Release)

Tuesday, Congressman Bill Foster (D-IL) reintroduced the Shareholder Political Transparency Act to shed light on corporate political spending by public companies and increase transparency to investors and the public. The bill would mandate public companies periodically share political spending information with their shareholders.

The legislation would amend the Securities Exchange Act of 1934 to require public companies to make quarterly disclosures to their shareholders to provide them with descriptions of the kinds and amounts of political spending that they engage in.

"Political contributions from publicly held companies should not be a secret, especially to people who invest their hard-earned money in them," said Congressman Foster. "This legislation is a commonsense measure that would provide investors with all the facts necessary to make informed decisions about where to put their money."

The Shareholder Political Transparency Act is cosponsored by Reps. Dean Phillips (D-MN), to attend a military academy. His interests are Jan Schakowsky (D-IL), Jamie Raskin (D-MD), mechanical engineering and computer software. Grace Meng (D-NY), Jason Crow (D-CO), and Eleanor Holmes Norton (D-DC).

the buses, the community experience of the new clean energy economy," Pritzker said, directing his comments toward younger people in the audience. "Because while all of that is very important, it's predicated on having a planet that's environmentally sustainable for your generation and beyond."

The event came on the heels of a weeklong trade mission that Pritzker led to the United Kingdom, where he and 41 other state government and business officials spent much of their time promoting Illinois' electric vehicle industry and its clean energy initiatives.

Among the events they attended in the U.K. was the Goodwood Festival of Speed, an annual motorsports festival in southeast England, where Pritzker said the delegation met with officials from many auto manufacturing companies, including some in the EV industry.

"Goodwood attracts the senior executive teams from, really, all of the major automotive companies across the world," Pritzker said during a virtual news conference just before leaving the U.K. "So it's a great place to go to meet everybody all at once, everybody from Mercedes to Toyota to Ford, and all the other companies that you can think of, and also some of the startup companies as well, many of the EV suppliers."

In addition to promoting the state's clean energy industry, Pritzker said the U.K. trip was also an opportunity to tout Illinois' assets in the emerging field of quantum computing, as well as more traditional industries such as financial services, hospitality, manufacturing and food processing.

But he said the state's clean energy initiatives, and CEJA in particular, have become big selling points when marketing Illinois to an international audience.

"Don't underestimate that here in the U.K. and across Europe, the idea that we are focused on (being) fossil fuel-free by 2050 ... is quite important to them," he said. "When they think about states – Mississippi or, you know, I could name lots of states that don't have climate policy

- they know that their customers expect them to be producing products using clean energy, and that can't be done, or at least not enough of it, in those other states."

The delegation that travelled to the U.K. included Pritzker and his wife MK, several members of his staff, several officials from the Department of Commerce and Economic Opportunity, higher education officials and executives from several Illinois-based companies.

A spokesperson for the governor's office said the Pritzkers paid for their own travel and the state paid the expenses of state employees. But a final cost of the trip was not yet available because not all participants had yet submitted their expense reports.

remembrance is also particularly relevant to our area as included in their numbers was a young man from Belvidere—1st Lt. Jack B. Lanning, the only son of Mr. and Mrs. A. J. Lanning who took off the morning of the mission on what would be his last flight.

Operation Tidal Wave was one of the most audacious and complex air raids in the history of modern warfare. The operation aimed to cripple Hitler's war machine by targeting the vital oil facilities at Ploiesti, which were supplying fuel to the Axis forces. During the operation 1st Lt. Lanning served as a bombardier with the 512th Bomb Squadron within the 376th Bomb Group. The plane he and fellow crew members were on was known as Wongo Wongo—one of the 178 B-24 Liberator bombers flying in the mission. They along with the 44th, 93rd, 98th, and 398th Bomb Groups took off from Benghazi, Libya, with Ploiesti as their destination.

The air raid, while strategically significant, was not without sacrifice. The operation came at a heavy cost, with 53 aircraft and over 660 brave airmen lost during the mission including 1st Lt Jack B. Lanning. His loss occurred over the Ionian Sea. As the plane was approaching Corfu and Greece, Wongo Wongo developed a wing wobble with its nose pitching up and down at ever-higher degrees. At approximately 2,000 feet, the pilot, 1st Lt. Brian Flavelle, made a steeply banked turn; then Wongo Wongo stalled and fell away sharply to the left.

Lt. Flavelle attempted to pull up but went into a tight spiral, spin-diving violently into the water. The aircraft detonated upon impact. In disbelief, witnesses watched the 30-second incident as smoke rose from the sea's fiery circle. Against USAAF regulations, Flavelle's wingman, Lieutenant Guy Iovine, broke formation and descended to search for survivors but found no trace of the B-24 or


its crew. His overloaded aircraft could not climb back to reach the section and had to return to Libya.

Of the 165 bombers that reached Ploesti, only 88 aircraft returned, of which were damaged significantly. Over 500 crewmen were lost from all causes, including 80 seriously wounded. One hundred eight airmen were taken prisoner in Bulgaria, Romania, Turkey, and Yugoslavia.

The next year, in May 1944, Allied aviators based in Italy bombed Ploesti from high altitudes. And the Soviets overran Romania's refineries in August 1944, capturing Axis General Gerstenberg and closing Hitler's "gas station."

Lt. Lanning is memorialized at the Tablets of the Missing North Africa American Cemetery and Memorial, Carthage,

Tunis, Tunisia. He was awarded the Distinguished Flying Cross, the World War II Victory Medal, the Air Medal, the American Campaign Medal, and the Purple Heart.

## Illinois Expands Use of Police Surveillance **Drones**

New law allows event surveillance, building inspections, search and rescue By Andrew Adams Capitol News Illinois

Next time you attend a parade, there might be an eye in the sky.

A new law signed by Gov. JB Pritzker on Friday expands local police departments' authority to use drones to surveil certain events, respond to certain 911 calls, inspect buildings and participate in public relations events.

House Bill 3902 passed 56-1 in the Senate and 84-7 in the House with three members voting "present," The law drew some concerns from civil liberties groups which ultimately led to added privacy protections and disclosure requirements.

The push to expand when police drone authority originated after a 2019 mass shooting at the Henry Pratt Company in Aurora, according to the bill's House sponsor, Rep. Barbara Hernandez, D-Aurora. She and others received renewed calls after a 2022 shooting at a July 4th parade in Highland Park last year.

"I hope people are safe and that this can prevent anything else from happening," Hernandez said.

Kenny Winslow, executive director of the Illinois Association of Chiefs of Police, supported the measure and is already planning to offer training on the new law to police departments.

He said drone technology could save lives and expects more departments to use them moving forward.

But he added that the protections contained in the bill – including requirements that police post notices if they are surveilling an event and keep a record of flight paths – were an important part of the final product.

organization that has long been a voice of opposition to unrestricted drone use by police departments - took a neutral stance on the bill. ACLU staff were key architects of a 2013 state law referred to as the Freedom from Drone Surveillance Act that placed significant restrictions on police drone use.



attorney Liza Roberson-Young told Capitol News Illinois.

These concerns led to some key protections in the bill, including limitations on what circumstances warrant the use of drones and how long the information collected by drones can be stored.

"We wouldn't want this to be a first step to a slippery slope to chipping away at the Freedom from Drone Surveillance Act," Roberson-Young

Under the new law, drones may only be used at outdoor, government-hosted events. These include events such as parades, walks, races, concerts or food festivals. These events must meet minimum size requirements depending on the size of the municipality in which they are hosted in order for police to use drones.

The law explicitly bars drones from being used to monitor "any political protest, march, demonstration, or other assembly protected by the First Amendment."

The law also allows police to use drones when responding to 911 calls to find victims, to assist with health or safety needs or to coordinate emergency personnel.

The information collected using drones, which could include video, images, sounds or other data, may only be stored temporarily and must be deleted within 24 hours after a parade or other special event and within 30 days for most other uses. There are some exceptions where police may retain that information, such as if there is reasonable suspicion that the information contains evidence of criminal activity, if the information is relevant to an ongoing investigation or if it will be used for future training.

The Illinois Attorney General's office can investigate police departments' patterns and practices of drone use and compel their compliance by seeking a court order. Departments can lose drone authority for at least six months the first time they are found to violate the law and up to one year for subsequent violations.

In an interview, Hernandez encouraged people to reach out to the attorney general if they find police violating the new regulations.

"I hope people get to see that there are clear instructions in the law to prevent people from violating privacy," Hernandez said.

The law also explicitly bans police from equipping drones with weapons, such as firearms, chemical irritants or lasers.

The law also places significant restrictions on the use of facial recognition technology in conjunction with drones, barring police from using it during a flight and only allowing it to counter a high risk of a terrorist incident based on U.S. Department of Homeland Security intelligence or to prevent "imminent harm to life or to forestall the imminent escape of a suspect of the destruction of evidence."

But some in the digital rights world say that the law still leaves the door open for police to use other surveillance technologies that encroach on people's civil liberties.

Beryl Lipton is a law enforcement technology and surveillance researcher at the Electronic Frontier Foundation, a digital rights advocacy group. EFF was not engaged in the process of drafting HB 3902.

"It's good that they have protections on facial recognition technology, but there are other biometric technologies that could be used," Lipton said, pointing to gait analysis as one example.

Although Lipton said that her organization has concerns any time police use drones, she added that there are good reasons for drones to be used in some circumstances.

Ultimately, however, Lipton said that local governments should be involved in determining appropriate use of police technologies for their communities.

"There should be a municipal, local conversation about surveillance," Lipton said.

The law went into effect immediately after Pritzker's signature Friday.
