This year at the Boone County Fair the Boone County Sheriff will be using approximately 75 video cameras throughout the fairgrounds and the roads around the area to monitor the crowd and traffic. The video feeds will be displayed in a remote location on a bank of computer screens. If needed, communication to security at the fair will direct officers to assist where required. This is the first year using video surveillance, and the sheriff's office will be looking closely on how to improve use of this technology, according to Boone County Sheriff Scott Yunk.

Boone County is considering purchasing a new drone to assist with search and rescue, fire observational control, and water rescue. The county's drone, which is now 10 years old, only has an operational battery life of 15 minutes and very limited video capabilities.

This drone being considered will triple the battery life and provide streaming video to a command center. It will also be able to do thermal imaging. It will have a laser range finder and the ability to create a GPS location. The new drone will be better able to operate in inclement weather.

County Board member Brent Muller asked how deep it could thermal image in water. The Team Leader for Emergency Management in Boone County, responded that it would depend on variables like how long a body had been in the water or how deep it is in order to be picked up. Board member Alisa Patterson, asked if the thermal imaging could differentiate a person from the fire in a burning building. Again, the Team Leader responded, stating that it could very well.

The cost of a new drone is \$18,000,including extra batteries and a recharging generator. Up to fifty percent of thestate

The purchase was approved by the Administrative Committee and will move to the County Board for a final decision.




The best pig. The best pie. The best plate of peppers. With 4,723 different competitions, The Fair is a celebration of excellence in Boone County.



Roots Of Hybrid Corn Trace Back To Tazewell County

Those who drive by the northeast side of Delavan, Illinois on Springfield Road might notice a carved stone that serves as a historical marker.

But while the field where the marker sits looks quite common for the area, the events that took place there in the 1800s were quite remarkable and had a significant impact on production agriculture that are still felt today.

The Tazewell County farm is where Robert and James Reid just happened to mix two different types of corn that transformed the industry. The site is designated as the "birthplace of openpollinated corn production," according to Matt Shipton, a descendent of the Reids and a seed industry representative.

The historical marker, erected in 1955, was established by the Tazewell County Farm Bureau and other local groups, the Illinois Department of Agriculture and the Illinois Seed Dealers Association along with the University of Illinois and Michigan State University.

"It's just fascinating to think of Delavan's place in the middle of the Corn Belt," Shipton told FarmWeek.

Shipton recently discussed the history recorded at the site and his ancestors' role modernizing corn production during Kansas State University's Grain Export and Supply Chain Expedition. The tour was organized and led by Guy Allen, senior ag economist at K-State and a Delavan native.

Robert Reid (1813-1888) moved to Illinois from Ohio in the mid-1800s and brought some of his own corn. But it wasn't very good for processing and he had production issues, so he planted some local seeds known as "little yellow" Indian corn in the same field.

"He had missing hills (of corn), so he grabbed some local seed and filled in those missing hills," Shipton said. "And by happenstance those two pollinated at the same time and created the openpollinated corn."

Then, for the next 60 to 70 years, Robert and James Reid (1844-1910) selected the best ears from this new line of corn, which kept improving its agronomic ability each subsequent season.

"They selected the best plants and best ears as they continued that lineage of the open-pollinated line," Shipton said.

The end result came to be known as Reid's Yellow Dent Corn. The open-pollinated variety not only dented, but it greatly outproduced most varieties of the late-1800s.

"Common corn yields for that time were around 25 to 35 bushels per acre," Shipton said. "But by 1877 it was documented James reached 125 bushels per acre."

Scott Jeckel, a Delavan native currently farming the former Reid property, noted the field produced a yield near 250 bushels last year. But it took nearly 150 years to double the production from what Reid's Yellow Dent Corn achieved nearly a decade after the Civil War.

"We've constantly improved (crop potential)," Jeckel said. "But we're talking a five-times jump (with what the Reids accomplished in the late-1800s). It was enormous."

The Reids entered their corn in grain contests and it eventually became a sensation at the 1893 World's Fair in Chicago. Reid's Yellow Dent Corn took top honors at that event, officially known as The World's Columbian Exposition to celebrate the 400th anniversary of Christopher Columbus's arrival in the New World in 1492.

James Reid subsequently began receiving numerous requests for his corn from around the world. It's said he fulfilled many of those requests by mailing Reid's Yellow Dent Corn seed from the local post office in Delavan.

"By 1920, it was grown in every state and by 1930, an estimated 75% of corn grown in the U.S. could be traced back to Reid's Yellow Dent Corn," Shipton said. "Many reported it increased productivity in local areas where it was planted.

"But (James Reid) never became wealthy off the process," he noted. "It sounds like he was more willing to give the seed away to help others have additional yield on their farms."

Hybrid corn varieties were then introduced in the 1920s and overtook their open-pollinated predecessors, constituting nearly 100% of cultivation in the Corn Belt by the end of the 1930s.


But the source of a number of inbred lines used as parents of many present-day corn hybrids still have roots to the accidental discovery of a lifetime, when the Reids inadvertently created their open-pollinated, yellow dent corn.

State Watchdog Investigating Employees Accused of Bilking Federal Pandemic Aid Program

Nationwide, about 17% of \$1.2 trillion in small business pandemic relief grants were fraudulent

Dozens of state employees across multiple agencies are under investigation by a state watchdog for claims they fraudulently obtained payments from a federal pandemic-era loan program, *Capitol News Illinois* has learned.

Neil Olson, general counsel at the Illinois Office of the Executive Inspector General, confirmed that "OEIG has been investigating allegations of Paycheck Protection Program fraud by state employees under our jurisdiction." The review, he said, is "systematic," involving multiple state agencies and the other governing bodies under OEIG's jurisdiction, which include state universities, boards and commissions, and regional transit boards.

Congress intended for the loans issued by the U.S. Small Business Administration, most of which were later forgiven, to keep small businesses afloat and their employees on the payroll as COVID-19 resulted in lockdowns and interrupted commerce.

Fraud in the PPP program has been widespread across the United States. In a June report, the inspector general for the SBA estimated that the agency paid out more than \$200 billion in "potentially fraudulent" aid during the pandemic – about 17 percent of the \$1.2 trillion that was dispersed through the PPP and other similar programs.

In the rush to swiftly disburse funds, the federal agency "weakened or removed the controls necessary to prevent fraudsters from easily gaining access to these programs," the report stated. "The allure of 'easy money' in this pay and chase environment attracted an overwhelming number of fraudsters to the programs."

The OEIG typically does not comment on ongoing investigations, and Olson declined to say how many employees could face disciplinary action – up to and including termination – as a result of the widespread probe or provide any additional details.

The scandal has ensnared numerous employees who work at the Illinois Department of Human Services, including at state-run facilities for people with disabilities that are facing staffing shortages. In late June, a spokesperson for the agency confirmed that at least 30 IDHS employees were in various stages of the disciplinary process for inappropriately taking PPP loans. At the time, eight IDHS employees had been fired, six had resigned and 16 were pending disciplinary action.

employee takes advantage of public programs."

The agency said it will continue to work to detect and punish fraud committed by its workers, in cooperation with the OEIG, law enforcement and federal authorities.

The fraud was not limited to IDHS. Collectively, state employees may have obtained millions of dollars in fraudulent payments. A spokesperson for Gov. JB Pritzker declined to provide specifics about how many employees have faced disciplinary action for PPP fraud, saying that the governor's office does not comment on ongoing investigations. While some employees have already received notices of their termination, they have a right to appeal that decision.

Not every state employee who claimed a PPP loan committed fraud. Some may have had legitimate outside employment that made them eligible for the federal loan program. Those individuals would not be disciplined.

State policies require employees to disclose secondary income, and certain state employees, such as agency managers and people who are responsible for procurement and other financial dealings, must also file statements of economic interest with the secretary of state's office that would detail outside income. The investigations may center around whether they filed fraudulent paperwork to obtain the loan, thereby acting in a way unbecoming of a state employee, or failed to follow ethical guidelines disclosing such income – or both.

The OEIG is not a criminal law enforcement authority. In general, it investigates state employees for breaches of ethics and other misconduct and makes recommendations that could range from retraining to termination, depending on the seriousness of the offense. If conduct is criminal in nature, OEIG has the authority to share its findings with law enforcement.

Other public sector employees in Illinois have also come under scrutiny for PPP fraud. Numerous Cook County government workers have been terminated or resigned for bilking the program of hundreds of thousands of dollars over the past year.

Finding Candor, Compassion, And Fun In Politics

It's a curious sign of our times that one of the best places that I've found to witness candor, compassion, and fun in American politics is the Illinois State Archives' website. I suspect it is not the first place that most people would go to feel good about politics.

The Archives celebrated Illinois' bicentennial in 2018 with an online exhibit called, "The 100 Most Valuable Documents at the Illinois State Archives." It was created to inform, stimulate, and even provoke discussion about Illinois history and is still available on its website.


The documents are a wonderful blend of the profound and the prosaic, the uplifting and the disappointing. For example you can view Illinois' 1818 Constitution, the first Black Law which in 1819 severely limited the rights of African Americans in Illinois, one of the first maps for what became the Illinois & Michigan Canal, an 1840 House resolution announcing that William Ewing of Vandalia defeated Abraham Lincoln of Springfield to be Illinois House speaker, the Illinois Central Railroad's 1851 charter, the Suffrage Act of 1913 which made Illinois the first state east of the Mississippi River to give women the right to vote for president, and a December 1941 resolution convening a special session of the General Assembly following the attack on Pearl Harbor.

This exhibit could — and I think should be the basis of a terrific college or high school class on our state's history. Two documents in *continued on page 13*

particular caught my attention. Not because of their gravity and consequence, but because they remind us that politics can be human and fun.

The first is a March 1858 letter from Abraham Lincoln to Illinois Governor William Bissell requesting that he pardon a man and his son who had been convicted of stealing six small hogs. The convicted man, Samuel Jones, was a widower with seven children.

It's worth recalling that 1858 was a busy year in Lincoln's life. He was building the Republican Party, delivered his "House Divided" speech, and later crisscrossed Illinois by train and coach for seven historic debates with his opponent for the U.S. Senate, Stephen Douglas. Though he had a lot on his mind, Lincoln took the time to write a brief letter that is a master class in candor, concision, and compassion. He acknowledged that he did not know the man convicted nor had he reviewed the evidence from the trial. However, he observed that Samuel Jones' neighbors "appear more anxious that he and his son should be pardoned, than I have known in any other case. This is really all I can say." The note is a modest and gentle request for mercy and commonsense. Governor Bissell pardoned the man and his son.

The second uplifting document is a 1949 veto statement by Governor Adlai Stevenson. The Illinois General Assembly had passed a bill, presumably playfully, requiring Illinoisans to keep their outdoor cats on leashes to prevent them from killing birds. Stevenson decided to veto the bill but not without having some fun. "I cannot agree that it should be the declared public policy of Illinois that a cat visiting a neighbor's yard or crossing the highway is a public nuisance. It is in the nature of cats to do a certain amount of unescorted roaming," he wrote, no doubt with a smile on his face.

"The problem of cat versus bird is as old as time. If we attempt to resolve it by legislation who knows but what we may be called upon to take sides as well in the age-old problems of dog versus cat, bird versus bird, or even bird versus worm. In my opinion, the State of Illinois and its

For these reasons, and not because I love birds the less or cats the more, I veto and withhold my approval from Senate Bill No. 93."

I cannot imagine there exists a more delightful veto message in Illinois history.

Lincoln's letter and Stevenson's veto message provide small examples of candor, compassion, and delight in public life. We need more of these qualities in person and now, not just online and from history.

Legislature Approves Bill to Tighten Restrictions on Red-Light Camera Industry

Bill hailed as first step toward broader ethics reform

Lawmakers in Springfield have unanimously approved a measure that would place new restrictions on the red-light and speed camera industry's involvement in state and local elections and government.

House Bill 3903 would ban automatic traffic enforcement companies or their officers from donating to candidates for public office at the state and local level. It would also prevent state and local government officials from accepting jobs or contracts with those companies while in office or for two years after leaving office, a kind of "revolving door" ban.

Sponsors praised the bill as much-needed ethics reform after several public officials in the past decade have been caught by federal investigators engaging in bribery deals and kickback schemes involving redlight camera companies.

"What this does is it tightens up the ethics surrounding the red-light camera corruption and scandals," Rep. Bob Rita, D-Blue Island, said during the House debate on Thursday.

Rep. Patrick Windhorst, R-Metropolis, called the two-year revolving door ban "a good step."

HB 3909 received unanimous approval in the House on Thursday after a similar unanimous vote in the Senate last week.

The bill would also grant the Illinois Department of Transportation new authority to review and either approve or revoke approval for automated traffic enforcement systems under certain circumstances, such as if a public official is charged with bribery.

The measure would also require that local governments review the safety impacts of automated enforcement systems every two years. Local governments would also have the sole authority to decide to issue tickets, ending their current ability to delegate that decision to the red-light and speed camera companies they contract with.

Bribes in the legislature, local government

The spate of indictments and convictions of public officials caught up in bribery schemes with automated traffic enforcement companies was alluded to during debate on the bill at the Capitol.

"We've had issues with this and I think the bill is a great first step," Sen. Jil Tracy, a Quincy Republican and member of the legislature's ethics commission, said.

Tracy has seen two of her Senate colleagues indicted on such charges in the last four years. In September of last year, Sen. Emil Jones III, D-Chicago, was charged with bribery for a scheme connecting him to red-light camera company SafeSpeed LLC in exchange for shielding the organization from a study of red-light systems in the state. Jones has pleaded not guilty and remains in the Senate. He voted in favor of the measure last week. The late Sen. Martin Sandoval, D-Chicago, also *continued on page 16*



admitted to accepting bribes from the company and falsifying tax returns in 2020. Sandoval died of COVID-19 complications later that year while he was awaiting sentencing.

"The public deserves to have the utmost trust in their government and their law enforcement," bill sponsor Sen. Laura Murphy, D-Des Plaines, said in a news release. "We need to ensure that there is accountability and honesty on all levels."

Two former suburban Chicago mayors, a former Cook County commissioner and his chief of staff have also pleaded guilty to charges involving bribes or kickbacks from SafeSpeed.

In 2016, former assistant Chicago transportation commissioner John Bills was convicted of accepting lavish gifts and \$600,000 in exchange for pushing the city to accept contracts from the red-light camera company Redflex. Bills received a 10-year prison sentence, the longest sentence so far handed down to an Illinois official in connection with a red-light camera company. Federal prison records show he's moved on to a halfway house.

A first step?

The General Assembly is facing pressure to enact ethics reforms in response to federal probes beyond those involving red light camera companies. Earlier this month, three ex-lobbyists and the former CEO of electric utility Commonwealth Edison were convicted of orchestrating a bribery scheme to curry favor with former House Speaker Michael Madigan, who was himself indicted on related corruption and racketeering charges last year.

In mid-May, former Democratic Gov. Pat Quinn made an appearance in Springfield to call for a special legislative session to consider ethics reform.

Madigan's Ex-Chief of Staff Will Test Limits of Loyalty

Tim Mapes accused of lying to grand jury **Despite Immunity Order**

In the summer of 2018, Tim Mapes' name had only recently faded from unflattering headlines after he was forced to resign from three top jobs he held under powerful Illinois House Speaker Michael Madigan.

Mapes, who served as Madigan's chief of staff for more than two decades, was accused of sexual harassment by a woman who reported to him in his capacity as clerk of the Illinois House. It was the third accusation of sexual harassment within Madigan's power structure that year, and the speaker was facing pressure to clean house. "At my direction," a statement from Madigan read at the time, "Tim Mapes has resigned."

But despite Madigan having publicly cut ties with Mapes, the disgraced political operative was still privy to what was going on inside the longtime speaker's inner circle, according to wiretapped phone conversations captured by federal agents in 2018 and 2019. Those recordings were captured on the cell phone of Mike McClain, Madigan's close friend and confidant who for decades also was a fixture in the Democratic power structure that controlled the General Assembly.

In an early July 2018 call, McClain told Mapes about a dinner he and the speaker had recently in a loud restaurant. Mapes joked that McClain should've told the establishment's management, "I'm Mike McClain, I'm the right-hand guy to Mike Madigan."

McClain quipped back, "I'm the right-hand guy of Tim Mapes."

Less than three years later, Mapes would be indicted on one count each of perjury and obstruction of justice after he told a grand jury that he didn't know McClain was doing Madigan's bidding in the years after he officially retired as a lobbyist in 2016.

Mapes allegedly lied to the grand jury despite being under an immunity order; he'd been warned that any untruthful testimony while under the order would result in criminal charges. But the Madigan loyalist has maintained his innocence, and on Monday, jury selection begins in his federal trial in Chicago.

In recent weeks, Mapes and government lawyers

related bribery and racketeering case against the speaker, in which the two men are alleged to have leveraged every position of power Madigan held – including as a partner in his property tax-focused law firm – in a "criminal enterprise." That trial is scheduled for April 1, 2024.

And in this trial, federal prosecutors will attempt to show that Mapes was well aware of McClain's role as Madigan's other right-hand man, a label often used for Mapes himself in the decades he served the speaker.

In the weeks following Mapes' ouster in early June 2018, he and McClain spoke about a dozen times, according to federal court records.

"You're the only person's made me cry today," McClain told Mapes on the day he was forced to resign, according to court records. "Anything I can do, ya know, I'm willing to do, you know that, don't ya?"

That afternoon, McClain also told Mapes, "I never thought you would be the one to leave the fox hole."

Though Mapes contended that letting the jury hear certain calls between him and McClain would be unfairly prejudicial, prosecutors argued the calls show why Mapes was so resistant to telling the grand jury anything that might incriminate either McClain or Madigan.

In their other calls that summer, Mapes and McClain also supported each other through McClain's mother's death, which the government contends is further evidence of their closeness. But they also discussed legislative and political business.

In a pair of calls within a week of each other in June 2018, McClain and Mapes strategized about fundraising within the Democratic Party of Illinois, where Mapes had most recently been executive director under Madigan, the longtime party chair.

In the second of those calls, McClain allegedly relayed a recent conversation he'd had with Madigan about how to reallocate Mapes' work with DPI after his departure.

"This is of course relevant to Mapes' false testimony that he was not aware of the interactions between McClain and Madigan," government lawyers wrote in a filing last month. "It is also relevant to show that McClain was stepping into Mapes' shoes after he left, and Mapes knew about it."

Kness sided with prosecutors in an opinion filed last month denying Mapes' request to block evidence at trial – including the government's intention to tell the jury that Mapes violated his immunity order, which Mapes argued was irrelevant.

"As the government argues, Defendant found himself in a difficult position: he did not want to testify truthfully about McClain and Madigan, but he could not invoke the Fifth Amendment privilege because he had signed an immunity agreement," Kness wrote. "When faced with potentially incriminating questions, therefore, Defendant claimed not to remember – a difficult assertion for the prosecutor to disprove. Because the immunity agreement explains why Defendant answered questions in an allegedly

noting that the ComEd verdict revealed a "grievous breach of public trust."

"If you take a look at the indictments that have been made that are going to be tried next year, the allegations include violations of conflict of interest," Quinn said. "That's just not right. It's not right for anybody in Illinois who's a taxpayer to have legislators voting on bills where they have a financial interest."

Ryan Tolley, the policy director for the government reform group CHANGE Illinois, noted that HB 3909 marks the first time the legislature has enacted a twovear revolving door ban, an idea that was contentious even when the General Assembly passed a six-month ban on lawmakers leaving for lobbying gigs in 2021.

"Hopefully this can be a first step moving forward," Tolley said in an interview.

Tolley noted that he believes further action is needed on ethics reform, such as giving the Legislative Inspector General, the General Assembly's top ethics

have filed last-minute motions trying to block each other's witnesses and evidence, though Judge John Kness has mostly denied Mapes' requests.

The motions contain previews of some wiretapped phone recordings that will be played at trial, mostly made from McClain's cell phone. McClain has already been convicted for his role in helping his biggest client, electric utility Commonwealth Edison, bribe Madigan with jobs and contracts for the speaker's allies in exchange for legislative wins for ComEd in Springfield.

In that seven-week trial this spring, federal prosecutors played dozens of calls featuring McClain and showed the jury hundreds of emails that showed the extent to which McClain went to bat for Madigan. In more than one instance, McClain told colleagues that the speaker was his "real client," and a few witnesses even referred to him as a "double agent" for both ComEd and Madigan.

McClain is also Madigan's co-defendant in a

Mapes and McClain kept each other abreast of other developments in their world for months after Mapes' resignation, including when Mapes was approached by FBI agents in January 2019. Mapes prepared a memo after his meeting with the feds, and the next month told McClain about a conversation he'd had with Madigan's attorney, Sheldon Zenner, according to court filings.

Mapes said he'd given Zenner the memo per "a request," and that he was calling McClain to "report back in" afterward.

"A jury could readily infer that Mapes made these statements to McClain with the intent that McClain relay them to Madigan," prosecutors wrote last month. "At the end of the call, Mapes again says, 'I'm just reporting in,' again clearly showing that he was intending to keep McClain in the loop, so that Madigan, too, could be kept in the loop."
