# Transportation for Civilization and Tourism


From the late 19th Century until the early 20th century, urban trolley systems were a favored mode of transportation. When automobiles became the most popular form of transportation, urban trolley systems began to disappear. Belvidere had a citywide trolley system that began operation in 1895 and survived until the system came to a halt with its last run on June 30, 1915. The trolley rails ran through the middle of State Street before angling east down Logan Avenue. There were a couple of side spurs, but from downtown Belvidere, the trolley slowly clanked along a path east before passing near the larger rail system that knit more distant towns and villages into a national network. Not many years after the Belvidere Trolley System was discontinued, the rails that ran through the middle of State Street and Logan Avenue were removed.

The trolley was reserved almost exclusively for personal transportation rather than to ship freight. Those that lived in residential neighborhoods on the north and south side of Belvidere caught the trolley to ride downtown or even, in those days, to ride to work.

This photograph shows the trolley stopped on South State Street just after crossing the Kishwaukee River. The large building in the photograph was the National Sewing Machine Company. The site of the photograph is also where today the PNC Bank is found.

The arm extending from the roof of the trolley at an approximate 45-degree-angle is the rod that connected the car to the electrical system. Even before electricity was a public utility, many trolley systems moved using electricity rather than an internal combustion engine, powered by a finite supply of hydrocarbons.

Two men ran the trolley. The motorman in the front that kept the car moving and the conduc-





## State Supreme Court Weighs Another BIPA Lawsuit, Lawmakers Mull Child Data Privacy Framework

Health care industry argues it is exempt from biometric privacy liability

In Springfield on Thursday, the medical industry went to court.

The Illinois Supreme Court heard oral arguments in a pair of class action suits brought by two suburban nurses, Lucille Mosby and Yana Mazya, who allege their employers violated the state's Biometric Information Privacy Act, a landmark 2008 law that gives Illinois residents the ability to sue companies that misuse biometric data, such as fingerprints or facial scans.

It's the same act that formed the basis of several high-profile lawsuits that have led to massive penalties or settlements, such as the \$650 million Facebook agreed to pay its Illinois users after it was alleged to have misused biometric data.

The nurses allege that, by requiring the use of fingerprint scanners to open medicine cabinets, Northwestern Medicine, UChicago Medicine and Becton, Dickinson and Co. – the company that makes the medicine cabinets – violated BIPA.

According to court filings, the hospital systems did not collect written releases allowing them to use the fingerprint data, nor did the hospitals provide information about how the biometrics would be stored or eventually destroyed. They also failed to obtain consent to disclose the fingerprint data to third-party vendors that host it.

But lawyers for the defendants argued the use of biometrics to manage medicine falls under an exemption to the law because it counts as, in the words of BIPA, "health care treatment, payment, or operations under the federal Health Insurance Portability and Accountability Act."

# Lawmakers Criticize Pritzker Administration's Handling Of Noncitizen Health Care Limits

Lack of 'collaboration' with immigrant advocates, executive overreach among concerns

Members of a state rulemaking oversight committee voiced concerns Tuesday that Gov. JB Pritzker's administration didn't sufficiently seek public input on its plan to cap enrollment in Medicaid-like health care programs for noncitizens.

The controversy centers on the Health Benefits for Immigrant Adults and Health Benefits for Immigrant Seniors programs, which provide health care benefits to low-income noncitizens who would qualify for Medicaid benefits if not for their citizenship status.

During May budget negotiations, lawmakers gave the Pritzker administration authority to cap program spending through emergency rulemaking, and his administration exercised that authority in late June.

Those emergency rules froze enrollment in HBIA, which serves noncitizens aged 42 to 64, and set a cap for enrollees in HBIS, which provides benefits to noncitizens age 65 and over. The changes also reduce reimbursement rates for two large public hospitals, institute copayments and coinsurance for some services and transition some enrollees into the state's Medicaid managed care program in an effort to reduce costs.

The Joint Committee on Administrative Rules on Tuesday heard from representatives of the state's Department of Healthcare and Family Services, who defended the rules.

"There is much more that can and must be done on a federal level to address a national humanitarian crisis that is currently being shouldered by state and local governments without support," Pritzker wrote in a three-page letter to the White House on Monday.

Without naming GOP figures like Texas Gov. Greg Abbott, Pritzker blamed political leaders who "have shipped people to our state like cargo in a dehumanizing attempt to score political points." But he also faulted the Biden administration for its lack of support for Illinois, which has already dedicated \$330 million to addressing the influx of 15,000 migrants and counting.

"Today, Illinois stands mostly unsupported against this enormous strain on our state resources," Pritzker wrote.

Since last August, Chicago has been one of the cities targeted by Republican leaders like Abbott, Florida Gov. Ron DeSantis and others who've paid for buses and air travel to relocate asylumseekers from their states.

Migrants hail mostly from Central and South America, including a large contingent fleeing economic and political collapse in Venezuela. New York City, which began receiving migrants earlier in 2022, has seen more than 110,000 asylum-seekers enter the city in the last year and a half, though some have moved onto other places, including Chicago.

On Friday, Pritzker's office announced the state would send an additional \$30.3 million to Chicago to address the needs of asylum seekers, along with roughly \$11 million to be split among several municipalities in the Chicago area and \$250,000 for downstate Urbana. The money represents nearly all of a \$42.5 million line item in the state's budget for the current fiscal year, which began in July.

The governor has been a vocal Biden ally, including in his monthslong effort to bring the Democratic National Convention to Chicago next summer. During a visit to Chicago in June, the president praised Pritzker as having "helped me more than anybody in America" in his 2020 election bid.

In his carefully worded letter, the governor thanked Biden for steps his administration had taken to assist Illinois' response to the migrant crisis, like providing "modest" funding through the Federal Emergency Management Agency. But he was unequivocal in expressing the need for more federal aid.

"The burden of funding the state and city have taken on is not sustainable only by our budgets," Pritzker wrote.

#### 'Untenable'

Pritzker accused the federal government of "abdicating responsibility" for asylum-seekers once U.S. Customs and Border Protection releases the migrants after any initial detention at the border.

The states busing migrants to Illinois have typically given no warning to state and city officials, and the pace of arrivals has been accelerating in recent weeks. Volunteer groups have worked to fill in the gaps of the ad hoc response. Pritzker urged the Biden administration to "take a much more active role in managing the transport and destination of the transport of asylum seekers."

"Unfortunately, the welcome and aid Illinois has been providing to these asylum seekers has not been matched with support by the federal government," Pritzker wrote. "Most critically, the federal government's lack of intervention and coordination at the border has created an untenable situation for Illinois."

The governor also criticized the White House for having a disorganized and disjointed system for responding to leaders in states and cities taking on migrants. Pritzker recommended that instead of the current system of "too many different federal department contacts — who are uncoordinated with one another," the federal government should create "a single office with an identified leader" to coordinate with state and city leaders.

The governor sent the letter one day after he, Chicago Mayor Brandon Johnson and the White House spoke on a conference call. Last week, tensions flared between Pritzker and the new mayor's allies on the Chicago City Council after Johnson's administration signed a \$30 million contract with a security firm to set up a "base camp" for migrants, many of whom are sleeping in airports and police stations across the city.

#### Work permits

At the end of August, when the number of asylum-seekers who'd arrived in Chicago numbered approximately 13,000, Pritzker and

other political and business leaders urged the Biden administration to allow Illinois to sponsor work permits for migrants. The idea is a bipartisan one that other states have also requested, especially as the U.S. economy still faces labor shortages in key industries while it continues to recalibrate from the COVID-19 pandemic.

In response, the Department of Homeland Security granted Temporary Protected Status to Venezuelan migrants last month while announcing plans to accelerate paperwork processing times. But Pritzker argued that TPS-eligible migrants will still have to wait months for their work authorization paperwork to clear, and he urged further action from Biden to "cut the red tape." And for non-Venezuelan migrants, the governor asked Biden to waive the "high cost" fee to apply for TPS.

"Mr. President, I urge you, (DHS) Secretary Mayorkas, and the rest of your administration to take swift action and intervene on our behalf and on behalf of the other affected states and their residents, as well as on behalf of the tens of thousands of asylum seekers who undertook a dangerous and difficult journey in hopes of attaining public safety and forging a better life for themselves and their families," Pritzker wrote.

The exact wording of the law, and the definition of "under," faced scrutiny from lawyers on both sides of the case as they argued about the intersection of BIPA and the federal HIPAA law.

"If the defendant is correct, that means the General Assembly decided that as much as 10 percent of the Illinois workforce should have no biometric privacy protection whatsoever, simply by virtue of working in the health care field," the nurses' attorney, Jim Zouras, told the court Thursday.

Beyond the specifics of the case, the hospitals' lawyers also focused on its potential industrywide impact. In their legal brieffiled ahead of arguments, they said health care providers would potentially face "catastrophic liability."

In a February decision against fast food chain White Castle, the Supreme Court ruled that each separate violation of BIPA – meaning every time the company required an employee to sign in using biometric data – represented a separate violation of the law. With penalties of \$1,000 or \$5,000 per violation included in BIPA, White Castle estimated the ruling could eventually cost the company \$17 billion.

That level of liability could be disastrous if applied to the medical community, the defendants argued.

"Biometrics are industry standard at this point," Matt Wolfe, a lawyer for BD, told the justices Thursday. "Over the last 15 years, this type of technology has become extremely widely used in the health care setting."

A lower court agreed with the nurses in 2022, with Justice Sharon Oden Johnson of the First District Appellate Court writing lawmakers "did not exclude health-care employee biometric information" from BIPA protections.

The case has drawn the attention of both the wider medical industry and the business community.

Severalmajoradvocacy and trade groups filed amicus briefs in the case, generally supporting the exclusion of health care workers from BIPA protections. These include the Illinois Health and Hospital Association, the Advanced Medical Technology Association and a coalition of private hospitals including Springfield-based Memorial Health, Northshore University Health System and Rush University System for Health in the Chicago area.

The Illinois Chamber of Commerce and the U.S. Chamber of Commerce also filed briefs warning of potential "annihilative liability" for hospitals if the court rules in the nurses' favor, referencing a line from a dissent written by Justice David Overstreet in the White Castle case.

While most of the amicus briefs supported the hospitals' arguments, the American Nurses Association filed an amicus brief supporting the plaintiffs.

"To exempt hundreds of thousands of healthcare workers from coverage without explicit language from the legislature to that effect would be contrary to BIPA's purpose," the organization's lawyers wrote in their brief.

The justices will now take the arguments into consideration, although there is no timetable for a decision being filed.

#### Lawmakers consider broader framework

While the high court considers the state's existing privacy regulations, lawmakers are thinking about broader privacy frameworks. A Senate committee met in Chicago on Tuesday to

discuss an unrelated proposal that would create a framework for data privacy focused on strengthening protections for minors online.

The hearing, held by the Senate Judiciary Committee, was to discuss a proposal from Sen. Sue Rezin, R-Morris, to implement "age-appropriate an design code." The proposed policy would require companies that offer online services "likely to be accessed by children" to assess the impact of their product on children and explain privacy policies in language that children would understand.

Under Rezin's bill as it is written currently, businesses would be liable for civil penalties of up to \$2,500 per affected child for negligent violations of privacy protections and up to \$7,500 per affected child for intentional violations.

The proposal would also place new privacy and data restrictions on companies, limiting their ability to profit from and share data collected from or about minors. This has drawn support from some youth activists, who say a policy like this could help curb the harmful effects of social media

"I'm here to speak on behalf of my generation for the harm we've experienced," Zamaan Qureshi, co-chair of the advocacy organization Design It For Us, told lawmakers Tuesday. "Some of our generation have developed depression, eating disorders and attempted or taken their life due to social media."

Rezin said the proposal is "almost identical" to a similarly named California law passed in 2022. That law was inspired in turn by another similarly named policy adopted in the United Kingdom.

The age-appropriate design code would also require companies to estimate the age of their users to a "reasonable level of certainty" and apply child-focused protections based on that estimated age. Alternatively, the companies could apply those protections to all users.

But Tyler Diers, a representative of the tech industry lobbying group TechNet, argued such a requirement would encourage web companies to collect more personally identifiable information than they already do, leading to increased risks from data breaches.

TechNet's members include Apple, Google and Meta – the owner of Facebook and Instagram – among other large tech companies.


On Monday, a federal judge in the Northern District of California granted a preliminary injunction in a lawsuit brought by tech lobbying group NetChoice that objects to California's age-appropriate design code law. The judge found the tech industry's argument that the law violates the First Amendment would likely prevail at trial.

When asked about the pending legal challenges to the ideas underlying her bill, Rezin said she expects to iron out some of those details in future legislation.

"The hearing was

a first step in educating my colleagues on how social media companies are creating algorithms to addict minors because they view minors as a product they can advertise to, to make money off of," Rezin told Capitol News Illinois.

tor, who made certain that the fares were collected. The name of the company that managed the trolley system was the Belvidere City Railway Company. The company, according to a number of sources, began business in 1895, but only survived until 1915, when the last street trolley route was run.

The photograph appears to have been taken near the turn of the century or shortly before. There are no automobiles or, as they were cursed, "horseless carriages," seen on the street. One man rides a horse beyond the trolley while a horse-drawn carriages abound on South State Street. Of course, more than a century ago, saddling a horse or hitching a team was how many moved across town.

On that sunny late summer day when the photograph was taken, it appears as if the trolley was enjoying a brisk business. We are uncertain what the fare might have been in that era, but a fee of a penny or two might have been adequate. Two cents might have been a small price to pay for a ride down State Street to the Bowley Bakery for fresh baked bread or perhaps one of their matchless apple pies. But in that same earlier era, most families would dedicate one day each week to bake bread. Likely a tasty tart apple pie was also prepared to grace many home-cooked menus for a Sunday dinner.

Trolley systems flourished for decades across the nation with systems operating in every state and in many small and large cities. For example, the Chicago Trolley System began not as an electric car network, but as a horse-drawn system. Later, electricity replaced the horses, and finally, the elevated train system was created. That train, known as the El and a network of over 100 bus

routes make the public transit system in Chicago today. Many of these bus routes are former trolley lines and carry the same route number that the trolley did! The Chicago Trolley System survived until 1947, when the Chicago Transit Authority (CTA) was born.

Rockford had a horse-drawn trolley system that began operation in 1881 and thrived for only a few years until 1889. The system was converted to an electric network that survived until 1936, when the electric cars were replaced by diesel burning buses. Today, Rockford's diesel buses are being replaced by electric buses and financed through grants.

For many years, there was an inter-city system of trolley transit that connected Rockford to Belvidere, which also traveled to more distant points east and west. However, in the throes of the Great Depression inter-city transportation systems began to disappear as automobile transportation and truck traffic grew in popularity.

Trolley travel appealed to a public that enjoyed a more relaxed form of transportation. Those travelers savored a more relaxed pace and had more time available or possessed a willingness to be less concerned with the loss of time moving from one place to another place.

There remain several vintage trolley systems in continuous operation in America that have a wider reputation than the short-lived system that once served Belvidere. These systems continue to operate in New Orleans, Philadelphia, Boston, and San Francisco.

New Orleans still has four operating trolley streetcar lines, the Riverfront Line, the Canal Street Line, the Loyola Avenue Line and the most famous in the city and the longest, the St. Charles Line. It is on the St. Charles Line where a streetcar still car-

ries the title, "Desire," in a route box above the front of the car.

Beyond these vintage trolley-systems, there is a worldwide revolution in new trolley systems. Often known as light rail, trams or streetcars, systems have made their debut in almost every major Midwestern city. Milwaukee's is known as The Hop and is free to ride. Even Kenosha now has a streetcar.

After the last troltook another 35 years before national train discontinued serves due to lack of ridership, including passenger rail service in Belvidere. Those that savor how it was in their youth—or perhaps in grandparents' their youth—can imagine what might have been a very enjoyable ride down State Street on a sunny, late-summer afternoon much like the romantic idea of train service returning to Belvidere stopping at a vintage depot.

The rules are designed, according to IDHFS officials, to limit costs for the program, which they say would be underfunded by hundreds of millions of dollars without the changes.

"We have projected liabilities of about \$1.2 billion for the program if no changes are made," IDHFS chief of staff Ben Winick said at JCAR's Tuesday meeting in Chicago.

He noted the General Assembly allocated \$550 million while giving the administration the authority to cap costs.

Pritzker's administration proposed the changes in both "emergency" and "permanent" administrative rules. While emergency rules are generally valid for 150 days, the law authorizing the administration to limit program enrollment also allows it to refile emergency rules once they expire. That means that unless JCAR votes by a three-fifths majority to suspend the rules, they would remain in place as long as the department wants, at least for the next two years.

JCAR – which consists of six Democrats and six Republicans and is responsible for overseeing policy making within the state's executive branch – didn't take action on either the emergency or permanent rules Tuesday, although the committee can still take action at a future meeting.

Both Democratic and Republican members shared concerns with IDHFS officials that mostly focused on the process by which the rules were developed.

Sen. Cristina Castro, an Elgin Democrat and member of the Illinois Legislative Latino Caucus, said that the department failed to consult stakeholders in the immigrant advocacy community when developing the rules.

"You quickly filed both the emergency rule and permanent rule. There's obviously been no discussions with advocates on either, it seems," Castro told IDHFS officials.

Rep. Eva-Dina Delgado, D-Chicago, also said she wanted to see "immediate action" to engage stakeholders and advocacy groups before moving forward with the process of implementing the department's proposed permanent rules. She particularly criticized the department's plan to issue a 14-day notice before freezing enrollment in HBIS.

"I'd like you all to engage with those that are impacted because I just don't know if that's going to be workable," Delgado said. "If you change somebody's health care every two weeks and expect them to follow along, even if they are fully language proficient, I think you're just asking for problems."





policy.

"This is another instance of a governor that thinks he can legislate on his own," Reick said. "First he did it with 47 disaster declarations and now he's doing it with emergency rule."

Sen. Bill Cunningham, a Chicago Democrat and co-chair of JCAR, said the committee was frustrated at the lack of stakeholder engagement from several agencies. JCAR also discussed a controversial emission rule change for heavy industries Tuesday, objecting to two state agencies' hurried implementation process.

"I think you heard throughout this meeting a frustration from committee members about the lack of engagement between agencies and various stakeholders and that was true across the board," he said in an interview after the hearing.

Cunningham said the committee will "likely" have another discussion about the health care rules next month.

"I am hopeful they will act in a good faith effort to collaborate more closely with the stakeholder groups," Cunningham said.
