Bears Pitch \$3.2 Billion Stadium Plan, Pritzker Still 'Skeptical' Despite Team's \$2 Billion Pledge

Bears executives, city leaders make appeal for \$900 million in public funding, \$1.5 billion for infrastructure

The Chicago Bears laid out a \$3.2 billion plan for a new domed stadium on Chicago's lakefront last week, painting pictures of future Super Bowls and other major public events while pinning their hopes on yet-to-be-had conversations with the governor and lawmakers.

The Bears – accompanied by Chicago Mayor Brandon Johnson at a Wednesday news conference – proposed a public-private partnership through which the Bears lease the stadium from the Chicago Park District. While the team would put up over \$2 billion of the \$3.2 billion needed to build the stadium, it's also seeking \$1.5 billion in infrastructure support over several years to realize its vision for a multi-use public park space on Chicago's lakefront Museum Campus.

Chicago Bears president and CEO Kevin Warren said the \$2 billion committed by the Bears would be the largest private investment in Chicago history. He also said a new stadium would provide thousands of temporary and long-term jobs for Chicagoans. Warren joined the Bears in early 2023 after previously brokering a deal to bring the Minnesota Vikings a new stadium with a public-private partnership in Minneapolis.

"Look around Chicago, I know the mayor is doing all that he can with his leadership to lean in to get economic development going," Warren said. "We want to be that catalyst."

Despite that major commitment, Bears executives sought to fill an estimated \$900 million "gap" through state funding via a bond from the Illinois Sports Facility Authority, a state agency created in the 1980s to finance new sports stadiums. The team also proposed using the city's

existing hotel tax and restructuring ISFA's current debt over a 40-year period.

While the proposal represents the largest private commitment of any of the recent pushes by professional sports teams for a new stadium yet, it was quickly met with skepticism by Gov. JB Pritzker, who was at a concurrent news conference at Loyola University Chicago.

"I'm highly skeptical of the proposal that's been made and I believe strongly that this is not a high priority for legislators, and certainly not for me when I compare it to all the other things," Pritzker said.

The governor downplayed the competing news conferences. He'd scheduled his in advance to highlight health insurance reforms that recently cleared the House with his support. The Bears' announcement was scheduled within the past two days.

Part of the proposal includes developing about 15 acres of recreational park space for public use and more stadium vendor businesses owned by women and people of color. Johnson hailed the project for upholding his "criteria for any new development project."

"We require real private investment, real public use and real economic participation for the entire city," he said.

He noted no new taxes would be imposed on Chicago residents and the city can expect "increased tax revenue from this investment, expanded public recreation, stronger economic growth for the entire city of Chicago for generations to come."

Team leaders claimed in their presentation that the stadium would create over 40,000 construction jobs and over 4,000 permanent jobs.

The Bears' presentation noted the organization was seeking about \$1.5 billion in three phases of infrastructure investment that could come "at the state level, at the potentially federal level, potentially at the city level," according to Warren, who gave no specifics.

Karen Murphy, the team's executive vice president of stadium development and chief operating officer, said that includes \$325 million in transportation, roadway and utility improvements that would be needed to open the stadium.

The remaining funding – at least \$1.1 billion – would come over a period of at least five years. That could include \$510 million in a second phase of construction for things such as parking upgrades and building surrounding parks and ballfields, followed by \$665 million for further attractions and transportation improvements in a third phase. Bears representatives said those estimates are subject to change.

Pritzker mentioned "higher priorities for the state" than building a football stadium, including his \$4.4 million proposed investment in birth equity centers to create a statewide plan and distribute building grants. And he noted Missouri voters rejected a stadium funding plan for the reigning Super Bowl champion Kansas City Chiefs and for the Kansas City Royals baseball team.

"The problem is that the offer that they've made just isn't one that I think the taxpayers are interested in getting engaged in," Pritzker said of the proposal, later adding, "We've seen this fail over and over across the United States."

House Speaker Emanuel "Chris" Welch, D-Hillside, who attended the governor's news conference at Loyola, said he gave Warren a blunt assessment when they recently met privately.

"If we were to put this issue on the board for a vote right now, it would fail and it would fail miserably. There is no environment for something like this today," he said.

Senate President Don Harmon, D-Oak Park, also expressed skepticism in a statement.

"At first glance, more than \$2 billion in private funding is better than zero and a more credible opening offer," he said. "But there's an obvious, substantial gap remaining, and I echo the governor's skepticism."

As for the bonding authority sought by the Bears, Pritzker noted three pro sports teams are seeking money through the ISFA for a new stadium – the Bears, the Chicago White Sox baseball team and the Chicago Red Stars women's soccer team.

"And this is one team that is offering to take all of the tax revenue for their stadium and

there apparently is nothing left over for the other two teams," Pritzker said.

While Pritzker had not been briefed on the proposal prior to Wednesday's news conference, Warren said team representatives "look forward to having some detailed conversations with the state here in the near future."

"Today was the first day that we have been able to publicly roll out our plan," he said. "It's very difficult for someone to say they're against this and we just presented it, so we look forward to having more conversations with individuals in Springfield."

When pressed by media at the Loyola event as to whether there was a "path" for him to support a subsidy plan, Pritzker responded "sure," but with a caveat.

"This has got to be a lot better for taxpayers than what they put forward. That's all I'm saying," he added.

Da Bare Facts

Last week, the Chicago Bears released fancy renderings of the stadium they would like to build on Chicago's Lakefront to replace Soldier Field. Chicago Mayor Brandon Johnson was there cheering them on. (Right now, Mayor Johnson needs to post a win even more than the Chicago White Sox!)

Like so many big Chicago proposals, the name "Daniel Burnham" was invoked along with Burnham's admonition to "make no little plans." A celebrated architect, Daniel Burnham created the master plan for the City of Chicago in 1909. Missing from the presentation was Burnham's equally famous exhortation to keep the lakefront space open, as it belongs to the people.

Open lakefront considerations aside, this project would allegedly be paid for by the McCaskey family, owners of the Chicago Bears, who would generously spend \$2.3 billion of their money to build this football palace. It would all be wonderful, with a weather-controlled stadium and great public spaces indoors and out.

Of course, there was the little matter of asking the Illinois Sports Facilities Authority to also borrow \$900 million for the project, for which the taxpayers of Illinois ultimately would be liable. (So, yes, it is of concern to Boone County.) The Authority would also refinance the \$430 million spent on previous projects, including the flying-saucer renovation of Soldier Field and \$160 million on top of that to create a "liquidity cushion."

Naturally, the City of Chicago would commit an additional \$1.5 billion in infrastructure improvements to support this great edifice.

Not to worry, though. The Bears organization reassured everyone that none of this will cost taxpayers a dime.

The last we heard, the Bears were moving to Arlington Heights.

That apparently didn't work out so well. It seems the McCaskeys were offended that the local school district expected the Bears to pay their fair share of property taxes for the local schools. (Why, the local school trustees must be Packers fans or something!) Immediately, a parade of suburbs from Naperville to Joliet to Waukegan suddenly were courting the Bears to build a new stadium in their fair cities. We're surprised Belvidere didn't put in a bid!

Governor J.B. Pritzker would have to approve the Sports Facilities Authority's loans. Pritzker (after reassuring everyone that he was, indeed, a

Bears fan and, indeed, wanted a domed stadium in Chicago) said he believed that the team's owners, the McCaskeys, should pay for the "vast majority" of the project. And that the taxpayers, if they put up anything, "should be getting return on the investment that they're making."

We agree with Governor Pritzker.

Study after study based on the empirical evidence of publicly supported or subsidized sports stadiums has shown that they are a bad investment for taxpayers. Chicago is already saddled with a mountain of debt and a large backlog of urgently needed projects. Much of that is from the latest Soldier Field renovations. And if Chicago has trouble paying all of those bills, rest assured that they will be at the General Assembly in Springfield, crying for help.

Effective schools, efficient transit, and affordable housing need to come before professional sports facilities.

Of course, this "naysaying" does not play well with the rah-rah crowd, both city and suburban, who wants a shiny new stadium. They are much like those in Belvidere who chant "we want a choo-choo" and refuse to acknowledge the reality that their train fantasy is not financially feasible.

Great public works are what make a city thrive, and we support building them. Silly projects like a new stadium for the Chicago Bears do not. Nor do ill-conceived "political projects" like Chicago's proposed multi-billion-dollar CTA Red Line elevated train extension to 130th Street. There are parallel Metra trains, both to the east and west of the proposed route, just a mile away. Multiple CTA bus routes crisscross the area. We are told that the "Roseland community" is a transit desert. Belvidere, with no bus service to the east—and virtually nothing to Rockford—must be the Sahara by those standards!

Another silly state political project is to spend over \$100 million building a four-lane replacement for Business Route 20 between Rockford and Belvidere. The new road would have three additional traffic signals and a 45-mph speed limit, replacing the current 55-mph limit. Of course, the current speed of traffic on that road is usually something over 60. When we noted that, despite numerous road "improvements," the travel time between Rockford and Belvidere is already slower than it was at the end of World War II. The proffered justification for an even slower road was that it will be "safer." (We were not aware that the present road was particularly dangerous.) Obviously, the sponsoring politicians and Illinois Department of Transportation couldn't care less about the inconvenience this will visit on Belvidereans and others making the journey.

We note that Illinois has almost universally higher tax rates than Wisconsin or Indiana. If we are going to pay more, we should get more. We want constructive, well-conceptualized projects, not boondoggles.

Maybe the Bears should move back to Decatur. Perhaps their local taxpayers will pay to plant a couple of goal posts in a local park!

After 3 Years, State Poised to Enforce Law Aiming to End Lending Discrimination

State-level Community Reinvestment Act finally was mired in rulemaking process

In 1977, then-President Jimmy Carter signed into law the Community Reinvestment Act, a federal law that sought to wipe away the last vestiges of racial discrimination and redlining in America's home mortgage industry.

The idea was simple. By requiring lenders – primarily banks – to make credit available in all parts of the communities they served, including low- and moderate-income neighborhoods, the government could redirect the flow of private capital back into areas that had suffered from decades of systemic disinvestment.

Nearly half a century later, many people in Illinois argue the federal CRA has failed to live up to its promise. Whether that's because the law was too narrow in scope, or because the lending business itself has changed dramatically over the decades, urban metropolitan areas like Chicago are still plagued with crumbling neighborhoods where few lenders are willing to invest.

"My area is the southeast side of Chicago, so if you want to talk about Woodlawn, Hyde Park, South Chicago, I mean, these are places where you have a significant amount of folks who are not white and upper-middle class. So yeah, there's been a problem," Rep. Curtis Tarver, D-Chicago, said during a recent interview.

Tarver was among the sponsors of a 2021 bill that enacted a new state-level Community Reinvestment Act. Passed during a special lame duck session in January that year, it was part of the Legislative Black Caucus' "four pillars" of social and economic reform measures that grew out of unrest that began sweeping across minority communities throughout the United States the previous summer.

"There were a few things that happened in 2020," recalled Jane Doyle of the Chicago-based Woodstock Institute, one of the main backers of the bill. "Of course, the pandemic, the ways that the pandemic exposed racial disparities in our economy and our health care system, pretty much all parts of society. There was the murder of George Floyd and the Black Lives Matter protests that ensued after that."

But more specific to Chicago and the lending industry, Doyle said, was an investigative news story entitled "Where Banks Don't Lend," by public radio station WBEZ and the nonprofit news organization City Bureau. It was released June 3, 2020, less than two weeks after Floyd's death.

"The sort of big summary data point that came out of that is that there was more mortgage capital invested in one majority-white community in Chicago than all majority-Black communities combined," Doyle said.

It was against that backdrop that the Legislative Black Caucus pushed through the Illinois Community Reinvestment Act, a part of its "Economic Access, Equity, and Opportunity" pillar.

Unlike the federal law, which applies primarily to nationally chartered banks, the state law applies to state-chartered banks and savings banks, credit unions and non-bank mortgage lenders.

It provides that every institution covered by the law has a "continuing and affirmative obligation to meet the financial services needs of the communities in which its offices, branches, and

other facilities are maintained." It also empowers the Illinois Department of Financial and Professional Regulation to conduct examinations to measure each institution's compliance with the law.

Much like the federal law, the state law does not impose specific mandates or establish any type of lending quotas on financial institutions. It does, however, require them to report on a periodic basis such things as the number and amount of mortgage loans and small business loans they make, the extent of their marketing activities to make community members aware of their services, and their participation in community development and redevelopment programs.

It also gives IDFP authority to review those reports and assign rating scores to each institution, classifying their compliance record as either "outstanding," "satisfactory," "needs to improve," or "substantial noncompliance."

Gov. JB Pritzker signed the bill into law March 23, 2021, and the law was supposed to be in full effect by Jan. 1, 2022.

That, however, proved to be more difficult than originally thought. The process of writing administrative rules to implement the law dragged on for nearly three years while regulators and industry officials negotiated the details of what information would have to be reported and how that information would be handled by the agency.

Those negotiations finally came to an end in April when the legislative Joint Committee on Administrative Rules, or JCAR, gave its blessing to the final rules, which now await publication in the Illinois Register before they are considered official.

"I knew it was hotly discussed and debated," Sen. Chris Belt, D-Swansea, the bill's chief Senate sponsor, said in an interview. "I'm not on JCAR so I don't know why it took so long. I know it was a lot of issues and nuances that they were discussing. I'm just glad that is over now."

Belt is also the lead sponsor of a follow-up bill this year, Senate Bill 3235. It calls on the state's Commission on Equity and Inclusion to conduct studies that will provide baseline information to identify geographies in Illinois where significant disparities exist in access to financial products and services, along with a listing of existing policies and practices that may have disparate impacts or discriminatory effects.

That bill passed out of the Senate April 18 and now awaits action in the House.

Advocates Renew Push To Tighten Firearm Laws Aimed At Protecting Domestic Violence Victims

Groups also call for changes to state's homicide reporting, cold case investigations

Advocates for stricter gun laws rallied at the state Capitol Tuesday for a measure aimed at protecting domestic violence victims and two other criminal justice reforms.

The bills are backed by organizations such as Moms Demand Action and One Aim Illinois among others.

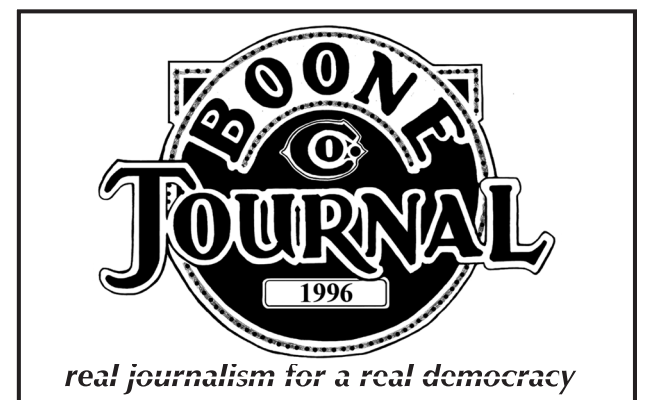
"These policies support those communities most impacted by the gun violence crisis," Yolanda Androzzo, One Aim Illinois program director, said at a rally Tuesday. "It's an opportunity to ensure protection and justice for survivors of gun violence."

A proposal dubbed Karina's Bill, contained in House Bill 4469 and Senate Bill 2633, is a response to the 2023 shooting death of Karina Gonzalez and her daughter in Chicago. Gonzalez's husband, Jose Alvarez, had an order of protection against him when he was alleged to have committed the murder last year.

The measure would clarify the process for victims who seek specific orders of protection under the state's firearm remedy – one of 18 specific remedies that can accompany an order of protection. Individuals can petition the court for such a remedy, and the bill would amend the process for what happens when it is granted.

Karina's Bill would require law enforcement to confiscate firearms when an emergency order of protection is granted with a firearm remedy. It would also require a judge to issue a search warrant in cases where the remedy is granted, provided the judge finds there is probable cause that the individual possesses a firearm and is a

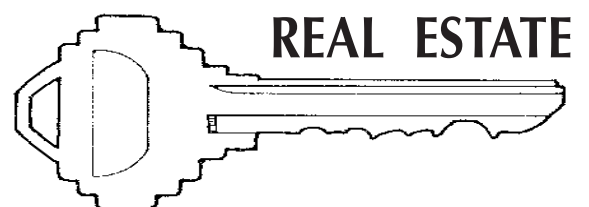

threat to the victim.

The proposal would also prohibit gun owners from transferring the firearms to another individual instead of surrendering them to law enforcement along with their Firearm Owner's Identification, or FOID, card.

The bill also adds an "intimate partner" — such as present and past spouses, dating or engaged relationships — to the list of those who can petition for a firearm restraining order. Previously, only family members and law enforcement officers could petition for such a remedy.

Both versions of the bill are still in committee.

"Gun violence is occurring way too often in our communities, in our schools, in our malls, everywhere," bill sponsor Sen. Celina Villanueva, D-Chicago, said at Tuesday's rally. "The reason why I'm championing Karina's law is because I want to make sure that Karina and Daniela's names never be forgotten. That what they went through never be forgotten."

House Bill 4753, known as the Homicide Victims' Families' Rights Act, would allow people to petition law enforcement to review murder cases that have been unsolved for at least three years. Officers who worked on the case previously would not be allowed to participate in the review. The bill, sponsored by Rep. Kam Buckner, D-Chicago, passed out of a committee on a 13-2 vote on April 4 and is awaiting action in the House.

"These bills, these actions, these pieces of policies have come directly from you," Buckner told rallygoers Tuesday. "And unfortunately, they've come from the pain that many of you have endured."

Buckner is also the sponsor of House Bill 4754, which would amend the Uniform Crime Reporting Act. The bill would require law enforcement agencies to digitally publish statistics of homicides and nonfatal shootings including if the cases are cleared or closed, if an arrest was made, and if the case was submitted to their local state's attorney's office.

"Without accurate homicide statistics we can't create evidence-based solutions to our county's gun violence problem," Alicia Schemel, a volunteer with Moms Demand Action, said.

The bill cleared committee on a 10-5 vote earlier this month and is awaiting action in the House.

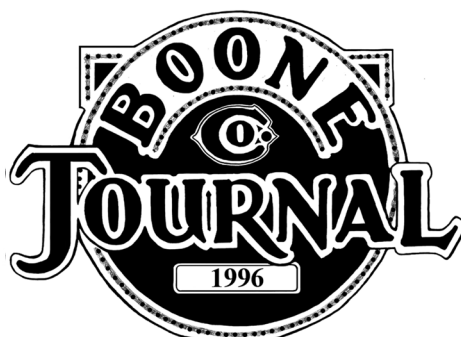

Education Leaders Seek Added State Funding to Help Districts Accommodate Influx of Migrants

Some advocates now put cost at upwards of \$180 million as state education board seeks \$35 million

The recent surge of international migrants arriving in Illinois has brought with it a host of new challenges for state and local officials. Those range from filling their most basic needs like emergency food, clothing, and shelter, to more complex issues like lining them up with basic health care, financial assistance, and other social services.

But there is another challenge stemming from the influx of migrants that some advocates say the state has not done enough to address – educating the children of those coming across the border.

Jeannie Stachowiak, superintendent of North Palos School District 117, a district of about 3,500 students in Chicago’s southwest suburbs, told a legislative committee this week how the crisis has affected her schools.

“Over 40 percent of our students qualify for English learner services, and the numbers are continuing to grow,” she said. “Just this year, we have enrolled 83 newcomer students who come from 16 different countries, from the Middle East, Eastern Europe, South America, and Mexico. Many of these students have suffered trauma in their countries of origin and have experienced interrupted schooling. Several who are enrolled also need additional services beyond that of (English learner), which may include special education as they were not properly identified and supported before they came to the United States.”

Kimako Patterson, chief of staff at the Illinois State Board of Education, said that in the last two years, a total of 62,644 “newcomers” have arrived

in the state’s schools. Those are people age 3 to 21 who were born outside of the 50 states, Washington, D.C., and Puerto Rico and have been attending school in the U.S. for less than three years.

Most of those students are enrolled in Chicago Public Schools, she said, but an estimated 12,771 are enrolled in other districts. She said those students come from 147 different countries, led by Mexico, Colombia, Ukraine, India, and Venezuela.

In January, the ISBE submitted a funding request for the upcoming fiscal year totaling just over \$11 billion, or roughly one-fifth of the state’s entire General Revenue Fund budget. That included \$35 million in new funding to support migrant students.

Although Gov. JB Pritzker did not include that money in the budget proposal he sent to the General Assembly, the ISBE still hopes to have it included in the final budget that lawmakers pass this session.

State Rep. Fred Crespo, D, Hoffman Estates, is the lead sponsor of two bills – House Bills 2822 and 3991 – that would authorize the ISBE to distribute \$35 million in New Arrival Student Grants to local districts that apply for a share of the funding.

But some advocates now say the \$35 million that was included in the ISBE’s budget request was based on old information, and they now estimate a much higher cost of \$188 million, just for districts in the Chicago metropolitan area.

“Yes, \$188 million to fund the Supporting Newcomer Students program,” Bridget Peach, executive director of the advocacy group ED-RED, told the House K-12 education budget committee Tuesday. “This amount represents the needs of (Chicago Public Schools), Cook County, Lake County, and DuPage County school districts.”

That figure came as a shock to some committee members, particularly Republicans who view the influx of migrants as a direct consequence of state and local policies that welcome immigrants, regardless of their legal status.

“Do we think that it’s a good idea to stop, or at least put a moratorium, on the sanctuary state policy until we could get to a level where we could actually afford this,” asked Rep. Blaine Wilhour, R-Beecher City. “I mean, we have every district

ident Biden to continue using America’s leverage to urge the Israeli government to pursue a long-term peace founded upon a sustainable two-state solution.”

Foster continued, “The mounting and unnecessary civilian death toll and worsening humanitarian crisis are unacceptable. They are not in accord with American principles or interests; nor do they make Israel safer. Maintaining the current strategy also jeopardizes efforts to permanently dismantle Hamas and secure the release of all hostages.”

Later, when Rep. Brad Halbrook, R-Shelbyville, asked when, if ever, the influx of new migrants into Illinois will subside, Crespo responded that it was a question better directed to Texas Gov. Greg Abbott. The Republican governor has organized the shipment of migrants crossing the southern U.S.-Mexico border to Chicago and other Democratically controlled cities.

As of April 16, the city of Chicago reported it had welcomed more than 39,000 individuals that had been bused or flown from Texas. Of those, more than 16,000 had been resettled, according to the city.

“I was hoping we didn’t have to start talking about Texas,” said committee Chair Will Davis, D-Homewood. “So I think we acknowledge the role that Texas is playing. And we’ll just move on from there.”

In a separate interview, Crespo said he does not actually expect his colleagues to approve \$188 million for migrant education. But he said he felt it was important for lawmakers to start talking about the actual cost of educating the migrant population.

“My main goal was to create awareness that when we talk about the newcomers, we talk about housing, we talk about health care, feeding these people, but we never really talk about education,” he said. “Some school districts have seen their population go up by 10 percent. And that’s a lot for one year to the next.”

Pritzker did propose a \$450 million increase in overall funding for PreK-12 education next year, including a \$350 million increase in the Evidence-Based Funding formula, the primary formula used for allocating state money to local school districts.

But Peach said funding for the migrant population should be treated differently because that formula does not take into account the special circumstances surrounding the migrant population.

“The calculation of each school district’s enrollment for EBF is taken at the beginning of the school year on one day,” she said. “So that snapshot fails to adequately capture the number of enrolled newcomer students based on the high mobility of the population we’re serving. And that’s really creating a funding gap for individual
