Interview with New County Clerk & Recorder

Appointed the new Boone County Clerk and Recorder on Oct. 2, Amy Ohler brings more than two and a half decades of professional management to the table. Ms. Ohler will be responsible for handling important records, including birth, marriage, and death records as well as land transactions. She will also serve as Chief Election Officer for the County. The office also helps calculate property taxes.

At the administration meeting at which she was appointed, Ohler said, "I take it with a lot of responsibility." Growing up, she witnessed her parents being proactive members of the Belvidere community. Her mother, Nora, worked in the Circuit Clerk's Office and was eventually elected Circuit Clerk. Her father, Larry, served as the Belvidere Streets Supervisor, which meant that when it snowed, he had a busy day ahead of him. He also worked as a part-time deputy. Both of her parents were part of the local rescue squad, an emergency service that predated ambulance services in the area, Ohler told the Journal in a phone interview.

Ms. Ohler has always been an active person, enjoying softball and basketball. She appreciates continued on page 2

Former Military Leaders Decry National Guard Deployment In Illinois

Legal challenges to deployment, immigration enforcement continue in court

A group of retired military leaders — including the former head of the state's National Guard, several generals and an admiral — met with Gov. JB Pritzker on Thursday and publicly criticized President Donald Trump's attempted use of National Guard troops in Chicago.

The deployment is on pause following a federal judge's order but has attracted criticism from other former military officials as well as civic groups like the American Civil Liberties Union.

"Our founders understood that freedom cannot thrive under the shadow of military control," retired Maj. Gen. Randy Manner said. "Civilian police accountable to local leaders and bound by civil law are the right tools for maintaining order, not troops and tanks."

During a Thursday news conference, several speakers pointed to troop deployments in Memphis, Los Angeles and other cities.

Trump Obeys Judge's Block On Deploying Guard **As Supreme Court** Weighs Case

Unclear when high court might rule on administration's plea for intervention

The Trump administration has agreed to obey a federal judge's temporary block on deploying National Guard troops to Chicago while the U.S. Supreme Court weighs whether to stay the judge's

In a filing Tuesday — two days before U.S. District Judge April Perry's 14-day temporary restraining order is set to expire — Department of Justice attorneys said they'd consented to a 30day extension of the order. The Trump administration appealed the matter to the U.S. Supreme

"Today we have to draw a line in the sand, respectfully, firmly and without equivocation," Janessa Goldbeck, a retired Marine and head of the Vet Voice Foundation, said. "This is not normal, this is not American, and this is not what the military is for."

Meanwhile, retired Maj. Gen. William Enyart, the former adjutant general of the Illinois National Guard and one-term Democratic U.S. representative, said he was offended by Immigration and Customs Enforcement agents "cosplaying" as soldiers.

"These ICE agents are not trained soldiers. They're not trained soldiers," Enyart said. "They don't show the discipline that soldiers do. They don't obey the same rules of engagement that soldiers do."

Other military opposition

The group convened by Pritzker is not the first group of military officials to oppose Trump's proposed National Guard deployment.

A group of nine former service secretaries and four-star admirals and generals filed a brief in an ongoing lawsuit over the deployment. They include former Secretary of the Army Louis Caldera, an appointee of Barack Obama and Bill Clinton, and former Secretary of the Navy Sean O'Keefe, an appointee of both George H.W. and George W. Bush. The group also includes admirals and generals from the Navy, Coast Guard, Army and Air Force.

A domestic troop deployment for law enforcement purposes "inevitably erodes public trust, hurts recruitment, and undermines troop morale," the group wrote in their brief.

"Peaceful protests of government actions are constitutionally protected political speech deserving of the highest protection, not intimidation by

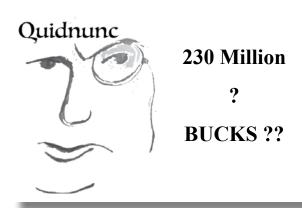

being part of a team, she said. She earned her BA in Criminal Justice from Edgewood College in Madison. Ohler said her decades of management experience helped her acquire soft skills such as knowing when to approach someone and when not to. Her professional opportunities allowed her to interact with a wide array of people of different ages, skill sets, and walks of life.

In her phone call, Ohler explained to the Journal that she hopes to be as hands-free as possible when it comes to managing money in this position. If she writes a check or uses the credit card, one of the deputy clerks will process those bills as well as any claims that come through the office.

She also told the paper that once a week, the County Clerk's office will have two people count the accumulated funds before the money is taken to the bank. The two people to do this change every week, and these pairs will not always be the same. This is one measure that has been taken, Ohler said, since the fraud that was discovered and tied to the former County Clerk and Recorder. The office wants the processes surrounding the handling of funds to be multi-signature, multiperson actions. Future measures that incorporate other checks and balances are expected.

While still new to the job, Ohler says she is learning a lot from her team. But she enjoys learning new things and sharing her knowledge with others. What follows is a series of additional interview questions Ohler replied to via email.

Boone County Journal: Have you worked in a Boone County position before? If so, what was the role and how did you work in it prior to this role?

Amy Ohler: Prior to my appointment as Boone County Clerk & Recorder, I served as the Office Manager for Sheriff Scott Yunk from December 2023 to October 2025. In that role, I was responsible for payroll, bill payment, and budget tracking for the six departments under the Sheriff's purview. This position gave me valuable insight into the "behind-the-scenes" processes that drive local government operations and how they differ from those in the private sector.

BCJ: Can you describe what opportunities and professional development prepared you for taking

AO: Most of my professional experience comes from the corporate world and independently owned and operated McDonald's franchises, where I worked from 1996 to 2023. What began as a summer job turned into a career spanning more than two decades. Managing McDonald's restaurants taught me about people, numbers, budgets, processes, and the soft skills essential for any leadership role. At one point, I oversaw seven restaurants across two states, supervising approximately 700 employees and managing around \$21 million in annual sales.

Every day in the restaurant business brings new challenges and interactions, and it was there that I discovered my passion for improving processes, training teams, and developing communication systems that connected multiple locations spread over long distances. I also valued the opportunity to engage deeply with the community, representing McDonald's through various initiatives and partnerships.

I served on the Belvidere Area Chamber of Commerce, including two years as its President, which allowed me to collaborate with local business owners and community organizations while strengthening ties within the region I live and work in. Additionally, I served on the Boone County Board of Health for four years and as its Vice President until my resignation following my appointment as County Clerk.

My experience centers on the management of people, departments, budgets, and revenue skills that continue to guide my work in public service.

BCJ: What does the working relationship between the County Clerk and Recorder and the County Treasurer look like in effect?

AO: The Clerk & Recorder's Office and the Treasurer's Office work closely together to ensure that each property in Boone County is properly taxed. The Assessment Office determines property values, the Treasurer issues the tax bills, and the Clerk & Recorder's Office applies the levies and tax extensions. It's truly a team effort when it comes to property taxes.

In addition to that collaboration, some billpaying functions are shared between our offices. The Treasurer's Office obtains and prepares claims for the County, while the Clerk & Recorder's Office prints and mails the checks to vendors.

One of my goals in the near future is to work with the Treasurer to implement a more secure and efficient bill payment process by utilizing the ACH (Automated Clearing House) network. This transition would help ensure timely and secure payments, reduce costs, and safeguard county funds while increasing overall efficiency.

BCJ: Based on the sentencing of Julie Bliss and the poor reputation that fell upon the position because of her theft, what kind of mindset do you have stepping into that role?

AO: I am entering this role with a commitment to strengthening the systems already established while introducing new procedures to ensure transparency and accountability in every function of the Clerk's Office. As I become more familiar with the operations, I will work closely with the clerks and the auditors to enhance existing checks and balances related to banking, accounts, and other key processes.

BCJ: Due to the aforementioned theft, the county wants to make the financial accounts to which the County Clerk and Recorder has access to be more transparent, and for all of the accounts to be accessible to the Treasurer—is that correct? What internal checks and balances are in place to prevent theft in the future across any/all county officials' accounts?

AO: I would be remiss if I did not recognize the great work that the clerks in this office have done since Julie's administrative leave began in 2023. Not only did they keep the office running smoothly, but they also implemented important checks and balances that had not previously

Court late last week, and it's unclear when the high court may rule.

In its filing to the Supreme Court, U.S. Solicitor General John Sauer argued the judicial branch has no right to "second guess" a president's judgment on national security matters or resulting military actions. The administration maintains National Guard deployment is necessary to protect federal immigration agents and property from protesters.

"A federal district court lacks not only the authority but also the competence to wrest control of the military chain of command from the Commander in Chief," he wrote.

Lawyers for the state of Illinois shot back in its own filing Monday, citing two U.S. Supreme Court decisions from the last century, including one "invalidating presidential seizure of steel mills during the Korean War."

"Furthermore, 'federal courts are fully empowered to consider' claims 'resulting from military intrusion into the civilian sector," lawyers in Attorney General Kwame Raoul's office wrote, citing a 1972 decision. "There are numerous indications that the questions presented here ... fall within this duty."

President Donald Trump's Oct. 4 order to federalize, or take control of, 300 members of the Illinois National Guard, along with the deployment of 200 Texas guardsmen and another 16 troops from California, has been blocked since Perry's Oct. 9 ruling.

The judge said the Department of Justice's arguments of violence added to a "growing body of evidence that (Department of Homeland Security's) version of events are unreliable" as the administration's narrative about "violent" protests in Chicago differed so strongly from the accounts of state and local law enforcement.

Perry also found there was "no credible evidence that there is a danger of rebellion in the state of Illinois." The 7th Circuit Court of Appeals backed up Perry last week, with a three-judge panel writing in an opinion published Thursday that "political opposition is not rebellion."

The three-judge appeals panel did stay the portion of Perry's order blocking the administration from federalizing National Guard troops. But the administration accused the 7th circuit of "judicially micromanaging the exercise of the President's Commander-in-Chief powers" as the appellate judges still sided with Perry on the actual deployment of guardsmen.

been in place. I understand that the integrity of this office is under close scrutiny from the administration, the County Board, and the citizens of Boone County — and rightfully so.

BCJ: How does the County Clerk and Recorder serve the people of Boone County? How would you describe your job?AO: As I've learned in a very short time, the Clerk's Office truly serves as the "catch-all" for Boone County. In addition to maintaining all land and vital records, the office is responsible for County Board minutes, military discharge papers, plat and monument records, election materials, employee files, and much more. We house land transaction records dating back to 1838 and vital records from 1877 to the present.

The Clerk's Office also oversees all local elections. While most citizens are familiar with us during election season, many also visit the office for certified copies of birth and death certificates or marriage licenses. Even if you've never come into the office personally, if you've bought or sold property in Boone County, your title

company has worked with us to complete your transaction.

> We also offer

several free and valuable services that are often underutilized by residents. Veterans can bring in their original discharge papers to have them recorded and securely stored in case the originals are ever lost. We also provide certified copies of those discharge papers at no charge. Additionally, veterans can enroll in our Honor Rewards program, which provides a card that offers discounts and incentives at local businesses.

Another free service is Property Fraud Alert, an online subscription program that allows residents to monitor their name within the Recorder's Office to detect potentially fraudulent activity involving their property. With the rise in mortgage fraud and identity theft, this service helps ensure homeowners are notified quickly if suspicious documents are recorded under their name.

BCJ: When it comes to your professional life, what's your passion? What drives you at work?

Illinois Lawmakers Condemn ICE Raids In Chicago

State leaders pledge to explore new protections for immigrants but say their power is limited

Democratic state lawmakers on Wednesday condemned aggressive immigration raids that in recent weeks have resulted in violent clashes between federal agents and protestors in the Chicago region — but it remains uncertain whether their words will translate to legislative action during the fall session.

"History will judge those who are silent in this moment, and we're going to speak up today," House Speaker Emanuel "Chris" Welch, D-Hillside, told reporters outside his Capitol office. "We're going to stand up for our democracy, and that's our plan for today."

Lawmakers returned to the Capitol this week for their annual fall veto session with an already extensive agenda that included reform of the state's public transportation agencies and addressing soaring energy costs and grid reliability.

An addition to the list is addressing the immigration enforcement campaign known as "Operation Midway Blitz." The Department of Homeland Security claims the operation has resulted in the arrest of more than 1,000 immigrants who were living in Chicago and its suburbs without legal permission over the past five weeks.

Violence has escalated as the operation has ramped up. Several protestors have been arrested over the past few weeks on charges of assaulting federal agents outside an Immigrations and Customs Enforcement processing facility in Broadview. Agents there have sprayed tear gas and nonlethal ammunition into crowds gathered outside the facility.

Other conflicts have flared up. Most recently, a car chase and crash involving federal agents resulted in a confrontation with at least 100 residents on Chicago's Southeast Side. Agents deployed tear gas canisters to quell the clash, which resulted in the detainment of at least three people, according to the Chicago Tribune.

Together for the first time in more than four months, the Democrat-controlled Illinois House — in party line votes — approved five resolutions signaling disapproval for various aspects of the Trump Administration. One decried "lawless actions" that have "denied people of all types of immigration status their rights to due process." Another condemned politically motivated violence, "whether in the form of a mass shooting or a mass deployment of masked troops empowered to instill fear."

Legislative response pending

Beyond expressing their opinions strongly, lawmakers thus far have taken no action this week on legislation responding to the federal immigration crackdown.

Gov. JB Pritzker told reporters after an unrelated event in Minooka on Wednesday that lawmakers "may be able to make tweaks to the law to protect people better in the state," but cautioned that "there are limits to what a state can do."

Still, there appears to be an effort to tee up proposals for when lawmakers return to the Capitol later this month.

One proposal being floated would prohibit civil im-

migration arrests inside and around courthouses under the state's jurisdiction. It would not apply to federal facilities

Such facilities were once generally considered off limits for immigration enforcement in a tacit understanding. But over the past year, state courts have been the site of at least 14 civil immigration apprehensions, according to the Illinois Coalition for Immigration and Refugee Rights.

On Tuesday, Cook County Chief Judge Timothy Evans issued an order barring warrantless immigration arrests of litigants and witnesses in and around the county's courthouses. Welch said lawmakers will consider legislation taking that idea statewide.

"We want to look at language; we want to make sure lawyers are all on the same page," Welch said. "If we can do something similar statewide, I'd love to get that done because what's happening with these masked ICE agents in courthouses and territories around courthouses is unacceptable."

Lawmakers are also expected to consider tweaks to the state's TRUST Act, the 2017 law that generally prohibits state and local law enforcement from assisting federal agents with civil immigration enforcement.

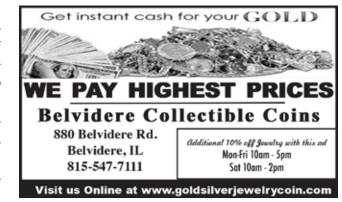
The legislation filed earlier this year by state Rep. Lisa Hernandez, D-Cicero, and state Sen. Omar Aquino, D-Chicago, would expand the definition of an immigration agent to include anyone authorized to arrest and detain people for immigration enforcement, including National Guard troops. It would also clarify that campus police and school resource officers are included in law enforcement barred from cooperating with civil immigration enforcement.

Another bill, filed by state Sen. Laura Fine, D-Glenview, would require school districts to notify parents, students and staff when immigration enforcement is confirmed on campus; make health care facilities adopt policies to prevent immigration agents from entering nonpublic treatment areas without a judicial warrant, and boost privacy protections that ensure automatic license plate reader data is not shared with federal agents.

State Sen. Celina Villanueva, D-Chicago, who is the lead sponsor on the courts measure and involved in the conversation about a broader immigration package, said she would "fight like hell with my colleagues in order to try to do whatever the hell we can in order to try to protect people."

"The reality is, the playbook that we used to play by doesn't exist anymore because they're not abiding by it," Villaneuva said. "So we're going to get really, really creative and try to do what we can in order to stand up for people because this is not OK. This is not normal."

the military," they said.

A temporary restraining order issued as part of that suit is currently blocking the federal government from deploying troops. That order expires next week but could be extended.

Appeals court stands firm

Over the weekend, the 7th Circuit Court of Appeals upheld U.S. District Court Judge April Perry's decision to issue that restraining order blocking deployment of National Guard troops but reversed her ruling that Trump didn't have the authority to federalize guardsmen.

On Thursday, a three-judge panel from the appeals court published its full opinion backing up its initial ruling, writing that "the facts do not justify the President's actions in Illinois."

"Political opposition is not rebellion," the judges ruled.

The ruling briefly alluded to arrested protesters who happened to be carrying firearms with the proper licensing. The judges wrote that just because some protesters "exercise their Second Amendment right" does not mean a protest is a rebellion — or when demonstrators are organized, engage in civil disobedience or "call for significant changes to the structure of the U.S. government."

"Nor does a protest become a rebellion merely because of sporadic and isolated incidents of unlawful activity or even violence committed by rogue participants in the protest," the judges wrote.

Free speech lawsuit continues

A judge on Thursday took a harsh stance against the recent actions by ICE as well as Customs and Border Protection, the two federal agencies responsible for the recent crackdown on illegal immigration in Chicago.

After barring federal agents from using chemical irritants like tear gas and other similar measures last week, U.S. District Judge Sara Ellis admonished federal agents for using tear gas in a residential neighborhood earlier this week.

Citing "serious concerns" that her orders were being ignored, Ellis told Russell Hott, the head of ICE's Chicago field office, to come into her courtroom for questioning on Monday, according to reporting from the Chicago Sun-Times.

Ellis also ordered agents to begin using bodyworn cameras.

Pritzker, who said federal agents have been "lying all along," applauded the judge's move, saying it was the "right thing."

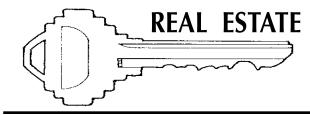
